Dear Mayor and Members of the City Council:

At its May 14, 2025 meeting, the Alexandria Commission on Persons with Disabilities chose to endorse the City's application for the Federal Transit Administration Enhanced Mobility of Seniors & Individuals with Disabilities discretionary grant program. The project will seek federal funding for critical Human Services Transportation vehicles to transport residents with disabilities to and from public services, as well as create a shared fleet of vehicles for all transportation needs for residents with disabilities. This procurement represents the continuing commitment to the City's residents with disabilities in ensuring all residents have access to all City amenities.

With the Commissions' mission "to promote the rights of persons with disabilities by advocating for equality, dignity and independence through advising the community and advancing public awareness," the commission finds this procurement of wheelchair-accessible vehicles to be directly in line with our mission. These vehicles will not just provide the necessary transportation that members of our community find difficult to access but provide transportation options that integrate wheelchair users into the transportation network for all users of public services; specifically, access to adaptive recreation programs at our city's rec centers.

The Commission on Persons with Disabilities is supportive of the City's application to the Enhanced Mobility of Seniors & Individuals with Disabilities discretionary grant program for the purchase and maintenance of wheelchair-accessible electric vehicles and charging infrastructure in FY 2027 and FY 2028 for a total grant ask of up to \$1 million.

Dear Mayor Gaskins and Members of the City Council:

We are writing to you as the Miracle League of Alexandria (MLA) to endorse the City of Alexandria's application for funding through the Federal Transit Administration Enhanced Mobility of Seniors and Individuals with Disabilities discretionary grant program.

As you know, the MLA has worked with the City and the special needs community for the past 15 years to provide an enhanced experience to members of that community. During that period, we found that transportation is a major issue for them, particularly for those in wheelchairs or using walkers. We felt that the problem was serious enough to have us send a "311" request to the City Manager to see what could be done to improve transportation options for the community.

That request gave rise to us meeting with the City's Paratransit Office. While they are doing good work in the area, we still believe that more can be done if additional resources are available. The funding under the grant program would allow the City to acquire additional vehicles specifically equipped to transport special needs individuals (as well as seniors and others with disabilities) in wheelchairs or using walkers.

Providing mobility to special needs individuals gives them the same opportunities as others in the City. Getting to medical appointments; attending City functions; participating in or just attending sporting events; any number of activities that a lack of transportation hinders their involvement. Our work with special needs individuals over the years has shown us that they share the same common wishes and desires as the rest of the City's residents. However, transportation is a major barrier for them. Acquiring several more handicap accessible vehicles is an excellent way for the City to help them fulfill their life in our City.

Making use of an available Federal program seems like a very viable option to achieve these goals. We hope that you support the City's application for these funds. We do. And it fits in with the MLA approach of working with various City organizations on other initiatives: expanding having sensory rooms in all new schools and recreation centers; developing sensory bags to help calm individuals (both special needs and others); coordinating "field trip" days to the Kelley Cares Miracle Field for special needs students at all levels of ACPS to play baseball; working with the Washington Nationals on sponsorship arrangements for game shirts for our special needs players; etc.

We are available if you would like to discuss this further. Thank you for your consideration on this issue.
