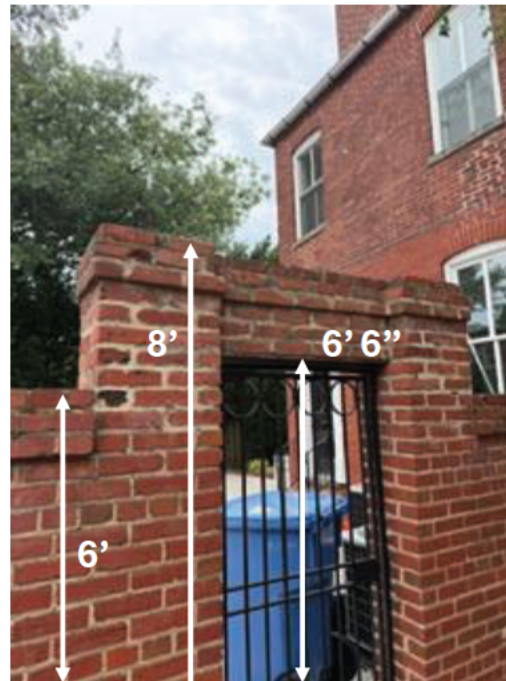

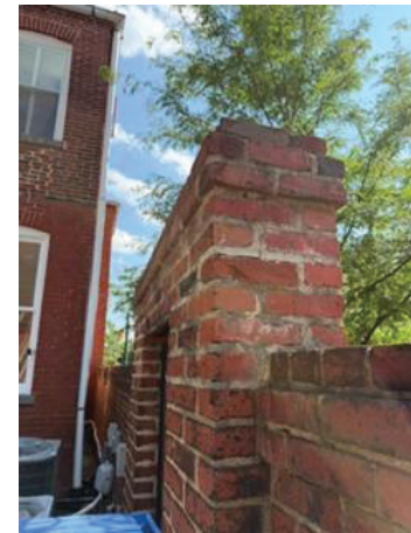

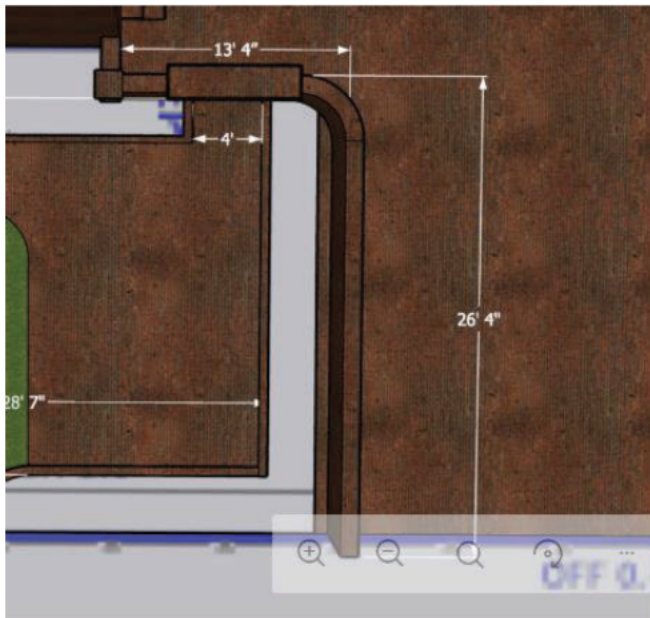


View from Prince St along the East side of the house into back yard, 11' opening per the Plat

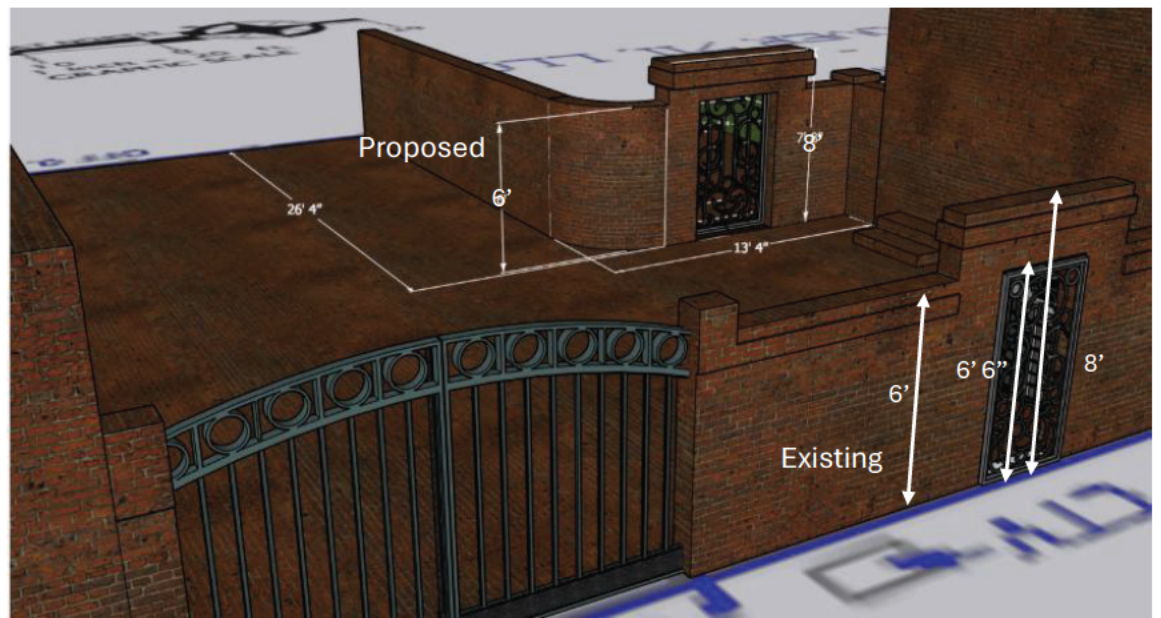

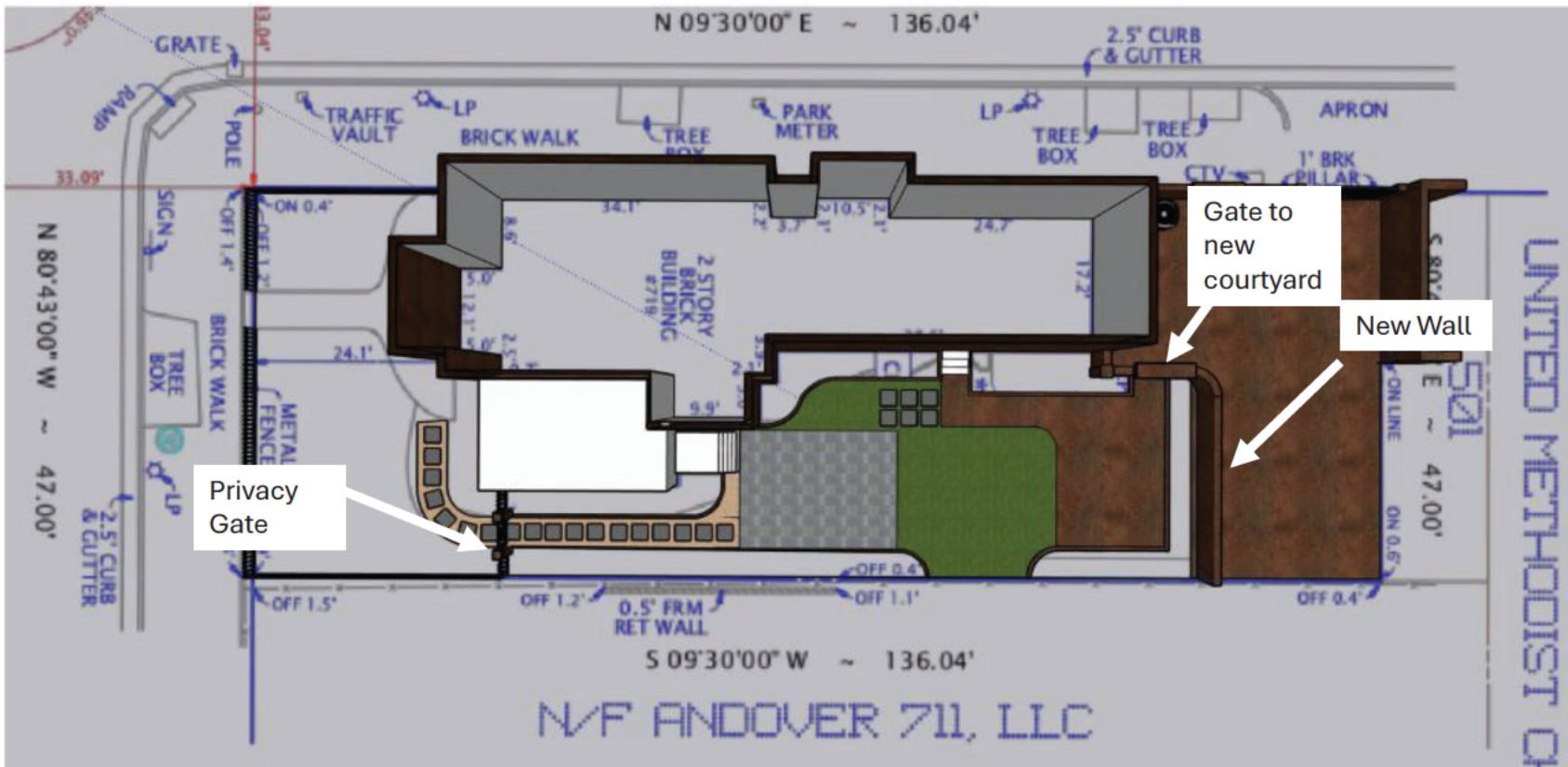
