

ORDINANCE NO. _____

AN ORDINANCE to amend and reordain Sheet No. 068.04 of the "Official Zoning Map, Alexandria, Virginia," adopted by Section 1-300 (OFFICIAL ZONING MAP AND DISTRICT BOUNDARIES), of the City of Alexandria Zoning Ordinance, by rezoning the properties at 4991 and 5001 Eisenhower Avenue from, OCM (100)/Office commercial medium (100) to CDD #31/Coordinated Development District 31 in accordance with the said zoning map amendment heretofore approved by city council as Rezoning No. 2023-00007.

WHEREAS, the City Council finds and determines that:

1. In Rezoning No. 2023-00007, the Planning Commission, having found that the public necessity, convenience, general welfare and good zoning practice so require, recommended approval to the City Council on December 3, 2024 of a rezoning of the properties at 4991 and 5001 Eisenhower Avenue from, OCM (100)/Office commercial medium (100) to CDD #31/Coordinated Development District 31, which recommendation was approved by the City Council at public hearing on December 14, 2024;

2. The said rezoning is in conformity with the 1992 Master Plan of the City of Alexandria, Virginia, as amended;

3. All requirements of law precedent to the adoption of this ordinance have been complied with; now, therefore,

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Sheet No. 068.04 of the "Official Zoning Map, Alexandria, Virginia," adopted by Section 1-300 of the City of Alexandria Zoning Ordinance, be, and the same hereby is, amended by changing, in the manner set forth below, the zoning classification of the property hereinafter described:

To: CDD #31/Coordinated Development District 31

LAND DESCRIPTION: 5001 Eisenhower Avenue, Alexandria, Virginia
22304, 068.04-01-20

From: OCM (100)/Office commercial medium (100)
To: CDD #31/Coordinated Development District 31

1 Section 2. That the director of planning and zoning be, and hereby is, directed to
2 record the foregoing amendment on the said map.

4 Section 3. That Sheet No. 068.04 of the "Official Zoning Map, Alexandria,
5 Virginia," as so amended, be, and the same hereby is, reordained as part of the City of
6 Alexandria Zoning Ordinance.

8 Section 4. That this ordinance shall become effective on the date and at the time of
