### Statement of Interest

Having attended nearly a dozen meetings of the Alexandria Human Rights Commission as a member of the public, I feel called to join the commission in a formal capacity to advance human rights in the city as we enter a new administration already attacking our marginalized community members on all fronts. Under the new regime, progressive local governments will increasingly be the site of struggle because we can still have at least some presumption of democracy and regard for human rights from which we can begin a conversation. As a born and raised Alexandrian who is incredibly lucky to still be able to call this city my home, I have always been deeply invested in local government and advocating for social justice. In high school, I served on various ACPS advisory committees and as the student representative to the school board, where I strongly advocated for racial equity policies even when I was reminded that my roles were supposed to be symbolic. I remain deeply connected to organizing efforts in the city, including the movement for divestment with Alexandria for Palestinian Human Rights, and have frequently engaged with local government and spoken out on police oversight, ICE collaboration, and centering marginalized communities in our budget priorities. I believe that my professional background in housing justice work and legal services will be useful to the commission, particularly my familiarity with federal subsidy programs and landlord-tenant relations. I have also worked extensively with the immigrant community in the DMV, both in advocacy spaces and in a mutual aid capacity, having helped file over a dozen pro se asylum, temporary protected status, and work permit applications. As a queer, trans, and disabled community member, I can speak directly to my experiences while uplifting those that are not my own.
