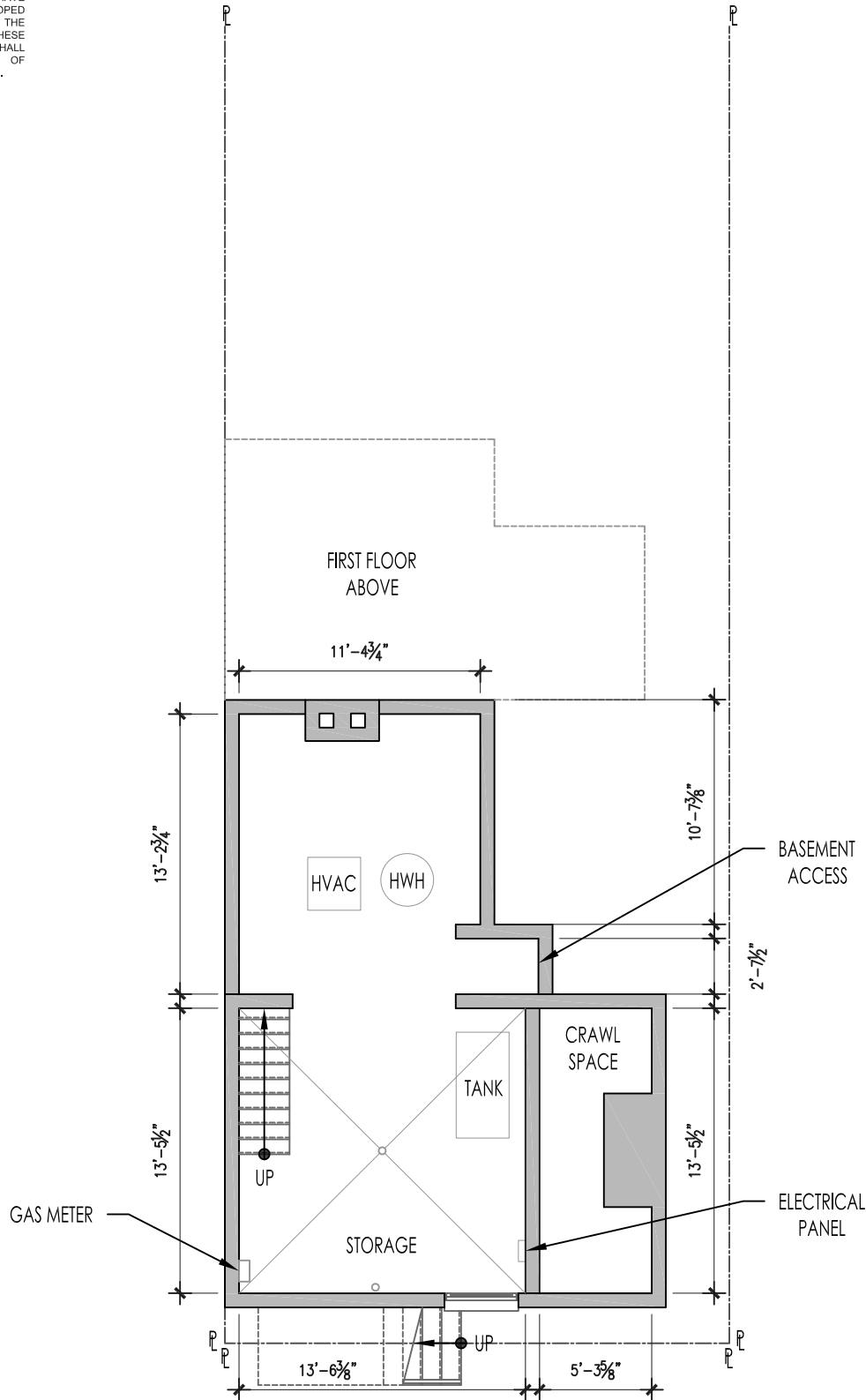

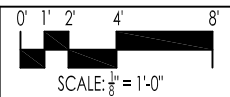
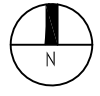
ROOF OF 1 STORY ADDITION BELOW TO BE REMOVED
