Thank you for considering my application to serve on the Alexandria Park and Recreation Commission. I have lived in Alexandria for over ten years and have found our parks and recreation amenities as well as our recreation services some of the greatest benefits of living here. I am a frequent user of the city's parks and trails and have a six-year-old daughter who makes regular use of the playgrounds and recreation centers in addition to participating in the city's camps. As an assistant coach of her soccer team, I see close-up the hard work that goes into the maintenance of the city's parks and fields. I am a real estate attorney for the federal government and have experience in leases, ground leases, subleases, licenses, easements, acquisitions, disposals, intergovernmental agreements, and interactions between different levels of government. One of Alexandria's greatest strengths is Recreation, Parks & Cultural Activities' portfolio of parks and recreation amenities, and my experience dealing with a variety of property agreements will help the City maximize the use and value of these properties. For example, soon the City will need to decide on the future of the Cameron Run Regional Park. I have worked for the United States Postal Service as an attorney in the Property & Procurement Law team primarily advising the Facilities group since 2014. The Postal Service has approximately 8,500 owned properties and over 25,000 leased properties. I currently advise the Postal Service's Atlantic Area (from Maine to Virginia) on all aspects of lease formation and management including renewals, amendments, disputes, maintenance, and the exercise of purchase options. Leases in my portfolio range from small rural post offices of a few hundred square feet with rents of under \$10,000 per year to large industrial facilities of hundreds of thousands of square feet with rents over \$1,000,000 per year. I also advise on the purchase and sale of lands and buildings as well as licenses and ground leases for parking or modular post offices. I am also responsible for advising the group managing the Postal Service's owned facilities which includes interactions with state and local governments, leasing out of excess space, and revenue generating projects such as antenna licenses and billboard leases.
