These petition signatures were gathered at farmers' markets, shopping centers, and apartment complexes all across Alexandria.

# Alexandria City Council Public Hearing ACT Public Comment

June 17, 2023

Good Morning, and thank you for this opportunity to speak at this City Council Hearing. My name is Saba Fentaw, and I am Community Organizer at African Communities Together. ACT is a national nonprofit dedicated to improving the lives of African immigrants and empowering them to fight for the dignity and respect they deserve. In this role, we support the tenants at Southern Towers in their fight against displacement, which is why we are here before you today to uplift their request for the city to stand and in solidarity with the tenants and publicly condemn CIM's actions.

CIM has implemented a new utility billing system that is adding to the financial burden of our community members. Under previous ownership at Southern Towers, tenants were only required to pay a flat rate of \$20/person for water and \$15 for trash. CIM is now charging tenants for all utilities and associated fees, resulting in a significant increase in living costs in addition to the already significant increases in rent. For example, tenants who previously only had to pay roughly \$55 for water and trash are now seeing utility bills of roughly \$197 and upwards. One tenant even received a bill for almost \$500. Additionally, tenants are now faced with inconsistencies in their billing, which makes financial planning difficult. There are also discrepancies in how the tenants are being billed. While tenants in the Graham are charged for their actual electric usage, tenants in the other four buildings on the property are tasked with sharing the total utility bill associated with their building, and their portion is determined based on the occupancy and square footage of their unit.

This billing system is just one of the many ways in which CIM has shown that they prioritize profit over human lives and are willing to pass expenses onto cost-burdened tenants.

The tenants at Southern Towers are in dire need of your support. Blue-collar workers and members of the immigrant community are being pushed out of their homes, and as we consider the redevelopment of the West End, we cannot allow predatory corporations like CIM to capitalize off of the displacement of the very communities that built our neighborhoods.

With this in mind, we hope City officials can come together and publicly condemn CIM's actions and compel them to meet tenant demands.

# Alexandria City Council Public Hearing Tarig Dafalla Public Comment

June 17, 2023

Good morning. My name is Tarig Dafalla, and up until this week, I was a tenant at Southern Towers, which as you know, was bought by the CIM Group in 2020.

Although CIM claims they are "community-focused," their actions have made it clear that they would rather contribute to the displacement of working- class families, than provide stable and safe housing. Tenants have met with CIM on numerous occasions to discuss our concerns and explain the struggles we face, but we still find ourselves dealing with unfair pricing practices, mold, and maintenance issues. Our community is seeing rent increases ranging from 6% to 14%, and our parking fees are nearly double what neighboring properties charge. Additionally, while rent used to be all-inclusive, CIM is now making us pay for utilities separately, even though our rent has gone up significantly. These pricing practices make it clear to us that CIM prioritizes profit over human lives.

I have personally experienced CIM's unjust practices, which has caused significant hardships for me. Due to my hospitalization for high cholesterol and blood pressure, I was unable to pay my rent and fell behind. Upon my release from the hospital, CIM gave me a five- day notice to pay the entire amount or vacate the premises. This added stress to my already vulnerable situation and affected both me and my family. I couldn't work much during my illness, and my income suffered as a result. Unfortunately, many members of our community are facing similar challenges. This unfair treatment by CIM not only places additional financial burden on us but also contributes to the displacement of immigrant communities, which play a crucial role in the social fabric of Alexandria.

We kindly request your support by publicly condemning CIM's actions. By publicly denouncing their practices and advocating for tenant rights, we hope to bring about positive change. Thank you for your time and consideration.

## Alexandria City Council Public Hearing Eden Kidane Public Comment

June 17, 2023

Good morning. My name is Eden Kidane, and I am a tenant at Southern Towers. I have lived in Southern Towers for almost four years. Today I am here to share my experience regarding the new utility billing system implemented by CIM, which has caused significant financial hardship for me and my Family.

As my neighbor mentioned previously, CIM's new billing system has resulted in additional financial burdens for us. With five children to care for and a low-wage job, I already face considerable financial responsibilities. Under the previous ownership at Southern Towers, we were only required to pay a flat rate of \$20 per person for water and \$15 for trash. Now, my utility bill is \$400 a month, on top of rent increases, leading to a substantial increase in living costs on my family. What makes matters worse is that the bills are inconsistent, making it challenging to plan and budget accordingly.

In light of these circumstances, I kindly request your support in publicly condemning CIM's actions and advocating for fair practices. Specifically, I urge you to request CIM to charge tenants based on actual electric usage and the actual square footage of our units. This would ensure that utility costs are more equitable and aligned with our specific needs and living conditions.

Thank you for your time and consideration. Your support in addressing this issue would make a significant difference in improving the lives of myself and my community.



### Petition to the Members of the Alexandria Virginia City Council:

More than a decade after the passage of the federal Affordable Care Act, over 12,900 people — 8.3 percent of Alexandria residents — remain uninsured, and thousands more are underinsured. Most of Alexandria's uninsured residents are Black and Hispanic, leading to significant racial disparities in quality of health care, patient outcomes, and life expectancy in the City of Alexandria.

The passage of national, improved Medicare For All would guarantee universal, comprehensive health coverage to all Alexandria residents -- without copays, deductibles, premiums, or out-of-pocket costs. It would also eliminate the need for employer-sponsored health insurance, saving the Alexandria city government more than \$9.5 million per year and relieve local businesses of the burden of providing health insurance to employees.

This is why we are asking the Alexandria City Council to pass the proposed resolution to endorse the Medicare For All Act (H.R. 3421 and S. 1655) in the United States Congress.

Similar resolutions have been passed in cities such as Washington DC, Philadelphia, Boston, Tampa, and New Orleans – as well as locally in Montgomery County, Prince George's County, Charles County, and Annapolis, Maryland. With this resolution, Alexandria has the opportunity to make history as the first locality in Virginia to endorse the Medicare For All Act, and we urge the councilmembers to take advantage of this opportunity by passing this resolution.

#### RESOLUTION NO.

#### RESOLUTION TO ENDORSE THE MEDICARE FOR ALL ACT

WHEREAS, every person in the City of Alexandria, the Washington Metropolitan Area, the Commonwealth of Virginia, and the entire United States deserves high quality health care; and

WHEREAS, although the Commonwealth of Virginia has made great strides in increasing our health care coverage through Medicaid expansion, we struggle to ensure quality health care for all, as more than 12,900 people, or 8.3% of residents, in the City of Alexandria remain uninsured<sup>[1]</sup>, and many more are underinsured; and

WHEREAS, more than 3,500 Black people, or 11%, and 6,100 Hispanic people, or nearly 24%, in the City of Alexandria remain uninsured<sup>[2]</sup>, and many more are underinsured; and

WHEREAS, health care expenditure comprises more than \$9,600,000 of the City of Alexandria's budget<sup>[3]</sup>; and

WHEREAS, the City of Alexandria suffers from racial disparities in quality of health care and patient outcomes, clearly demonstrated by the unequal rates of morbidity and mortality of Black residents in the City of Alexandria during the COVID-19 pandemic [4]; and

WHEREAS, more than 25% of pregnant people in the city do not receive early prenatal care although it is known that babies born to those who do not receive prenatal care are three times more likely to have a low birth weight and five times more likely to die<sup>[5]</sup>; and

WHEREAS, there are racial disparities in life expectancy in the City of Alexandria with white residents expected to live nearly 7 years longer than Black residents (85.4 and 78.5 years, respectively)<sup>[6]</sup>; and

WHEREAS, Black and white residents of the City of Alexandria have similar rates of cancer diagnosis, but Black residents are more likely to die from cancer compared with white residents<sup>[7]</sup>; and

WHEREAS, hypertension hospitalization rates among Black residents of the City of Alexandria are 12 times the rate of hospitalization among white residents, and hospitalization rates due to long-term complications from diabetes among Hispanic residents are four times the rate of hospitalization among white residents [8]; and

WHEREAS, 50% of undocumented children and 5% of all children in Virginia are uninsured, and 27% of the total uninsured population in Virginia are non-citizens<sup>[9]</sup>; and

WHEREAS, City of Alexandria's culture and tourism depends heavily on its restaurant industry, an industry with only 31% health insurance coverage nationally before the pandemic<sup>[10]</sup> and which now faces significant loss of income, while many restaurant industry workers frequently oscillate between Medicaid and other insurance or no insurance due to unstable wages, leading to interruptions of care for chronic disease management, which worsens outcomes<sup>[11]</sup>; and

WHEREAS, many people delay seeking needed health care due to an inability to pay<sup>[12]</sup>, leading to a sicker and poorer population which is significantly more likely to develop serious illness if exposed to COVID-19 or other infectious disease, and will subsequently face higher mortality rates from infectious diseases; and

WHEREAS, homeless populations use emergency departments at higher rates, and are more likely to have repeat visits than their housed counterparts, which has been linked to a poor understanding of the *Patient Protection and Affordable Care Act* and Medicaid enrollment criteria, and leads to increases hospital emergency room costs and to preventable deaths among the homeless population<sup>[13]</sup>; and

WHEREAS, medical bills are a leading cause of bankruptcy in this country<sup>[14]</sup> and more than 25% of residents of Virginia report past-due medical debt which is above the national average<sup>[15]</sup>; and

WHEREAS, the COVID-19 pandemic has caused increases in applications for Medicaid<sup>[16]</sup> and other health care programs managed by the Commonwealth of Virginia; and

WHEREAS, the COVID-19 pandemic has led to record levels of unemployment, loss of employer-sponsored health insurance, a severely strained health care system, widespread illness, and taken a profound toll on our community's mental health, all of which is placing significant demands on our health care system; and

WHEREAS, the ever-increasing costs of health care, which are further elevated due to the pandemic, may challenge our already strapped state and municipal budgets<sup>[17]</sup>, and COVID-19 related treatment is likely to cost uninsured patients tens of thousands of dollars<sup>[18]</sup>; and

WHEREAS, in order to equitably and effectively address the health care needs in the City of Alexandria, including the additional burden of the COVID-19 crisis, we must urge the United States Congress to expand health insurance coverage to provide every resident of the United States comprehensive health care without any cost-sharing; and

WHEREAS, only comprehensive universal health coverage can assure people that, no matter what health condition is ultimately responsible for their symptoms, or whatever treatment becomes necessary, all residents of the U.S. will be financially protected; and

WHEREAS, the *Medicare for All Act* would guarantee all residents full coverage for medically necessary health care without copays, deductibles, or other out-of-pocket costs, [19][20] provide full and comprehensive mental health services to all residents of the City of Alexandria, and provide long-term support services for people in the disability community and those with pre-existing conditions<sup>[21]</sup>; and

WHEREAS, legislators in several states including California, New York, Maryland, and Washington have introduced bills in their legislatures that could potentially create state-based single-payer universal health care systems for their residents; and

WHEREAS, the State-Based Universal Health Care Act would amend the Patient Protection and Affordable Care Act to authorize the establishment of, and provide support for, state-based universal health care systems that provide comprehensive health care to their residents<sup>[22]</sup>;

### NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF ALEXANDRIA, VIRGINIA:

Vigorously SUPPORTS the enactment of federal legislation to provide universal and comprehensive health care for all residents of the United States including the residents of the City of Alexandria.

Specifically REQUESTS and VOICES SUPPORT for passage of the *Medicare for All Act* (H.R. 3421 & S. 1655) and *State-Based Universal Health Care Act* (H.R. 3775 - 117th Congress).

CALLS UPON the United States Congress to adopt federal legislation to provide universal, comprehensive health coverage with zero cost-sharing to all people in the United States.

THANKS the members of the U.S. Congress who have cosponsored the *Medicare for All Act* (H.R. 3421 & S. 1655), including U.S. Representatives Don Beyer and Robert C. Scott, for their continued support for a comprehensive single-payer universal health care system.

DIRECTS that a copy of this resolution be sent to the President of the United States, President of the United States Senate, Secretary of Health and Human Services, U.S. Speaker of the House, U.S. Senate Majority Leader, U.S. Senate Minority Leader, U.S. Senators Tim Kaine and Mark Warner, U.S. House Minority Leader, U.S. Representative Don Beyer and all other Representatives to the U.S. Congress from Virginia, Governor Glenn Youngkin, and Members of the City's delegation to, as well as the leadership of, the Virginia General Assembly.

City Council Testimony June 17th, 2023

Dear Mayor and Members of City Council,

I am sure you know by now that I am an opponent of the proposed Business Improvement District and that I have organized opposition to this proposal. I would like to give you an update since this is the last public hearing this summer, and I know some of the people I am working with would like to get back to focusing on their businesses, and not this unwelcome tax increase. We have had several meetings, talked to business and property owners, put up signs, and yes, banners, and sent letters to all the residential properties that will be taxed. If the proposal is not withdrawn, we will continue to do the work, and I think we will have no problem getting to the number that would make it statistically impossible for the BID supporters to get to %60 of owners, as laid out in the BID Guidelines.

Even if proponents, who have tried to get the largest property owners on board first, were to somehow argue that they had reached %60 of owners, the creation of a BID, is as the name implies, a tool to improve the district or to increase services, and in the words of your guidelines "for the purpose of providing additional, more complete or more timely services than may be needed or desired by the remainder of the city." The BID being proposed is not planning to increase services, or take over services the city currently does. The City has done a great job since the 2017 BID proposal, putting up banners, putting out planters, planting trees, keeping our streets clean, and marketing Old Town, which continues to be award winning, through Visit Alexandria. BID's are created to solve problems, and there is no problem that has been identified. Old Town is not Georgetown in the 80's, and it is not filled with vacancies. Most vacancies are in properties transitioning, as downtown business districts do. It is up to you whether "a need exists to provide some of the services authorized by law..." The key words here are "you may determine..." Or you may not.

I think Old Town is thriving. Today, I walked through the nation's oldest farmers market, which fills the plaza in front of City Hall. Later today I will go to the Portside Festival, which I went to last night as well, and I will celebrate the opening of the Maritime Heritage Center, something I have advocated for since 2008. It is great to see it finally happening, with the help of the city and private donations, and investors. All this voluntary effort and partnerships are leading to great positive changes for Old Town. Old Town is changing. Soon there will be over 300 new residents living near King St. as many of our offices are converted to residential. This will also help our retail corps. There are more hotel rooms, and more Air B and B's that also bring people to town to visit. Our proximity to DC, as well as our own historic sites, means that there will always be reasons to come to Old Town. The closing of the 100 Block of King St., another thing I have advocated for, because of public safety and because walking by foot should be the primary mode of transportation there, has come to be, and it is now a destination.

Even though I have never been a member, or been asked to be a member, or been assisted by any of the current proponents of the BID, I know they are an important part of the community and many businesses appreciate their representation and advocacy, and I hope that they will continue to exist and thrive. But here is where I must draw the line. They are asking me to pay the bill for the work they do, for which I receive no benefit. I paid over \$30,000 in property tax this week. A .10 cent increase would be a %9 increase would mean \$5,400 in

additional tax payments each year. That is a lot more than membership in the Old Town Business Association, The Chamber and Visit Alexandria together. And it would not be voluntary, I would be forced to pay this. I own the building where Taverna Cretekou is located at 820 King St. Next year will be the 50th year they have been there and the 50th year my family has owned the building. We are looking forward to a big celebration, an anniversary it shares with just a couple other restaurants, and the Torpedo Factory Art Center.

They have never been a member of the Business Association, the Chamber, or Visit Alexandria, and they are doing fine. Of course, they did not do so well during the pandemic, but neither OTBA, nor the city ever approached us to help during this time. We did not receive any grant money. I met with Charlotte Hall and Amy Rutherford to give them a chance to personally give me their pitch, and I have attended two presentations of OTBA, and feel like I have heard and given proponents a chance to convince me. They have not. The purpose of the BID, as far as I can discern, is to do what OTBA is already doing. The things they do are marketing, promotion, and events. Most of these events take place near the Waterfront, understandably. The meetings were poorly attended, and there were many of them, and their second deadline of May 31st has come and gone. They had hoped to add the tax in July, and then in December. I would argue that according to the guidelines, neither of these proposals is possible. The language in the guideline reads:

"If a non-profit BID corporation requests funding, in order to have the service district accord with the city's annual tax assessment valuation cycle and budget, the timing of the creation of the district is recommended to be the calendar year prior to the calendar year in which the assessment goes into effect. The tax would be presented with the City's other annual tax ordinance amendments."

I am not a lawyer, but the language in the guidelines seems to say that the tax increase must be considered at the same time as other tax ordinances, so not until next spring. And then it could only go into effect the following year.

Now, a final thought, if there is an appetite in Alexandria for a .10 cent tax increase, just think what could be done with the increase in revenue City wide. Montgomery County proposed such a tax this year and it would have given 220 million to its schools. According to the city Budget, that would raise 46 million in Alexandria. That would buy some nice open space, fund the affordable housing trust fund, keep our pools open longer, and pay our librarians what they deserve. I am sure we also have schools in need. If the city had raised the tax rate just .1 cent, it would have raised 4.6 Million and the city could give a grant to OTBA and other business organizations as it has done in the past through AEDP.

But a 10 cent increase on 489 properties, only some of whom want it or will benefit, will be a mistake. It is already dividing Old Town, when we should be uniting in celebrating our progress. We have just come out of a pandemic, and we are returning to full strength. Some small businesses may take it as a signal to close and move on. That will make Old Town less unique and special. And instead of increasing property value may actually decrease the value, as buyers may look at a higher tax rate, and with high interest rates, pass on Old Town.

One last thing, if we want Ambassadors, we should all be ambassadors. I was on the news about the water main break, and to promote Goodies Frozen Custard and Treats, and I have

been celebrating the new mural being put up at King and Alfred. I am constantly recommending to visitors where to go, and where to eat. Isn't this kind of appreciation of where we live something we all should be doing? I urge you to ask the OTBA to withdraw the proposed BID now, and let us get back to promoting the place where we live and work.
