I. OPENING

1. Calling the Roll.

Vice Mayor Bagley called the meeting to order and the City Clerk called the roll. All members of Council were present with Mayor Gaskins and Councilman Chapman joining during the Executive Session.

2. Approval of the Electronic Participation Resolution by Council [ROLL-CALL VOTE]

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilwoman Greene and carried 4-0, City Council adopted the electronic participation resolution. WHEREAS, Virginia Code Section 2.2-3708.3 provides that an individual member of a public body may fully participate in meetings electronically if any such member meets the criterial of the code and the public body has adopted an Electronic Meeting Policy; and

WHEREAS, City Council adopted an Electronic Participation Policy on June 24, 2025 as Resolution No. 3309; and

WHEREAS, Mayor Alyia Gaskins has notified the Clerk that she is unavailable to be physically present for the April 14, 2026 City Council Meeting due to a personal reason, specifically work-related travel; and

WHEREAS, the Mayor has not participated in more than two or 25% of City Council Meetings by electronic means during this calendar year; and

WHEREAS, Mayor Alyia Gaskins will participate in the City Council Meeting by video conference call from Cambridge, Massachusetts and arrangements have been made to ensure the member shall be heard by all participants at the City Council Meeting; and

WHEREAS a quorum of the City Council is physically assembled in person.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ALEXANDRIA, VIRGINIA:

That pursuant to Virginia Code 2.2-3708.3 and the City Council's Electronic Meeting Policy Resolution 3309, Mayor Gaskins will participate remotely in this meeting by video conference call.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilwoman Greene and carried 4-2, City Council convened in closed executive session at 6:15 p.m., pursuant to Virginia Code section 2.2-3711(A)(6) to discuss or consider the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of the City would be adversely affected. In favor: Vice Mayor Bagley, Councilman Aguirre, Councilman Elnoubi, and Councilwoman Greene; Opposed, none; Absent, Mayor Gaskins and Councilman Chapman.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried unanimously, City Council reconvened in open session at 7:05 p.m. The vote was as follows: In favor, Mayor Gaskins, Vice Mayor Bagley, Councilman Aguirre, Councilman Chapman, Councilman Elnoubi , and Councilwoman Greene.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried unanimously by roll-call vote, City Council adopted the resolution regarding the closed executive session that was previously circulated to the Council. The

*Council of Governments (COG) Board of Directors (Mayor Gaskins)

Mayor Gaskins stated that the Board discussed the regional commuter survey that looked at trends pre-Covid, present trends, and post-Covid trends in commuter habits. Mayor Gaskins reported that commuter habits have changed and most people commute in the area on Tuesday, Wednesday, and Thursday and have that impacts transit options throughout the region. Mayor Gaskins noted that more people are driving in single occupant vehicles and there discussion about how to encourage use of the transit options in the region.

*Council of Governments (COG) Food and Agriculture Regional Member (FARM) Policy Committee (Councilwoman Greene)

Councilwoman Greene reported that the Committee held breakout groups to discuss ways that the region can better support food security for residents in the area. Councilwoman Greene noted that the group would reconvene in September to continue the work.

*Commission on Aging (Councilman Aguirre)

Councilman Aguirre reported that the Commission thanked Council for passage of the Age-Friendly Plan and discussed the next steps. Councilman Aguirre reported that there was a presentation from the Center for Medicare Advocacy and a report from the DAAS.

Councilman Aguirre reported that he attended several events to celebrate the 50th Anniversary of the WMATA system.

Councilman Aguirre reported that he attended the grand opening of Mexican Corner.

A RESOLUTION OF THE ALEXANDRIA CITY COUNCIL APPROVING OF THE CITY'S PARTICIPATION IN THE PROPOSED COMBINED SETTLEMENT AGREEMENT RESOLVING OPIOID-RELATED CLAIMS AGAINST ASSOCIATED PHARMACIES, INC. (AND AMERICAN ASSOCIATED PHARMACIES); J M SMITH CORPORATION; LOUISIANA WHOLESALE DRUG COMPANY, INC; MORRIS AND DICKSON CO.; NORTH CAROLINA MUTUAL WHOLESALE DRUG COMPANY, INC.; and UNITED NATURAL FOODS, INC. (INCLUDING ITS SUBSIDIARIES SUPERVALU AND ADVANTAGE LOGISTICS) (COLLECTIVELY REFERRED TO AS THE SIX REMNANT DEFENDANTS), AND DIRECTING THE CITY ATTORNEY AND/OR THE CITY'S ADMINISTRATOR OR CITY'S MANAGER TO EXECUTE THE DOCUMENTS NECESSARY TO EFFECTUATE THE CITY'S PARTICIPATION IN THE SETTLEMENT

There is one settlement agreement covering the combined settlement with the Six Remnant Defendants.

WHEREAS the opioid epidemic that has cost thousands of human lives across the country also impacts the City of Alexandria by adversely impacting the delivery of emergency medical, law enforcement, criminal justice, mental health and substance abuse services, and other services by the City's various departments and agencies; and

WHEREAS the City has been required and will continue to be required to allocate substantial taxpayer dollars, resources, staff energy and time to address the damage the opioid epidemic has caused and continues to cause the citizens of the City; and

WHEREAS a settlement proposal has been negotiated that will cause six opioids defendants, Associated Pharmacies, Inc (and American Associated Pharmacies); J M Smith Corporation; Louisiana Wholesale Drug Company, Inc.; Morris and Dickson Co.; North Carolina Mutual Wholesale Drug Company, Inc.; and United Natural Foods, Inc. (including its subsidiaries SuperValu and Advantage Logistics) ("Six Remnant Defendants") to pay approximately \$97,625,000 nationwide to resolve opioid-related claims by state subdivisions against it; and

WHEREAS the City will be entitled to a portion of the settlement proceeds despite not having filed suit against any of the Six Remnant Defendants; and

WHEREAS the City seeks recovery of the public funds previously expended and to be expended in the future to abate the consequences and harm of the opioid epidemic; and

WHEREAS the City's outside opioid litigation counsel has recommended that the City participate in the Six Remnant Defendants settlement to recover its share of the funds that the settlement would provide; and

WHEREAS the City Attorney has reviewed the available information about the proposed settlement and concurs with the recommendation of outside counsel; and

NOW THEREFORE BE IT RESOLVED that the Alexandria City Council, this 14th day of April, 2026, approves of the City's participation in the proposed settlement of opioid-related claims against the Six Remnant Defendants and their related corporate entities, and directs the City Attorney and/or the City Administrator or City Manager to execute the documents necessary to effectuate the City's participation in the settlement, including the required release of claims against the Six Remnant Defendants.
