There's a lot to love about living in Alexandria: friendly residents, historic neighborhoods, green parks, mature tree canopies, and lots of options for how to get around the city. If my destination is reachable via bike trails or bike lanes, then I'll gladly hop on my bicycle and pedal my way across town. If I'm going shopping and will return home with heavy packages, then I'll get in the car to run my errands. If my destination is in Old Town, then I'm more likely to take the bus. But my absolute favorite mode of transportation are my own two feet. As a lifelong wildlife conservationist, I relish the opportunity to spend time outside and to observe the natural world around me. And, yes, that includes time outside in Alexandria too! I walk and bike everywhere in Alexandria, which enables me to see all kinds of animals, flowers, architectural details, meet new neighbors, and observe changes in our city. Providing multimodal transportation options for Alexandria is critical to the success and sustainability of our city. It benefits individuals like me, who have the option to use all modes of transportation. But it also benefits citizens who may not have the option to use every mode of transportation, due to financial, mobility, or other reasons. To help Alexandria live up to its ALL Alexandria equity goal "to create the conditions in which everyone can participate, prosper, and reach their full potential," we must continue to provide a range of transportation options to enable all communities throughout the city to travel to places where they work, play, and live. Well connected, multimodal transportation connects neighborhoods, facilitates commerce, reduces air pollution, mitigates climate change, and improves the health and wellbeing of residents. It is for all these reasons that I joined the Duke Street Transitway Advisory Group (DSTAG). I had the great honor of being asked to serve as the Chair of the DSTAG, a position I held for the duration of the Group's work. Leading a citizen and business advisory group was one of the most rewarding volunteer experiences of my career. It was rewarding because the DSTAG helped to shape the future of the Duke Street corridor, which is in desperate need of a makeover. The DSTAG assisted in the development of a preferred alternative that recommended primarily center-running, dedicated bus lanes for the new bus rapid transit (BRT) system, as well as substantial improvements to the pedestrian and bicycle infrastructure on Duke St. Improving the safety of all citizens traveling along Duke St. was one of my top priorities during this process. As a result, I advocated for infrastructure improvements that would help the City meet the Vision Zero goal "to eliminate fatal and severe injuries on our streets by 2028." In collaboration with City staff, we included strong safety measures in the DSTAG's final recommendation, such as explicitly stating that "the safety of pedestrians should be prioritized," creating uninterrupted 10foot wide sidewalks buffered from traffic, installing ADA accessible pedestrian signals, establishing pedestrian refuge islands, designing a dedicated cycle track separate from cars and pedestrians, and implementing multiple traffic calming measures. Working with the DSTAG and City staff to create a recommendation for both the near-term and long-term was a wonderful experience because I helped to create an inclusive, environmentally friendly vision for the Duke St. corridor. I expressed my strong support for the recommendation and process when I presented the DSTAG's recommendation to City Council in June of this year. I would like to continue to volunteer in my community and leverage my experience leading the DSTAG to serve as a member of the Transportation Commission. I am especially interested in the work of the Transportation Commission, since it is a chance to help develop and support the City's long-range transportation plans. I would love the opportunity to help advocate for and promote balanced transportation systems in our City. I have substantive experience leading strategic and long-term planning for both government agencies and non-profit organizations. As Chair of the DSTAG, as well as in my government jobs, I facilitated tense meetings and public hearings to reach a positive resolution. In addition, I have participated in the grantmaking process from all sides: writing grant proposals as staff for non-profit organizations, setting project priorities and approving grant proposals as a board member for non-profits, and reviewing and ranking grant proposals for a funding agency. As a result, I fully understand and support the City's efforts to secure grant funding for transportation projects. In fact, the Duke Street BRT project is the perfect example of the City utilizing funding sources other than taxpayer dollars to cover the costs of a major transportation project. I am excited about the opportunity to serve on the Transportation Commission to advance multimodal transportation, safety, equity, and environmental sustainability in the City of Alexandria. The role would be a way for me to continue to give back to my community by utilizing the skills and experiences I have gained during my career and previous volunteer work.
