#### I. OPENING MATTERS

1. Calling the Roll

Mayor Wilson called the meeting to order and the City Clerk called the roll. All members of City Council were present, with Councilman Aguirre and Councilman Chapman arriving during the closed executive session. Vice Mayor Jackson was absent.

3. 5:45 p.m. -- Consideration of a closed executive session for personnel matters. [ROLL-CALL VOTE]

WHEREUPON, upon motion by Councilmember Bagley, seconded by Councilman McPike and carried 4-0, City Council convened in closed executive session at 5:46 p.m., to discuss the performance of the city manager, city attorney, city clerk and the independent

police auditor pursuant to Section 2.2-3711 (A)(1) of the Code of Virginia. The vote was as follows: In favor, Mayor Wilson, Councilmember Bagley, Councilwoman Gaskins, and Councilman McPike; Opposed, none; Absent, Vice Mayor Jackson, Councilman Aguirre, and Councilman Chapman.

# III. Oral Reports from Members of Council on Boards, Commissions, and Committees

# \*Northern Virginia Transportation Authority (NVTA) (Mayor Wilson)

Mayor Wilson reported that NVTA meeting there was discussion on the 495 Express extension for the Springfield exchange to the Woodrow Wilson Bridge, noting to the concern for the impacts to the potential transit on the Wilson Bridge in the future. Mayor Wilson noted that WMATA provided information along with VDOT about changes to address some of the concerns. Mayor Wilson reported that NVTA endorsed the letter for the extension of the express lanes, stating that he did not support the letter. Councilman Aguirre gave an overview of support from the Transportation Planning Board and how the transit option would look in the future.

# \*ARHA Redevelopment Committee (Mayor Wilson and Councilman Chapman)

Mayor Wilson reported that ARHA has made a selection on a new CEO for the Authority and would make a public announcement soon. Mayor Wilson reported that there was discussion of the bond issuance for the Heritage and Housing Alexandria's project in Arlandria. Mayor Wilson reported that there was discussion about community engagement about the future of property in Cameron Valley. Mayor Wilson reported that there would be an update of the MOU between ARHA and the City of Alexandria discussed at future meetings.

# \*City/Schools Subcommittee (Mayor Wilson and Councilman Chapman)

Mayor Wilson reported that the Subcommittee had conversations around Minne Howard and students and families receiving orientation and tours of the new building. Mayor Wilson reported that there was discussion about the opening of the community pool located in the new facility, likely sometime in August. Mayor Wilson noted that there was a lengthy discussion about budget timing and schedule with the School Board and the City.

# \*Virginia Railway Express (VRE) (Councilmember Bagley)

Councilmember Bagley reported that VRE is reinstating the cross honor program between VRE and MARC, allowing passengers to use both services. Councilmember Bagley reported that VPRA is in discussion to purchase a portion of the Manassas Line from Norfolk Southern.

# \*Waterfront Commission (Councilmember Bagley)

Councilmember Bagley reported that the Commission discussed the special use permit coming from the Board of Architectural Review for outdoor seating at the Tall Ship Providence. Councilmember Bagley reported that there was discussion of the development of Robinson Terminal North and following Alex Renew's work on the parcel, development projects will be coming before City Council for consideration.
