I have experience as an archaeologist, attorney, and diplomat who has worked extensively on historic preservation, cultural property, and Native American / Native Hawaiian repatriation issues. I currently work as a Diplomat for the U.S. Department of State on a domestic tour serving as an attorney in the Office of the Legal Adviser. Prior to the State Department, I worked at the U.S. Department of the Interior for ten years, first with the National Park Service where I covered Native American repatriation and the "Kennewick Man" case (a legal dispute involving an ancient set of human remains discovered in Washington State), and then with the Office of the Solicitor as an attorney where I practiced Native American law (treaty rights, tribal recognition, land claims, etc.) and cultural property law (NAGPRA, NHPA, assisting DOJ prosecute looters, etc.). In my most recent overseas assignment as a public diplomacy officer at the U.S. Embassy in Zimbabwe, I managed a \$475,000 State Department grant to preserve the structural and historic integrity of the Great Zimbabwe National Monument from 2019-2021. I also secured an additional \$145,000 in State Department grants to conduct a comprehensive archaeological survey of the Naletale Monument and to create a modern database for the collections housed at the Zimbabwe Museum of Human Sciences, which included looping in the University of California, Los Angeles' Fowler Museum to provide consultation.

Here is where I’ve had a career, bought a house, and where we’ve raised a daughter, who currently attends ACHS and received her Virginia driver’s license yesterday (yikes!). Alexandria is the home I have come to love. During my career, I’ve had the privilege of contributing to public health and public policy at the national and international levels. That service has had some wonderful highlights. I served as health policy director for the US Senate Committee on Health, Education, Labor and Pensions, working for Senator Edward M. Kennedy – a remarkable, happy and often exhausting experience in which I led work to enact the Affordable Care Act (sections of which were actually written at St. Elmo’s café on Mt. Vernon Avenue), as well as extensive legislation on pandemic preparedness, global public health, drug safety, and genetic discrimination. I then moved into international public health, where I worked on the global campaigns to eliminate polio and malaria. I feel very strongly that the time has come for me to try to give back to this community, my home. I have moved from having a full-time job at an external employer to running my own consulting firm, which gives me the freedom to pick the kinds of assignments and volunteer activities I wish to pursue. I would be delighted if the Council would consider me for service on the Public Health Advisory Commission. As Tip O’Neill famously said about politics, all public health is ultimately local. As we’ve seen so clearly in the last few years, local public health has the capacity to affect how we live, what information we get, and what level of readiness we have for disease emergencies. While no community is perfect, I feel Alexandria has done an excellent job during the pandemic, coping as well as possible with the challenges we all faced. There have been many times in the last few years when, in discussing national responses, I’ve said, “Well, in Alexandria, we...” It would be a privilege to try to help continue this tradition of excellence by serving on the Public Health Advisory Commission. I wanted to close by addressing the category of the vacancy, which I see is for someone who is not a health professional, typically defined as an individual licensed to practice health care on patients, such as a medical doctor or nurse. By that definition, I am not a health professional and would qualify for the vacancy, since I do not have that license and have never practiced health care on patients. I have, of course, been involved in public health in a professional capacity, but I hope that does not disqualify me from service in this position. I would welcome the opportunity to speak to any of the Council about this application or my background. I heard about this position only recently, and would otherwise have reached out prior to applying. I did work with one of your predecessors, Paul Smedberg, when I served on the Senate staff, but do not yet know the current Council members. I would welcome the chance to correct that. Thank you very much for your consideration, and I hope I earn the chance to serve.
