## Statement of Interest

As an architect with over 30 years of experience in the commercial real estate industry, I understand that land planning is the underpinning for the social and spatial structure of our communities. Alexandria benefits from the robust community involvement which is the basis for a rigorous (and often messy) process of informed consensus. I believe that the more inclusive the process, the better the outcome. Over the course of my career, I have worked on projects ranging from a dance center near Catholic University to an affordable housing project on K Street to an office building on a parcel of the St. Elizabeths Campus, to the net zero energy renovation of the American Geophysical Union's headquarters. All projects require adherence to code and zoning requirements. Most of the projects in my portfolio also required rigorous jurisdictional reviews and approvals, from DC's Historical Preservation Review Board to the Office of Planning's process for Planned Unit Developments. In some cases, the projects were also reviewed by the Commission of Fine Arts. For me, presenting to the neighborhood commissions was the most meaningful part of the process. The community input kept the project team accountable for the impact that the building would have on its surroundings. When I moved to this region in 1991, I chose to work in the "developer driven" world of commercial architecture. I also sought to pursue another goal: to contribute to the creation of affordable housing. To that end, I joined the Board of Directors of Mi Casa, a DC based non-profit housing developer. I sat on that board for over 20 years and watched—with deep admiration—as the staff worked diligently and patiently to make high quality housing more accessible to DC residents. At the start, Mi Casa focused on renovating single family houses; today their projects run that gamut from affordable rental units for seniors to limited equity co-ops which ensure that the affordability is permanent. Their current executive director started focusing on sustainability early on and, to her credit, Mi Casa has built two net zero energy homes in Anacostia's historic district. My interest in joining the Planning Commission developed somewhat inadvertently. A year ago, I joined the Executive Committee of the Sierra Club's Potomac River Group Chapter. This organization combines my interest in the built and natural environment with its ability to engage in issues such as smart growth, climate change mitigation and political activism. What I did not realize is that the chapter endorses local candidates, including for Alexandria's City Council. The interviews of the candidates highlighted that this group of people had been serving their community in many ways, focusing on everything from education to housing to transportation issues. That experience is why I am applying for the Planning Commission open position. Meeting the candidates convinced me that—even with the volunteer work that I have done and continue to do— now is the time to do more.
