Members of the Committee, I've lived in Alexandria since 2016 and I am staying for life. When my then-fiancée and I moved to the DC area, I worked at a company with an office right by the King Street Metro station and commuted an hour each way from Silver Spring. I loved it - not the commute, but the place I worked. We moved a little closer, to Arlington, and I started driving to work, but parking was too expensive, so I would park on the street and move my car every two to three hours. The three-hour parking spots were right on the other side of the tracks, in a beautiful neighborhood I learned was called Rosemont. When we were in the market to buy a house, we found a townhouse on East Linden and jumped at the chance. There were ten bids in three days, and miraculously we got it. Since then we've had cats, dogs, and now two daughters - one who attends Naomi Brooks and the other who will join her in a year and a half. My wife created the Brooks Bike Bus this year, with dozens of kids riding through our neighborhood to school every Friday. I serve as the 1st Vice President of the Rosemont Citizens Association, and our family is deeply woven into the civic life of Alexandria. Professionally, I am honored to serve the American people in this turbulent time as a Presidential Innovation Fellow (beginning in 2024) and now as the Deputy Director for Innovation, both at the Council on Environmental Quality. In this role, I provide environmental policy leadership across the federal government, helping modernize environmental review and permitting processes, develop federal environmental data standards, and advance strategies that improve sustainability, transparency, and community outcomes nationwide. My work has included authoring major federal policy documents, building rapid-response environmental workflow systems, and supporting federal agencies as they adopt more resilient and efficient environmental practices. Before joining CEQ, I spent many years working at the intersection of environmental science, urban planning, and land-use compatibility.
