I write in my personal capacity; I am a commissioner of the Industrial Development Authority and currently chair the IDA, but this communication is not a formal communication from the IDA.

I only recently learned that the IDA seat currently held by Lynn Hampton is contested. Ms. Hampton has applied for reappointment. I write to ask that Council reappoint Ms. Hampton.

Ms. Hampton is unique among IDA members and applicants; she is the only recognized public finance official on the IDA, and her skill-set is rare and essential to the IDA's work. In addition to Ms. Hampton's familiarity with Alexandria's public financing and overall economic development posture, Ms. Hampton's demonstrated, recognized, national expertise in the financial management of state, local, and special-purpose public entities is simply not otherwise available to the IDA. The IDA's membership is limited by state law to precisely seven commissioners, and Ms. Hampton's incumbency adds exceptional value to the services that the IDA renders to the City.
