Statement of Interest

Dear Members of the Economic Opportunities Commission, My name is DT Oliver and I'm in my sixth year living in Alexandria, Virginia. I am enthusiastically submitting my application to be part of your Commission for three reasons that I'll break down individually: (1) My fulltime job and volunteer work demonstrates my commitment to the causes this Commission prioritizes; (2) I have a skillset/service to provide for free that can benefit this Commission and our city; and (3) I have a commitment to and love for the city of Alexandria. (1) My fulltime job and volunteer work demonstrates my commitment to the causes this Commission prioritizes. In 2018, I was in a high-paying job in Raleigh, NC, that provided me with a comfortable lifestyle. However, I couldn't shake the feeling that I needed to be doing something else. After a lengthy "soul searching" process, I left this comfortable job to become a temp employee at Feeding America's DC office to analyze a new type of data that was about to become available for a small batch of food banks. On paper, this seemed like a risky move, but this ended up being one of the best decisions of my career. In 5.5 years I've gone from being a temp analyzing data to being the Director of our Capacity Building Analytics work. My commitment to the cause of food insecurity, self-discipline, empathy towards others, and big-picture approach to our use of data has allowed me to develop substantially at Feeding America. In my current role, I work directly with food banks who may be stretched-thin capacity-wise and assist with optimizing their approach to sourcing food, raising funds, providing tailored services depending on the micro-level community data in their service areas, and enhancing their data capabilities. My full-time job may demonstrate my commitment to this work, but it is at the national level. In 2022, I began exploring ways to get more involved with economic development in the city of Alexandria. I had been narrowing down my list of potential volunteer positions when I happened to run into the Executive Director of Senior Services of Alexandria at a coffee shop on King St. This led me to try an initial volunteer shift with Meals on Wheels - my first shift being on my 30th birthday. As I'm writing this statement of interest, I've made 440 deliveries across nearly 60

shifts to 120 Alexandrian seniors, totaling 870 meals delivered. This volunteer experience has shown me the impact of these local food programs that I help with at a national level. When I deliver meals to seniors, it sometimes leads to great conversations. For them, it provides two nutritious meals and it may be the first conversation they've had with someone that day if they live alone. For me, I'm learning from someone with more life experience and who has a lot to offer others. It's a highly rewarding experience. At this point, I'm ready to do more for this city I love so much. My full-time job has given me insight into the processes and methods deployed nationwide to promote economic opportunities, and my volunteerism with Meals on Wheels has allowed me to drive nearly every street of Alexandria and see the city in its entirety. This Commission is a natural next step in my ability to serve the city. (2) I have a skillset/service to provide for free that can benefit this Commission and our city These days, data is a crucial part of serving others. I see the impact data can have each day at Feeding America. Data serves as a critical conversation starter and decision-informer at the local level. My career growth at Feeding America has grown my technical skillset and has evolved my communication capabilities. I can easily modify my communication of data and visualization of data depending on who I'm talking to. I'm frequently viewed as and referred to as a data leader and thought leader with all things data at Feeding America. I've developed tools that help inform food bank strategy, and I've helped teammates overcome all of the challenges that are inevitable with data. Additionally, I've served on nearly 10 grant review committees and have helped build food bank capacity to write grants. Data is a key piece in successful grant applications, and the ability to articulate data in a grant application can have a snowball effect due to the grant's potential for benefiting the community. This is a skillset that I am proud of, and one I am excited to offer to the City of Alexandria for free to demonstrate my commitment to the city. Additionally, I have a side project I've been working on since 2018 that I feel would benefit this Commission greatly. For nearly 6 years, I've been accumulating different sources of publicly-available data, paying for a personal Tableau license, building maps/dashboards, and refining them in hopes of showing these tools somedays to community leaders as a free resource to help inform their strategy. The purpose of these dashboards is to provide a detailed view into small geographic areas of cities/townships to help leaders better understand how these areas compare to other similarly-sized areas. In short, it is meant to help "put yourself in the shoes" of a community - both its strengths and its areas for development. What I've been lacking with this side project is a tangible body of work to apply it to. This Commission seems like a natural place to showcase this tool as a free resource and use it to help inform the Commission's strategy. (3) I have a commitment to and love for the city of Alexandria. Before 2018, I honestly hadn't ever been to Alexandria and knew nothing about it. When I found out my job at Feeding America required me to work in the DC office, I was put in contact with someone who was born and raised in the DC metro area. She asked me what my priorities were with a community here and I communicated to her that my top priority was my 85-pound Lab-Pyrenees dog, Toby, having a comfortable life in his golden years. I explained to her that I bottlefed him as a two-week old puppy, he had come with me everywhere in my adult years, and now that he was in his senior years, I needed to be in a town that was known for being dog-friendly and where I could make sure his golden years were the best possible. She bluntly said "Alexandria. Don't look anywhere else." Toby and I spent a perfect 5.5 years together in Alexandria. He became something of a community dog - everywhere we went, he knew a friend and would happily bark at folks from across the street. Almost every morning we went to Dolci Gelati, where he was deemed the #1 Dog in Virginia by the locals. After a long, fun life and countless adventures together, Toby started his next adventure in July 2023. It may be unorthodox to mention a dog in this statement of interest, but the way Alexandria made his golden years so perfect, filled with joy and fun, will always hold a special place in my heart. Even when I still had him, I had a deep appreciation for the role Alexandria played in his life and mine. Now that he is no longer with me, I want to do even more to give back to this city. I had never been so confidently told which community would be a good fit for me. And I've never felt so confident in my commitment to a community until I lived here.
