Ms. Puskar explained that the staff recommendation is exact as that the other sign referenced is from the 2022 approval. Ms. Miller responded that she is okay with the new blade sign.

# **REASON**

The Board found that the proposed modifications were consistent with the design of the existing building and in keeping with the Design Guidelines.

### **SPEAKERS**

Cathy Puskar, attorney for the applicant introduced the project.

Gozde Tanyeri and Jenny Crawford, project architects, presented the proposed design.

#### **DISCUSSION**

Ms. Miller noted that the proposed design is an improvement to the building and asked for clarification regarding the false wood batten product. The applicant described these as metal battens with a wood grain appearance.

Ms. Miller asked the applicant to describe the material being used to re-skin the existing structural members. The applicant described the finish system.

Ms. Zandian asked the applicant if mechanical units will be located n the roof. The applicant stated that there will be some units on the roof and they will either be located such that they are not visible from the public right of way or will be screened.

Mr. Adams asked about the alignment of the ground floor retail with the floors above. The applicant described how this wall works with the existing components.

Ms. Zandian expressed her support for the project.

Mr. Adams suggested that the applicant t work with staff on the articulation of the ground floor retail space.

Mr. Spencer expressed his support for the proposed design including the configuration of the ground floor retail.

Ms. Miller asked about siding. The representative responded that the front will be wood. The representative responded to Mr. Leaf's concerns about draining by saying that there is no footprint being added so there will be no additional water, and all construction rules will be followed.

Mr. Spencer asked if the roof is becoming more steep. The representative responded that the roof line is changing.
