Born in the UK, I'm a naturalized US citizen having lived in the US since 2007 - and in the City of Alexandria since 2012. For me, the city's commitment to environmental stewardship is a reflection of the broader values that make this community special - and is absolutely essential to our shared sustainable future. Much of my career thus far has been in international conservation and sustainable development. Coming from an environmental science background (I have a PhD in ecological genetics from the University of Oxford in the UK) my work has increasingly focused on climate change - from global modeling of its impacts to developing regional-to-local scale solutions, that all use nature to help local communities both mitigate and adapt to climate change. Given the breadth of the climate challenge, it means I have had the privilege to work across a wide range of environmental issues at the natureclimate nexus - from water (both too much and too little) to threatened species conservation to food security and farming. I have worked on the pure research side (in the lab and in the field), all the way through to organizational strategy, management and high-level communications and advocacy. Key to the success of my work, that of the teams I've managed, and of the diverse organizations I have worked for over the years (from academia to government to NGOs), has been to rigorously connect and translate environmental science to inform policy and practice, and thus support behavior change on-the-ground. One of the many lessons I have learned along the way, is that process must be a partnership – between scientists, policymakers and the local communities they serve - for it to deliver equitable and durable outcomes. Unfortunately, I was laid-off last month as my employer for the last 16 years, Conservation International based in Arlington, is undergoing a major downsizing and consolidation (largely as a result of recent changes in US Administration policies particularly around climate change). While I will be looking to continue to work across the globe in international conservation and development, I would also now relish the chance to engage at the local level - supporting and serving my community - where the results are truly tangible and benefit the City of Alexandria and its surrounds - the people and place where I am fortunate to live.
