<p><b>PLANNING COMMISSION ACTION, FEBRUARY 3, 2026:</b> This item was pulled from the Consent Calendar and heard before Docket Item #6. On a motion by Vice Chair Koenig, seconded by Commissioner Ramirez, the Planning Commission voted to close the Public Hearing. The motion carried on a vote of 7-0.</p> <p>On a motion by Vice Chair Koenig, seconded by Commissioner Ramirez, the Planning Commission voted to recommend approval of Special Use Permit #2025-00054. The motion carried on a vote of 7-0.</p> <p><u>Discussion:</u>            In response to concerns over noise and lighting, Chair McMahan confirmed with the applicant’s representation, Duncan Blair, attorney, that the rooftop layout was oriented away from the neighboring residences. Mr. Blair also explained that no lights would be aimed at residences and that glass sound barriers as well as special flooring materials would be utilized to reduce sound impact. Chair McMahan also highlighted that the use of solar shades on the roof would also help to shield any lighting. Vice Chair Koenig recommended to Mr. Blair that his client explore using translucent glass for the sound barrier to increase privacy.</p> <p>Regarding the site’s access and alley traffic, Chair McMahan asked if fencing was possible to form more separation between the alley and the subject property. Mr. Blair indicated that additional fencing could be installed. Commissioner Brown also asked about traffic patterns and vehicular access to the site. Mr. Blair recognized that the site’s access was somewhat odd given the traffic patterns of surrounding streets and identified a few ways someone driving could access the site.</p>		

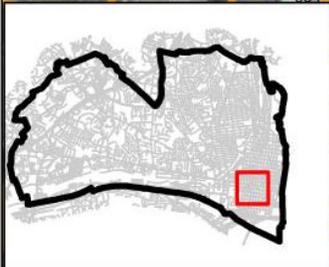
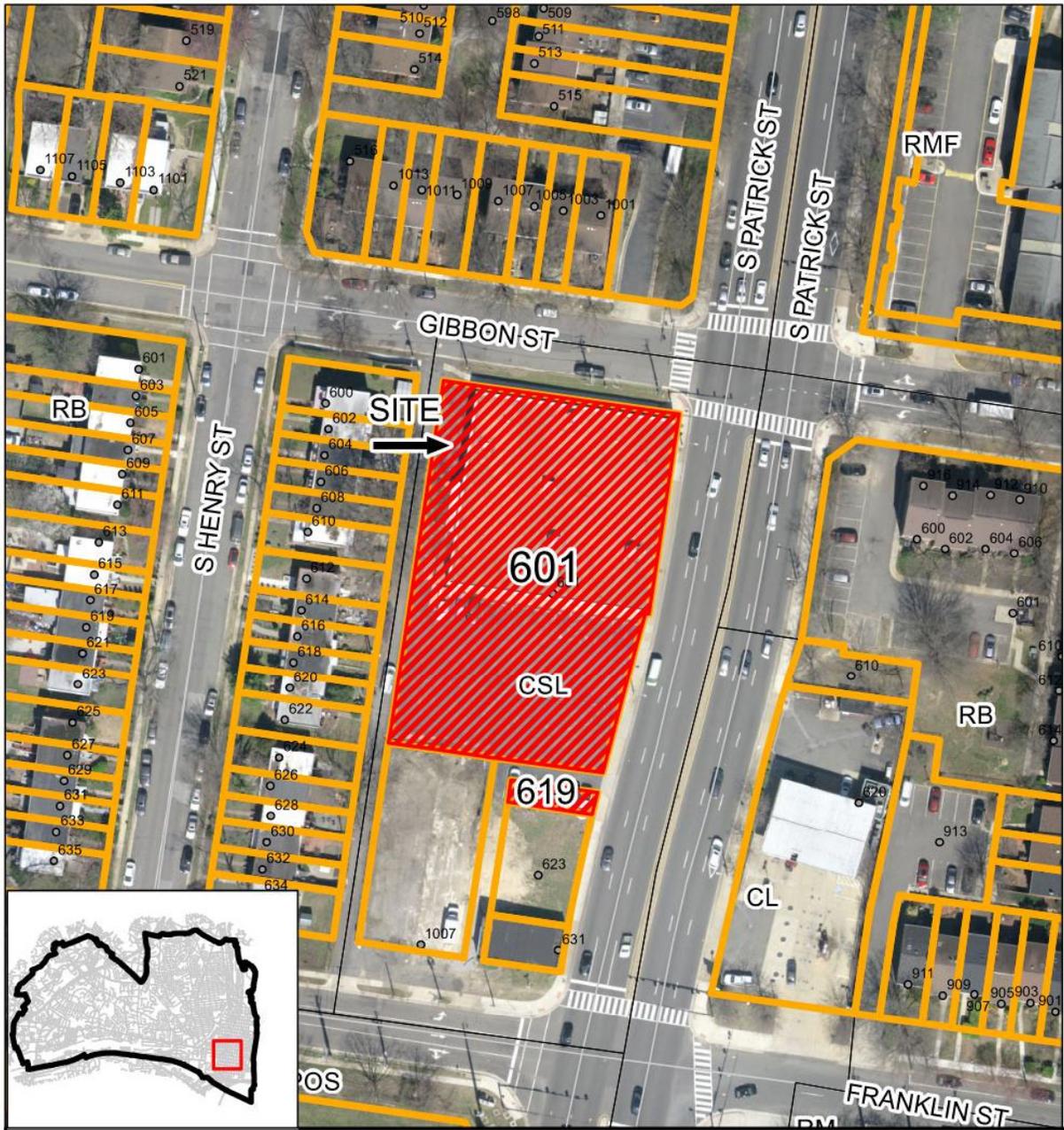
Speakers:

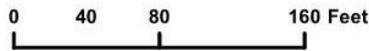
Shelley Castle, 612 S. Henry Street, spoke in opposition of the request. Ms. Castle expressed concerns over noise and lighting later into the evening.

Jeff Erickson, 612 S. Henry Street, spoke in opposition of the request. Mr. Erickson was mainly concerned about noise and light later in the evening. He also mentioned concerns over the traffic in the adjacent alley.

## I. PROPOSAL

The applicant, Valhalla Property Holding, LLC, requests Special Use Permit (SUP) approval for an outdoor recreational and entertainment use. The applicant proposes converting an existing retail building at 601 South Patrick Street to a health and athletic club with a rooftop outdoor workout space. The rooftop facility will contain various exercise equipment including weight machines, a running track around the perimeter of the roof with glass railings, and turf in the center. The outdoor workout space is considered an outdoor recreation or entertainment use and requires SUP approval. Staff recommends approval of this request.

### SITE DESCRIPTION

On May 7, 1963, the Planning Commission approved site plan SIT #63-0037 for the construction of an auto accessories store, Auto Accessories Company, Inc. Various retailers have operated out of the site since its construction and West Marine Supply currently occupies the space.

The subject property is one lot of record having 146 feet of frontage on Gibbon Street and 238 feet of frontage on South Patrick Street. The lot is 32,749 square feet and contains a one-story, 15,035 square foot building currently occupied by a West Marine retail store. A surface parking lot with 40 spaces is located on the south side of the building. The building's main entrance faces the parking lot and is shown in Figure 1, below.

The subject property is surrounded by both commercial and residential uses. The adjacent properties to the north and west contain townhouse dwellings. To the south is a commercial building containing a convenience store. Across Route 1 to the east is a Speedway gas station and more townhouse dwellings.

Route 1, on which the subject property fronts, is a six-lane, major north-south arterial that provides access to the Beltway. The immediate area experiences heavy vehicular traffic.

ZONING/MASTER PLAN DESIGNATION

**Use Requirements**

The subject site is located in the CSL/Commercial Service Low zone. Health and athletic clubs are a permitted use in the CSL zone pursuant to Section 4-302(F.1). Section 4-304(W.1) allows outdoor recreation or entertainment use – in this case, an outdoor workout facility – with approval of an SUP only.

**Master Plan Requirements**

The subject site is within the Southwest Quadrant Small Area Plan (SAP) and near the South Patrick Street Housing Affordability Strategy boundaries. The SAP designates the subject property for commercial uses that are compatible with the surrounding residential neighborhood. In general, the SAP also encourages a balance between commercial and residential spaces to create a dynamic mixed-use neighborhood.

## **II. STAFF ANALYSIS**

Staff supports the applicant's request to operate the outdoor workout space component on this CSL-zoned property. This section of South Patrick Street contains another retail use (a convenience store), two automobile-oriented uses (gas stations), and adjacent residential uses.

The applicant's proposal would increase activity at the subject property which would create additional vitality in the neighborhood as envisioned by the SAP. The proposed use would be consistent with the SAP as the facility would be a "neighborhood-serving retail/commercial" use and could be easily accessed on foot by nearby residents. The SAP also recommends transitional uses and buildings between Route 1 and adjacent residential areas. The building already provides a visual break between Route 1 and the townhouses behind it. Given that the existing building would remain, an appropriate transition between higher and lower intensity uses would be maintained.

The proposed rooftop space would accommodate running and weightlifting activities. While some noise would be generated from these activities and associated equipment, they are not inherently noisy because they involve individualized exercises that do not require amplified sound, vocal instruction, or motorized equipment.

Route 1 is a very busy roadway with substantial truck and general vehicular volume throughout the daytime and evening hours. Given the existing ambient noise levels generated by Route 1, any noise generated by the proposed outdoor activities would likely be negligible. Nevertheless, the applicant must observe the City's noise ordinance which limits noise levels to 65 decibels between 7am and 11pm, and to 60 decibels after 11pm. In addition, the applicant's proposal includes glass walls screening the entire roof to aid in noise mitigation. Staff has also recommended several conditions to ensure that noise impacts are minimized. Should recurrent noise complaints arise, however, further noise mitigation efforts may be required. Condition #10 enables staff to monitor the impact of the proposed use on the adjacent residences and to docket the matter for further consideration by Planning Commission and City Council if further noise mitigation is found necessary.

Subject to the conditions stated in Section III of this report, staff recommends approval of the Special Use Permit request.

## **III. RECOMMENDED CONDITIONS**

Staff recommends approval subject to compliance with all applicable codes and ordinances and the following conditions:

1. The operator shall conduct employee training sessions on an ongoing basis to advise employees of these conditions. (P&Z)
2. Outdoor hours of operation shall be limited to 7:00 a.m. to 11:00 p.m., daily. (P&Z)
3. All rooftop outdoor lighting shall be shut off by 11:00 p.m., daily. (P&Z)

4. Instructor-led classes using amplified sound are not permitted on the rooftop. (P&Z)
5. Screening along the rooftop shall be required on the sides of the building that abut residential properties. (P&Z)
6. Supply deliveries, loading, and unloading activities shall not occur between the hours of 11:00pm and 7:00am. (T&ES)
7. Chemicals, detergents or cleaners stored outside the building shall be kept in an enclosure with a roof. (T&ES)
8. Trash and garbage shall be stored inside or in sealed containers that do not allow odors to escape, invasion by animals, or leaking. No trash or debris shall be allowed to accumulate outside of those containers. Outdoor containers shall be maintained to the satisfaction of the Directors of P&Z and T&ES, including replacing damaged lids and repairing/replacing damaged dumpsters. (P&Z) (T&ES)
9. The Special Use Permit shall be granted to the applicant only or to any business or entity in which the applicant has a controlling interest. (P&Z)
10. The Director of Planning and Zoning shall review the special use permit one year after it has been operational, and then again every three years for compliance with all conditions and may docket the matter for consideration by the Planning Commission and City Council if there have been documented violations of the permit conditions which were not corrected immediately, constitute repeat violations or which create a direct and immediate adverse zoning impact on the surrounding community; or the Director has determined that new or revised conditions are needed to offset land use impacts not addressed in the City Code. (P&Z)

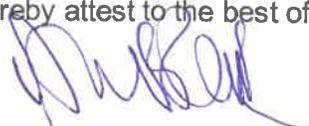

Valhalla Property Holding LLC, a Virginia limited liability (the "Applicant") is requesting a Special Use Permit for recreational and educational use for a roof top outdoor workout area associated with the first-floor health and athletic club. This Special Use Permit is only for the roof top recreational and educational use as the Health and Athletic Club is a by-right permitted use.

The Applicant plans to renovate the existing building and to convert it into a Scandinavian design, upscale bodybuilding gym. Extra windows will be added for natural light where windows have since been sealed up. The health and athletic club will be open 24 hours, seven days a week, with staff on hand. Personal trainers will be available, but there will be no "workout classes." The facility will be an open concept layout. There will be state-of-the art heavy lifting equipment, and cardio machines. Along the north wall will be the locker rooms, with a central area between them for hot saunas, cold plunges, and red-light therapy. There will also be a posing room for athletes to practice their stage routines.

On the rooftop there will be outdoor space for working out along with battle ropes, cages for lifting, tires for flipping, and push/pull sleds as well as a large walking lap around the perimeter of the roof with glass railings and green turf in the center.

This facility will refresh that part of town with new life and will be a popular spot for people going to and from work.

We have basic gyms and grungy gyms in Alexandria, but nothing that combines both heavy lifting and an upscale "spa like" appeal.

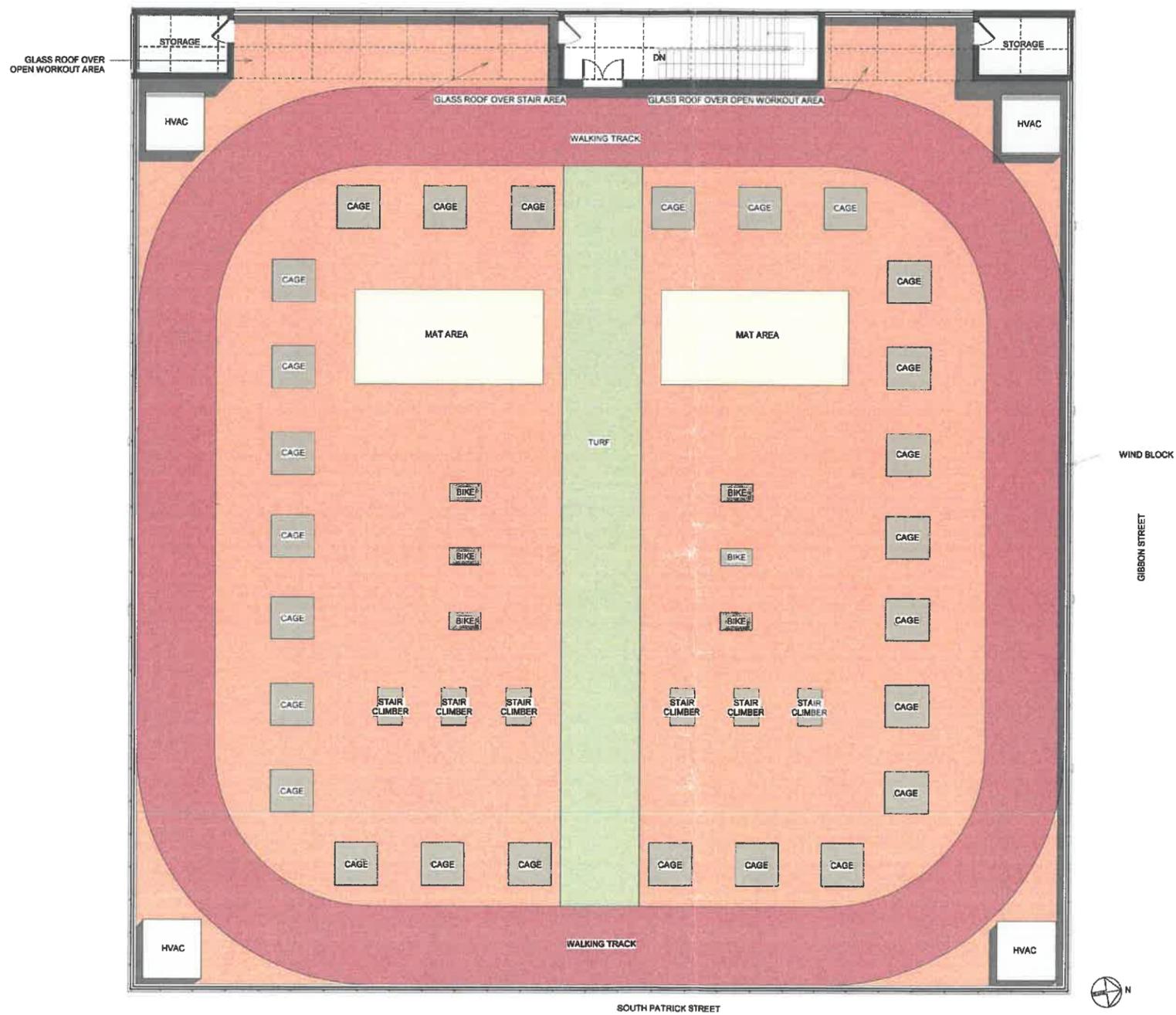

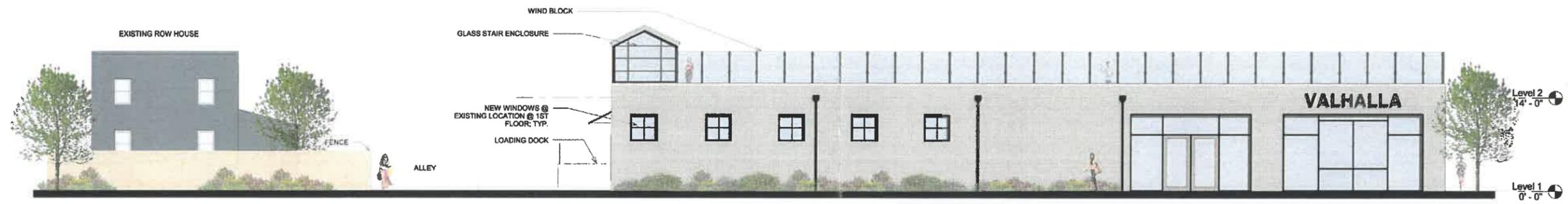
