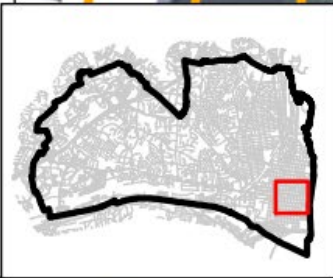
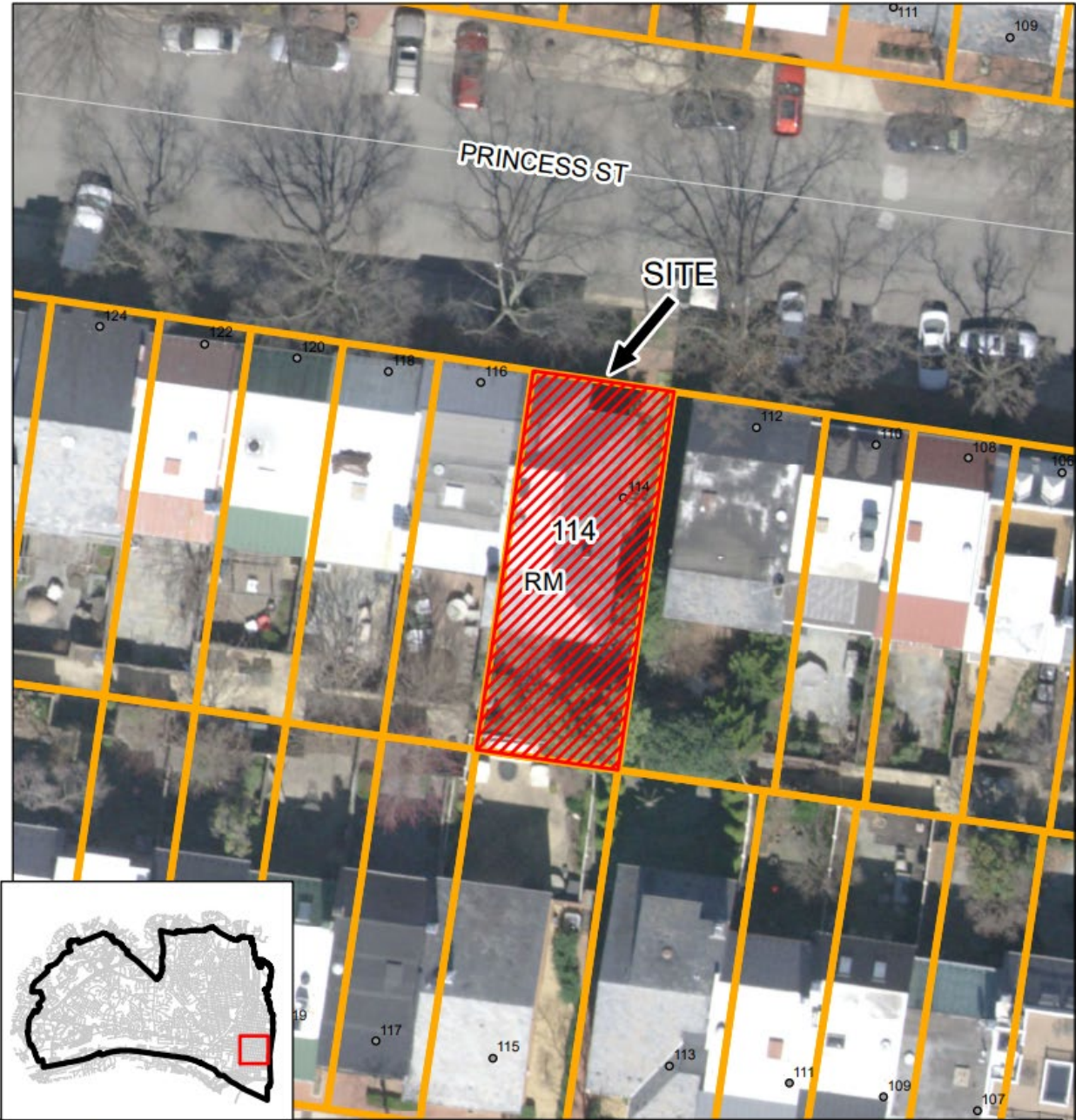
**STAFF RECOMMENDATION**


Staff recommends approval of the Permit to Demolish/Capsulate and Certificate of Appropriateness for alterations, with the following conditions:

1. The masonry is stained or limewashed/whitewashed rather than painted.
2. The deck/trim of the proposed third-floor balcony on the north elevation is made of wood or metal.
3. The proposed windows are full-frame replacements rather than insert windows.
4. Work with staff to revise/simplify the composition of the windows on the east elevation.

**GENERAL NOTES TO THE APPLICANT**

1. **APPEAL OF DECISION:** In accordance with the Zoning Ordinance, if the Board of Architectural Review denies or approves an application in whole or in part, the applicant or opponent may appeal the Board's decision to City Council on or before 14 days after the decision of the Board.
2. **COMPLIANCE WITH BAR POLICIES:** All materials must comply with the BAR's adopted policies unless otherwise specifically approved.
3. **BUILDING PERMITS:** Most projects approved by the Board of Architectural Review require the issuance of one or more construction permits by Department of Code Administration (including signs). The applicant is responsible for obtaining all necessary construction permits after receiving Board of Architectural Review approval. Contact Code Administration, Room 4200, City Hall, 703-746-4200 for further information.
4. **ISSUANCE OF CERTIFICATES OF APPROPRIATENESS AND PERMITS TO DEMOLISH:** Applicants must obtain a copy of the Certificate of Appropriateness or Permit to Demolish PRIOR to applying for a building permit. 5. **EXPIRATION OF APPROVALS NOTE:** In accordance with Sections 10-106(B), 10-206(B) and 10-307 of the Zoning Ordinance, any Board of Architectural Review approval will expire 12 months from the date of issuance if the work is not commenced and diligently and substantially pursued by the end of that 12-month period.
6. **HISTORIC PROPERTY TAX CREDITS:** Applicants performing extensive, certified rehabilitations of historic properties may separately be eligible for state and/or federal tax credits. Consult with the Virginia Department of Historic Resources (VDHR) prior to initiating any work to determine whether the proposed project may qualify for such credits.

**Note:** Staff coupled the applications for a Permit to Demolish (BAR #2024-00405) and Certificate of Appropriateness (BAR #2024-00404) for clarity and brevity. The Permit to Demolish requires a roll call vote.

## **I. APPLICANT'S PROPOSAL**

Note: Several alterations included in the application, such as alterations to the rear (south) elevation and moving the AC units to the roof deck, will not be visible from a public right-of-way and thus are not discussed in this report.

### Permit to Demolish/Capsulate

The applicant requests a Permit to Demolish/Capsulate to:

- Demolish 650 square feet of existing roofing material for the construction of a fourth-floor addition and roof deck
- Demolish a 33.9 square foot section of the northeast corner
- Demolish sections of masonry to create several new and enlarged window/door openings on the north and east elevations

### Certificate of Appropriateness

The applicant requests a Certificate of Appropriateness to:

- Construct a new roof deck with a 42" tall black wrought-iron railing
- Construct a new black standing seam metal front roof
- Construct a fourth-floor addition
- Build out the northeast corner by 4'8" and re-brick
- Enlarge, add, and replace all windows on the north and east elevations
- Replace and add doors on the north and east elevations
- Add a balcony with 36" tall wrought iron railing to the third floor on the north elevation
- Add a Juliet balcony with 36" tall wrought iron railing to the second floor on the north elevation
- Paint or whitewash the masonry on all elevations
- Install three coach lights on the north elevation, one adjacent to the garage door and two flanking the Juliet balcony doors on the second floor
- Replace the garage door with a black painted wood garage door, with no windows

The applicant has provided the following material specifications for the proposed windows/doors:

- All doors will be Anderson A Series wood doors, painted black
- The north and east elevation windows will be Anderson 100 Series Fibrex insert windows with a black exterior, full divided light, dual-pane, with clear Low-E glass and ¾" grilles.

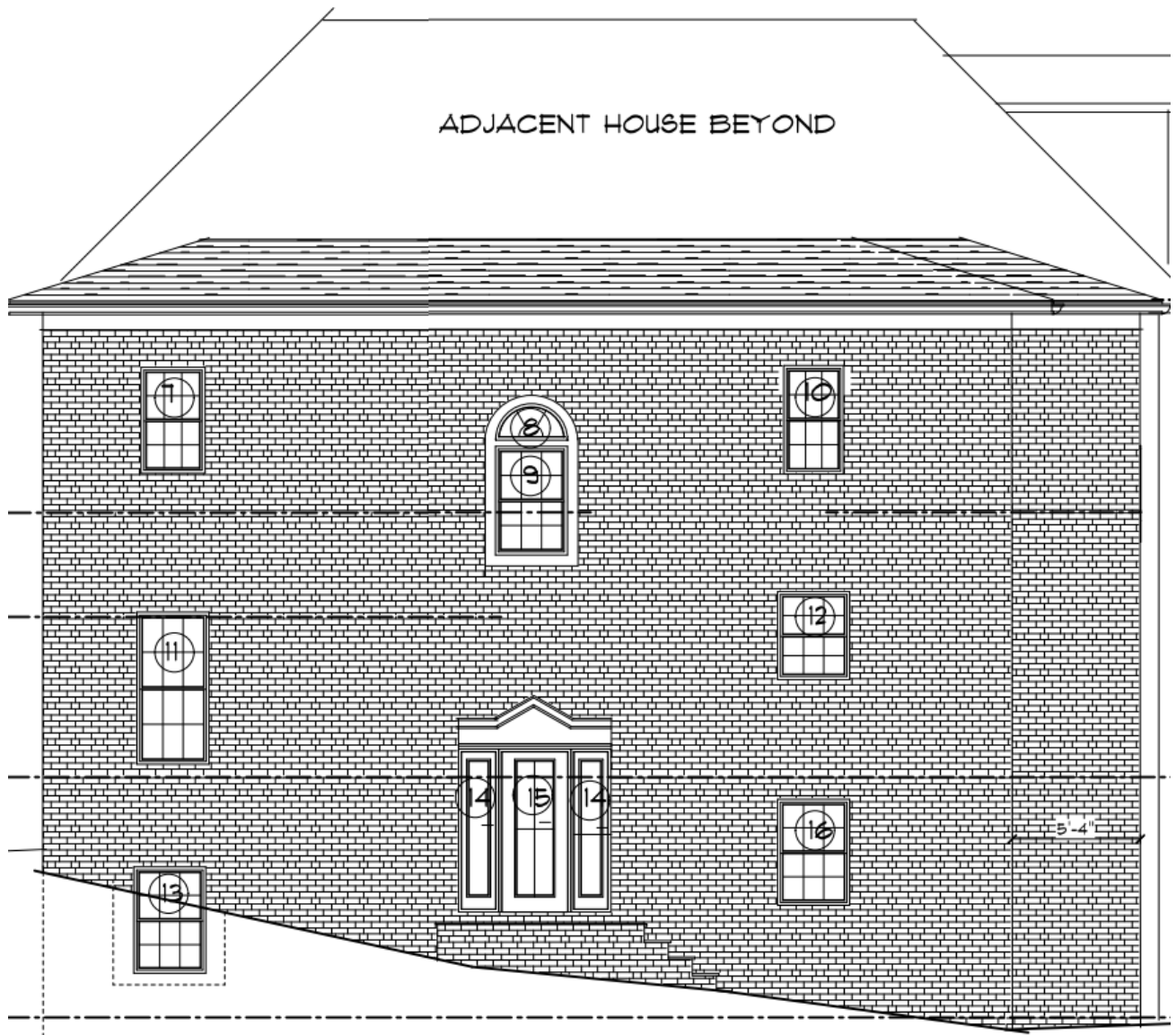


*Figure 1. Existing north elevation.*

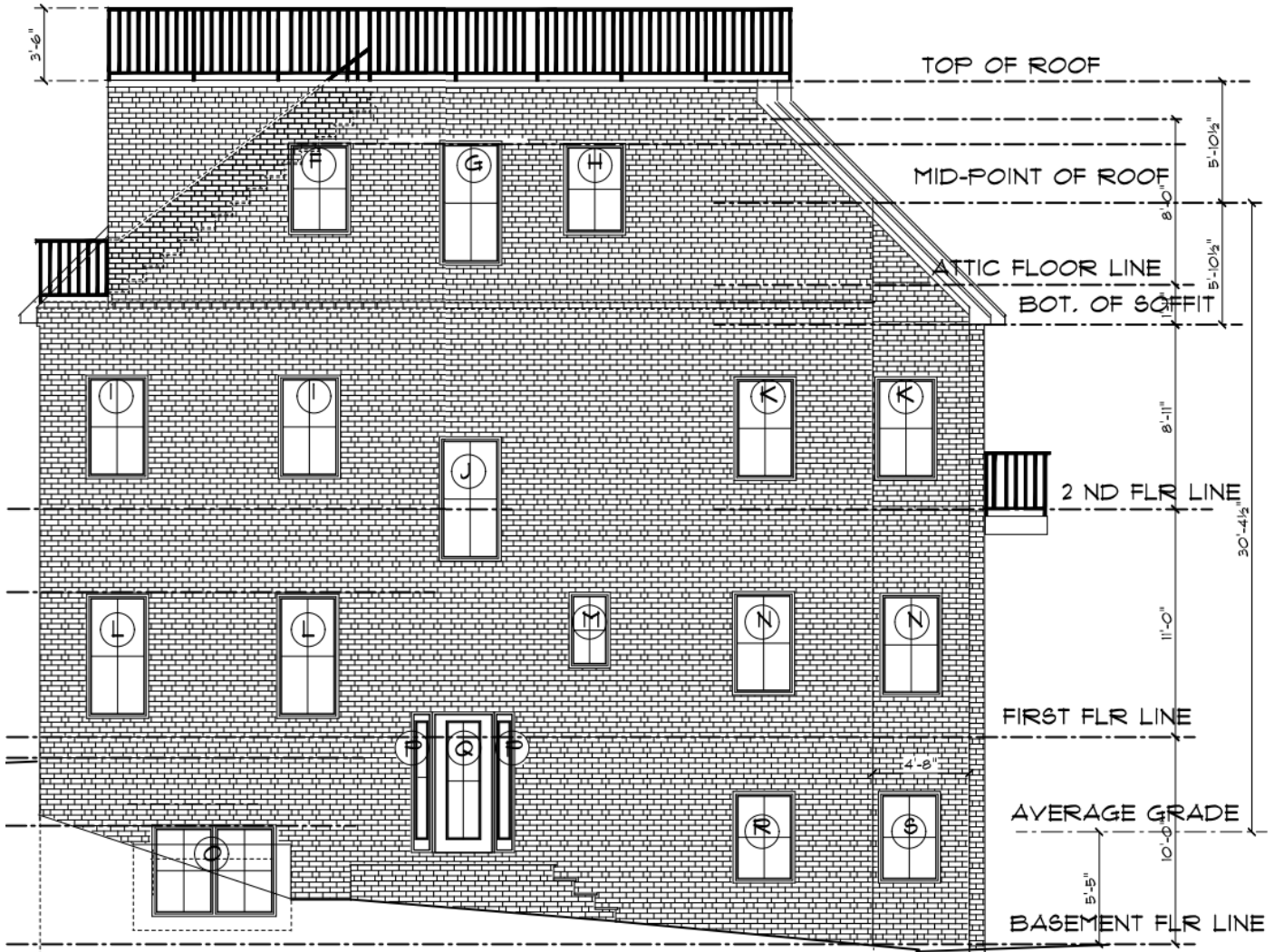




Figure 2. Proposed north elevation.

Site context

The subject property is bound by Princess Street to the north and on all other sides by neighboring townhomes. The alterations will primarily be visible from Princess Street. Due to the property's mid-block location, it is likely that the alterations will be only minimally visible from both North Union Street and North Lee Street.

**II. HISTORY**

The dwelling at 114 Princess Street is one of a group of 86 brick townhouses bounded by North Union, North Lee, Queen and Oronoco streets which was approved by City Council in 1968 (Special Use Permit #1084) and constructed in **1971**. The attached brick townhouses are similar in design with a garage door and front entrance on the first floor and punched window openings or bay windows on the second floor, all with simple vernacular Colonial Revival detailing. This area was not included in the Old and Historic Alexandria District between the late 1960s and June of 1984 and, based on staff's research, was included in the district at that time, a little more than 10 years after these townhouses were built, at the request of the property owners who lived there at

the time. The Board has reviewed and approved well over a hundred additions and/or alterations (bay windows, roof decks and dormers primarily) to houses in this development since 1984.

Previous BAR Approvals

None.

**III. ANALYSIS**

Permit to Demolish/Capsulate

In considering a Permit to Demolish/Capsulate, the Board must consider the following criteria set forth in the Zoning Ordinance, §10-105(B) which relate only to the subject property and not to neighboring properties. The Board has purview of the proposed demolition/capsulation regardless of visibility.

In the opinion of staff, none of the criteria for demolition and capsulation are met, as the building was constructed in the early 1970s and has not achieved historic significance. The townhouse is typical of the types of vernacular townhomes constructed in Alexandria in the mid-to-late 20<sup>th</sup> century. The demolition does not remove any portion of the building containing character-defining features of uncommon design or historic merit and does not compromise the integrity of the



building. Staff therefore has no objection to the demolition/capsulation and recommends approval of the Permit to Demolish/Capsulate.

#### Certificate of Appropriateness

This townhome is part of a larger development of non-historic townhouses where the BAR has approved substantial alterations and redesigns since this development was included in the historic district in the 1980s. These townhouses lack historic significance or architectural distinction – they have a vaguely Colonial Revival character with the street level devoted to multiple curb cuts and garage doors – and in the opinion of staff, alterations to the building’s architectural style and character are appropriate.

The immediate context for this project is the other c. 1971 townhomes on the surrounding block. The townhomes on this block of Princess Street vary in height and scale. While most are three stories, several (such as 101, 112, and 119 Princess Street, and 401 North Lee Street) have received BAR approval to construct roof decks, and others (such as 118 and 119 Princess Street) have received BAR approval to add a fourth floor. The roof decks and additions that have been approved by the Board have incorporated various contemporary designs that are appropriate for these modern townhomes. Allowing the subject property to add a roof deck and additional story would not set any new precedents on the block and would be compatible with several projects that the Board has already approved in recent years.

In cases such as this, where there is no historic context to protect, the BAR has given applicants a good deal of latitude to alter the original architectural style and to accommodate personal taste, as long as the proposal itself is well-designed. Staff believes that the overall design of the proposed alterations and addition are a thoughtful improvement over the existing design. However, staff does have some minor concerns about some aspects of the design. First, staff finds that the composition of the windows on the east elevation is visually overwhelming and should be simplified. Additionally, the window specifications provided indicate that all windows will be Fibrex insert windows. According to the *BAR Policies for Administrative Approval*, “replacement windows must be full frame replacements, rather than insert or pocket style replacements.” While staff does not have any issues with the use of Fibrex material on a Later building, the proposed windows should be full frame replacements to comply with the adopted policies. Staff is willing to work with the applicant to address these concerns.

Furthermore, the applicant has requested to either paint or whitewash the masonry on the subject property. Staff does not support painting this unpainted red brick. The *Design Guidelines* state that “painting a previously unpainted masonry surface, no matter what color, requires review and approval of a Certificate of Appropriateness by the Board. Additionally, the Board strongly discourages the painting of a previously unpainted masonry surface.” The *Design Guidelines* have been designed in a way to distinguish what is appropriate in one part of the district or at one building from what may not be appropriate in other areas or on other buildings, so each request is reviewed on a case-by-case basis. Notably, in 2013, 101 Princess Street received BAR approval to paint the unpainted red brick of that property white, due to a tied 3-3 vote in which the Board took no action, meaning the application was automatically approved (BAR #2013-00036). The Board also recently approved staining/limewashing at 107 Princess Street (BAR #2023-00160). Staining or limewashing is less damaging to brick than paint, and limewashing is somewhat reversible,

while painting is more permanent. Additionally, there are no painted masonry buildings on this block except for 101 Princess. For these reasons, staff would support staining or limewashing of the masonry of the subject property, but not painting.

Therefore, staff recommends approval of the Certificate of Appropriateness for alterations, with the following conditions:

1. The masonry is stained or limewashed/whitewashed rather than painted.
2. The deck/trim of the proposed third-floor balcony on the north elevation is made of wood or metal.
3. The proposed windows are full-frame replacements rather than insert windows.
4. Work with staff to revise/simplify the composition of the windows on the east elevation.

## **IV. CITY DEPARTMENT COMMENTS**

### **Zoning**

C-1 The proposed front addition, attic addition and roof deck addition will comply with Zoning.

F-1 Properties within this development are subject to BZA-1084 for FAR compared to the RM district.

F-2 Max FAR for this property is 1.21 instead of the 1.50 allowed by the RM zone.

### **Code Administration**

C-1 If the building is changed to a 4-story residential house, the occupancy classification will shift from R-5 to R-3. Consequently, the design code will transition from the Virginia Residential Code (VRC) to the Virginia Construction Code (VCC). A sprinkler system will be required to be installed per VCC Section 903.2.8.1, unless a code modification is obtained.

### **Transportation and Environmental Services**

R-1 The building permit must be approved and issued prior to the issuance of any permit for demolition, if a separate demolition permit is required. (T&ES)

R-2 Applicant shall be responsible for repairs to the adjacent city right-of-way if damaged during construction activity. (T&ES)

- R-3 No permanent structure may be constructed over any existing private and/or public utility easements. It is the responsibility of the applicant to identify any and all existing easements on the plan. (T&ES)
- F-1 After review of the information provided, an approved grading plan is not required at this time. Please note that if any changes are made to the plan it is suggested that T&ES be included in the review. (T&ES)
- C-1 The applicant shall comply with the City of Alexandria's Solid Waste Control, Title 5, Chapter 1, which sets forth the requirements for the recycling of materials (Sec. 5-1-99). (T&ES)
- C-2 The applicant shall comply with the City of Alexandria's Noise Control Code, Title 11, Chapter 5, which sets the maximum permissible noise level as measured at the property line. (T&ES)
- C-3 Roof, surface and sub-surface drains be connected to the public storm sewer system, if available, by continuous underground pipe. Where storm sewer is not available applicant must provide a design to mitigate impact of stormwater drainage onto adjacent properties and to the satisfaction of the Director of Transportation & Environmental Services. (Sec.5-6-224) (T&ES)
- C-4 All secondary utilities serving this site shall be placed underground. (Sec. 5-3-3) (T&ES)
- C-5 Any work within the right-of-way requires a separate permit from T&ES. (Sec. 5-2) (T&ES)
- C-6 All improvements to the city right-of-way such as curbing, sidewalk, driveway aprons, etc. must be city standard design. (Sec. 5-2-1) (T&ES)

**Alexandria Archaeology**

- F-1 Although the proposed undertaking will have little if no impact on below-ground archaeological resources, it is notable that the property once functioned as a plaster and later as a fertilizer mill, part of an industrial complex on the block that was in operation after the Civil War until the mid-20th century.
- R-1 Call Alexandria Archaeology immediately (703-746-4399) if any buried structural remains (wall foundations, wells, privies, cisterns, etc.) or concentrations of artifacts are discovered during development. Work must cease temporarily in the area of the discovery until a City archaeologist comes to the site and records the finds. The language noted above shall be included on all final site plan sheets involving any ground disturbing activities.
- R-2 The applicant shall not allow any metal detection and/or artifact collection to be conducted on the property, unless authorized by Alexandria Archaeology. Failure to

comply shall result in project delays. The language noted above shall be included on all final site plan sheets involving any ground disturbing activities.

- C-1 All required archaeological preservation measures shall be completed in compliance with Section 11-411 of the Zoning Ordinance.

The exterior painted aluminum surface (Kynar® fluorocarbon coating system conforming to AAMA 2605-05 ("2605 Coating System")) on components including frame, panel and grilles on Andersen entry doors in standard colors is warranted not to crack, chip, peel, flake, blister or lose adhesion for a period of twenty (20) years from the date of purchase from the retailer/dealer when exposed to normal atmospheric conditions. The paint film is warranted to be free from manufacturing defects resulting in color fade greater than 5 delta E (Hunter)^(^ in accordance with ASTM D2244-16e1 and chalking in excess of a number eight (8) rating based on ASTM D4214-07 for twenty (20) years from the date of purchase from the retailer/dealer when exposed to normal atmospheric conditions.

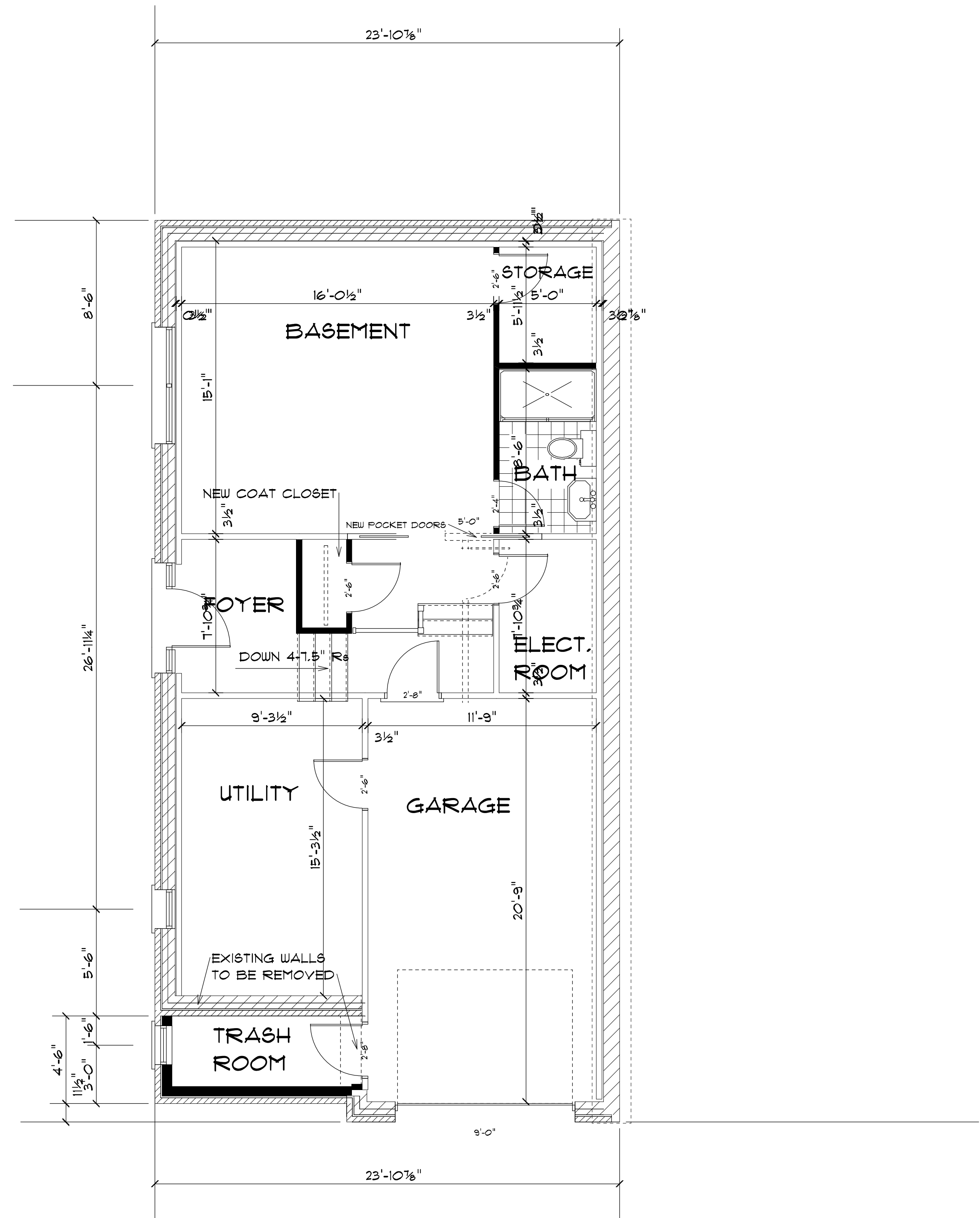

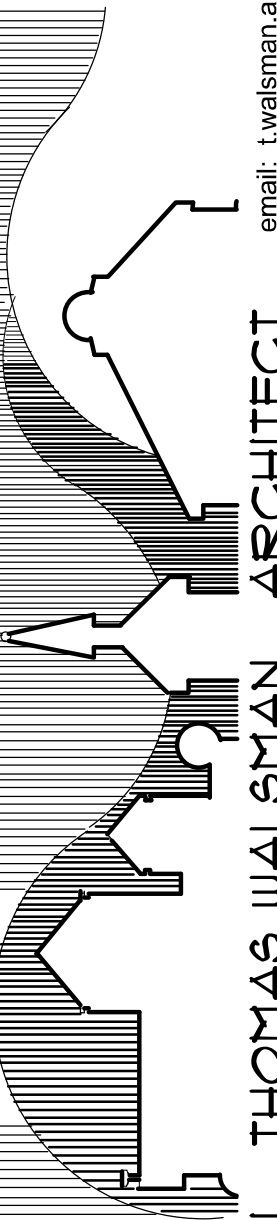
**PROPOSED BASEMENT FLOOR PLAN**

EXISTING AND PROPOSED BASEMENT FLOOR PLANS



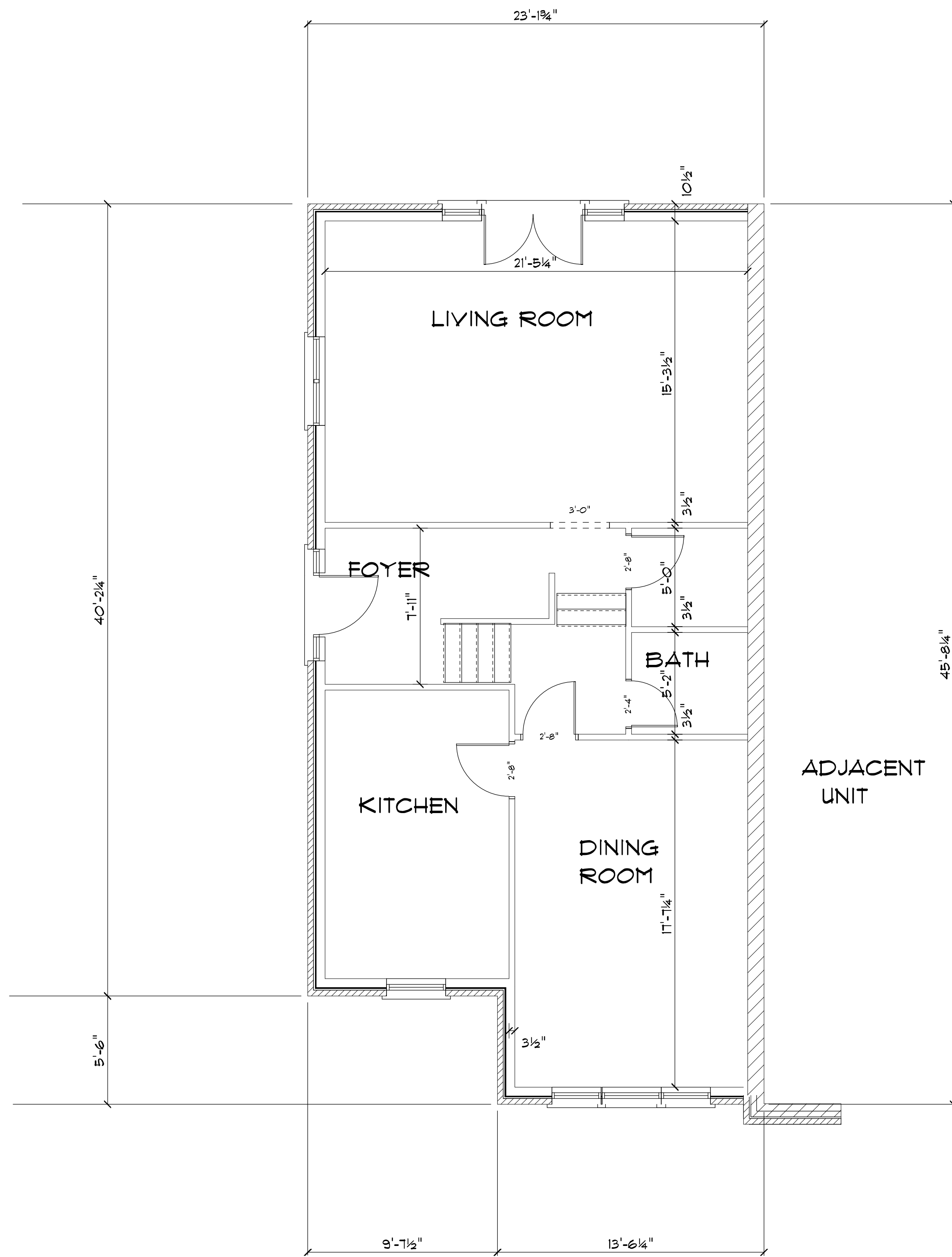

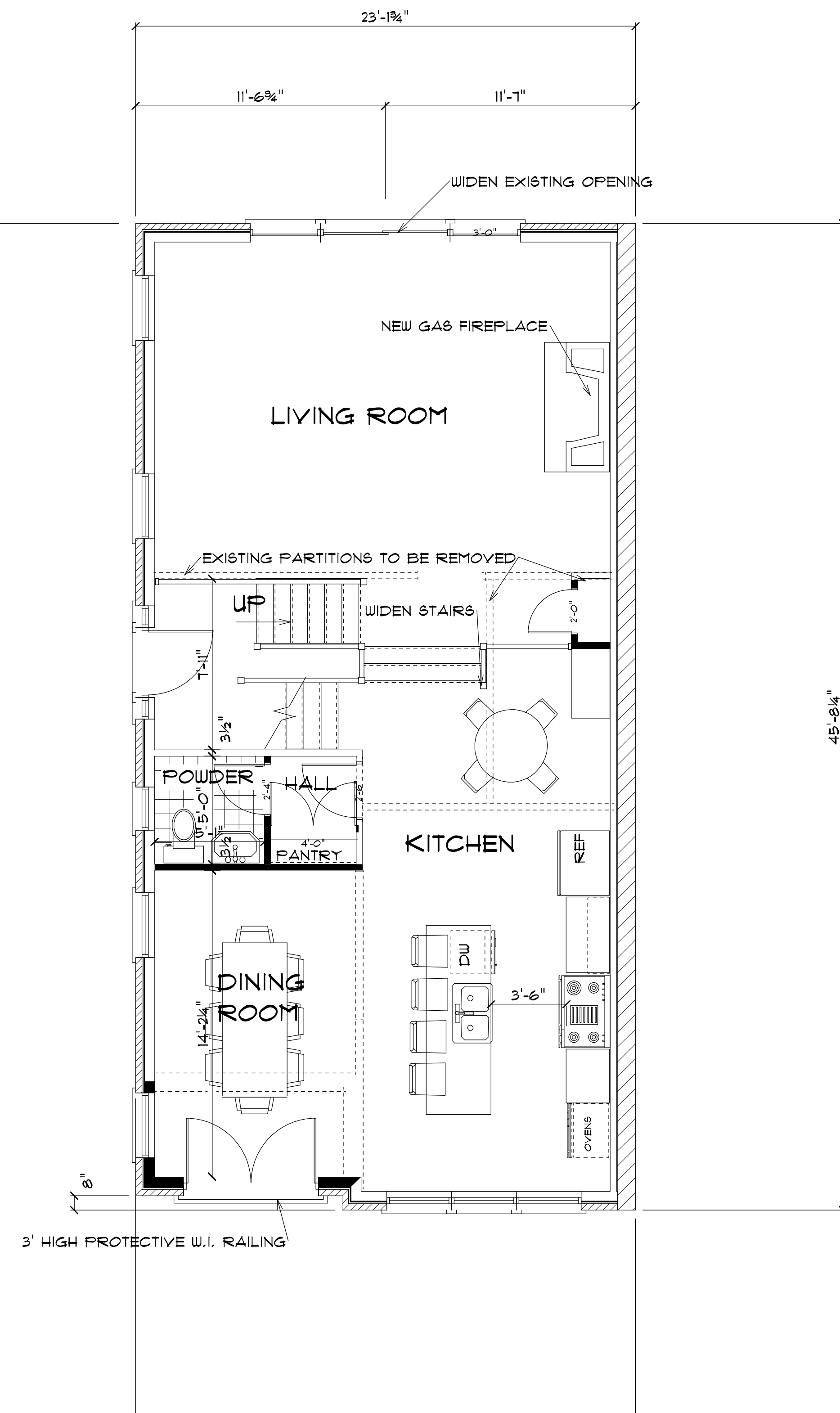

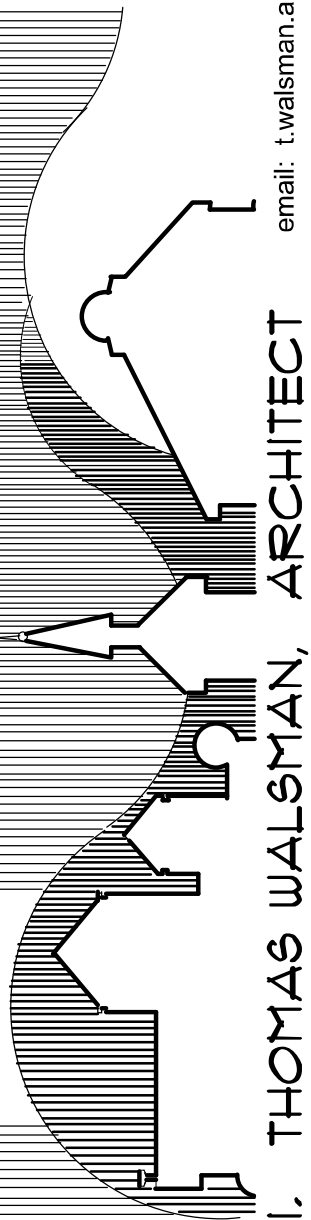
**EXISTING FIRST FLOOR PLAN**

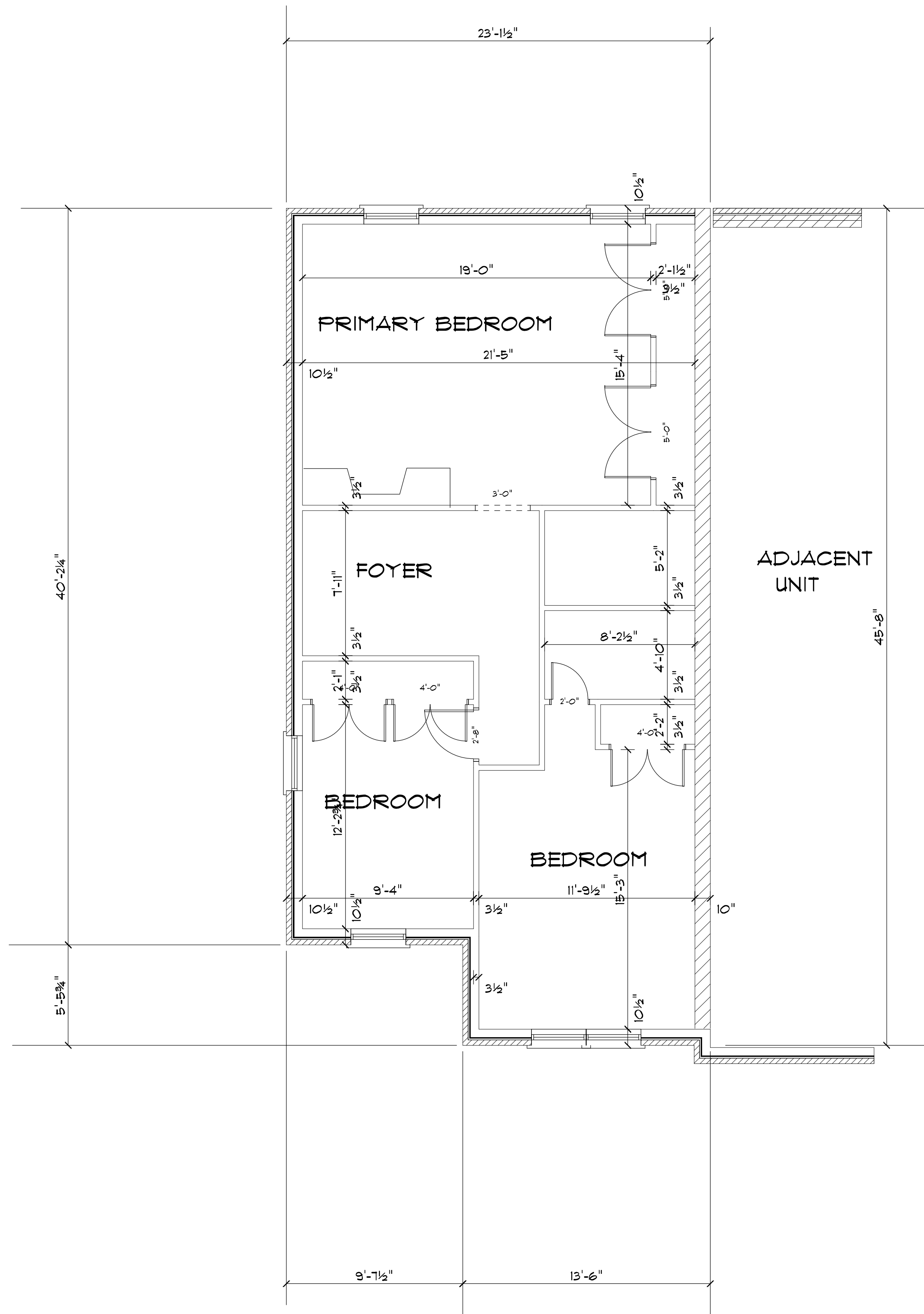

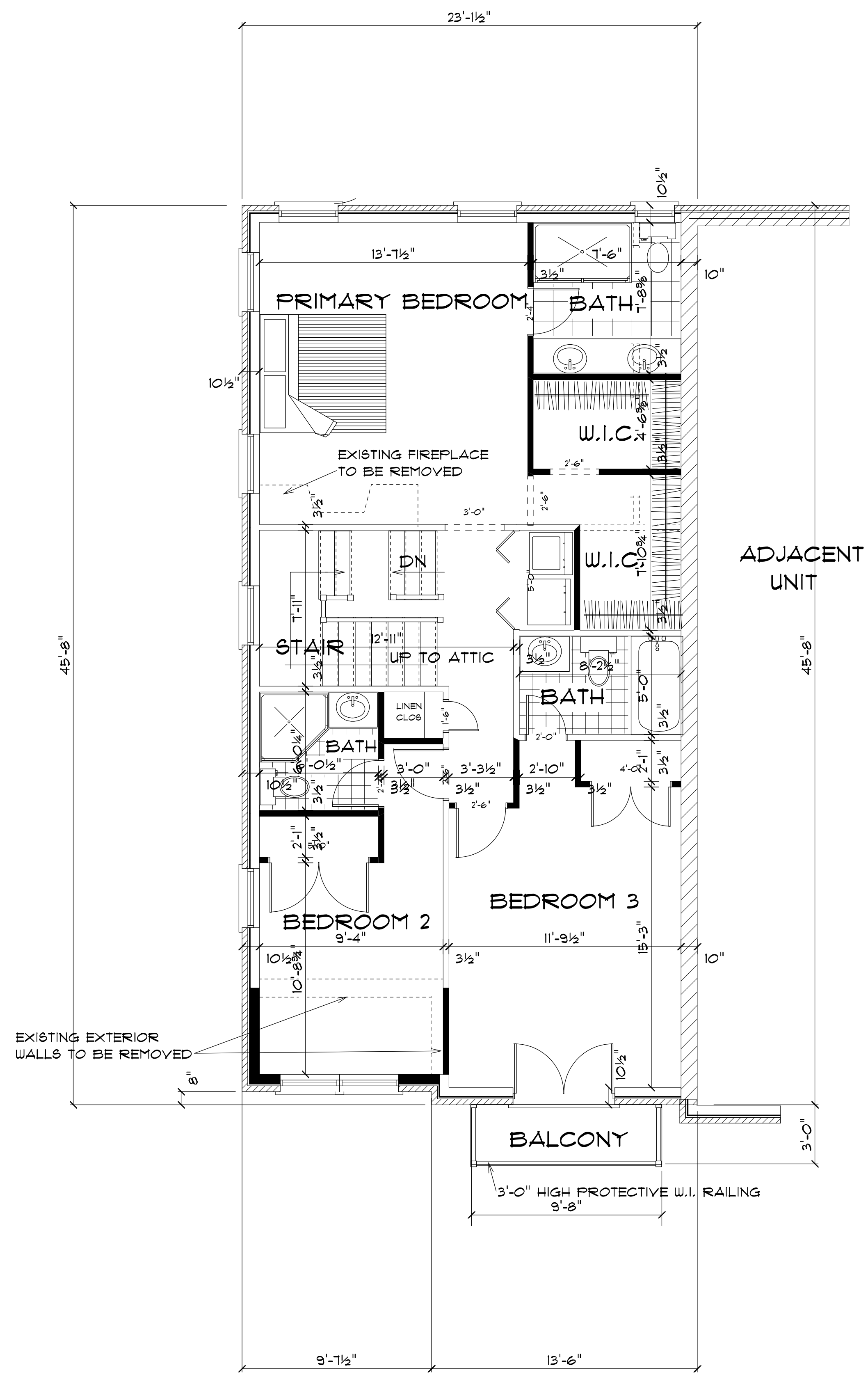

**EXISTING SECOND FLOOR PLAN**

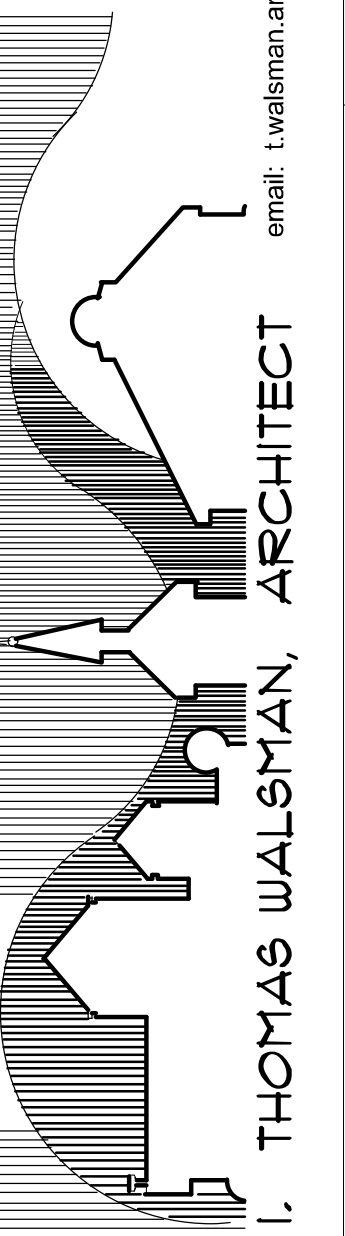

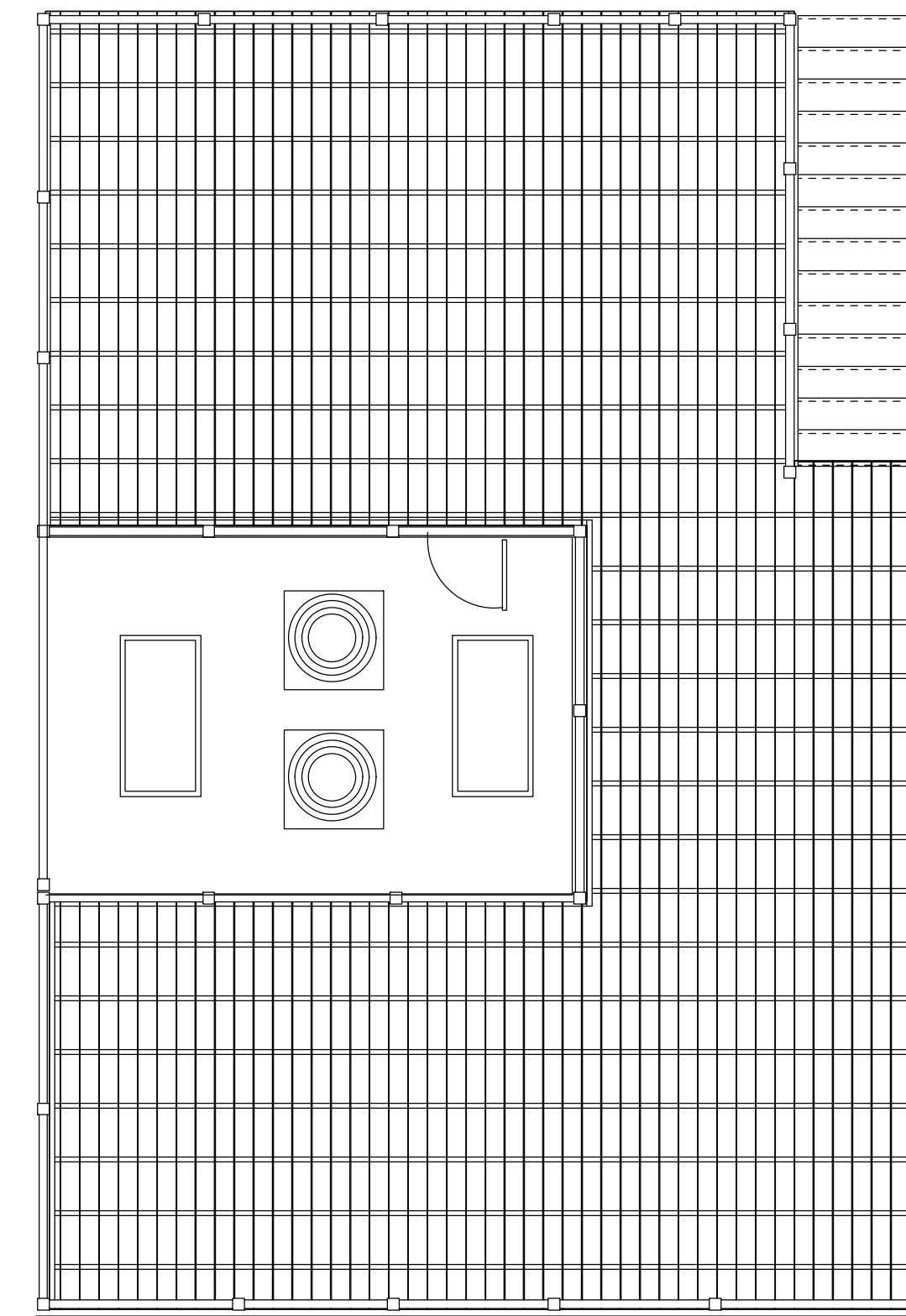

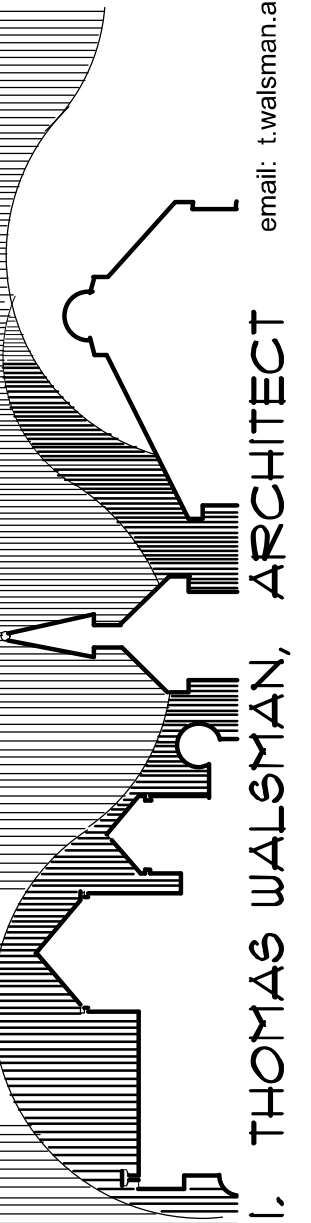

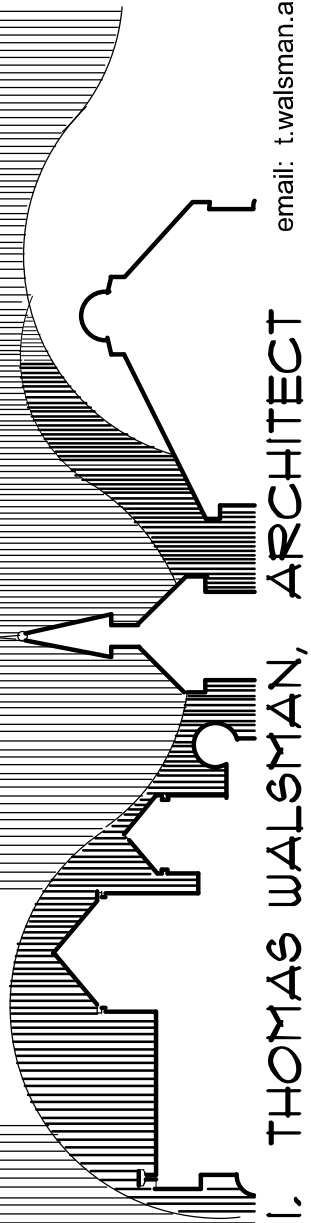


**EXISTING FRONT ELEVATION**

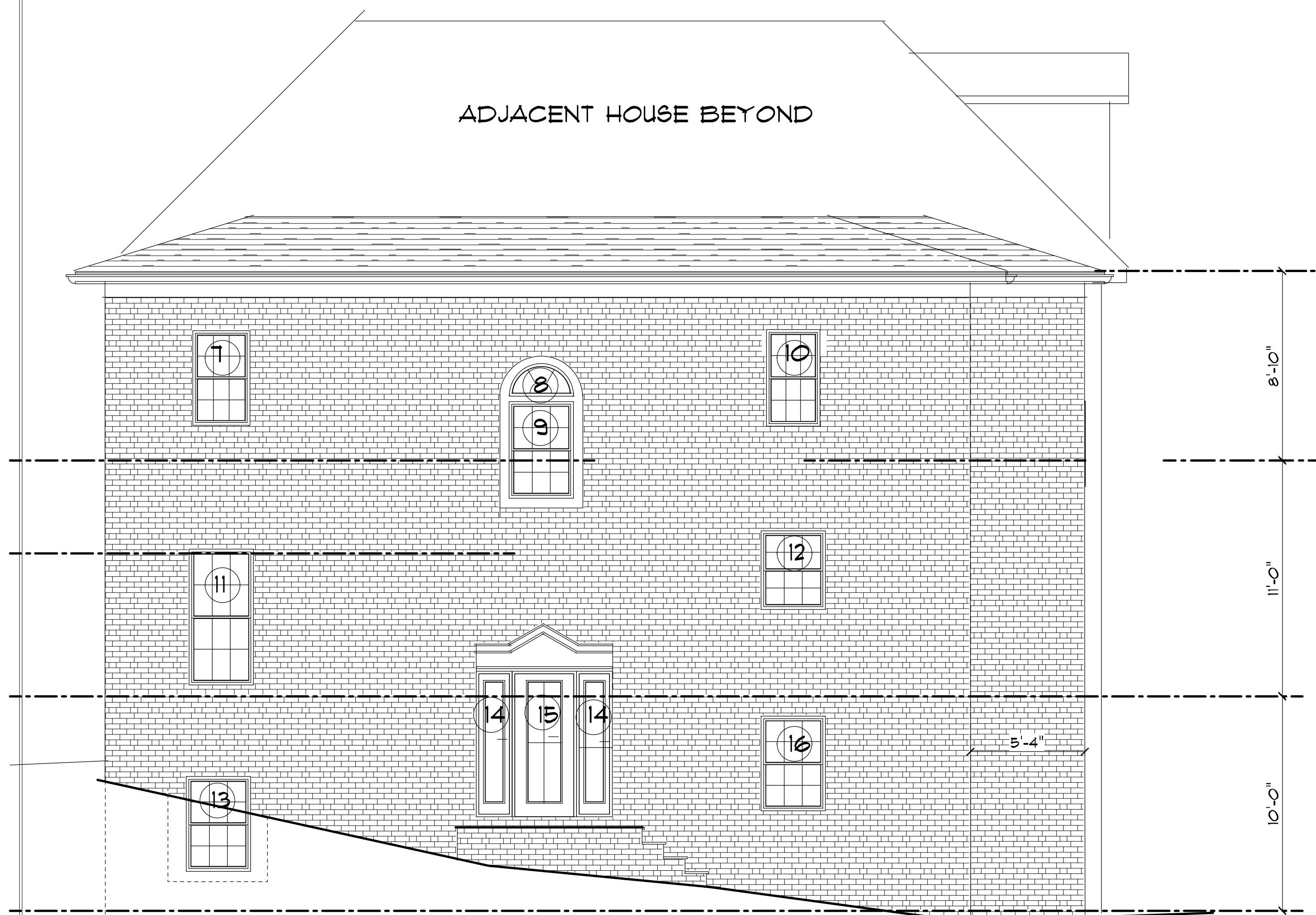

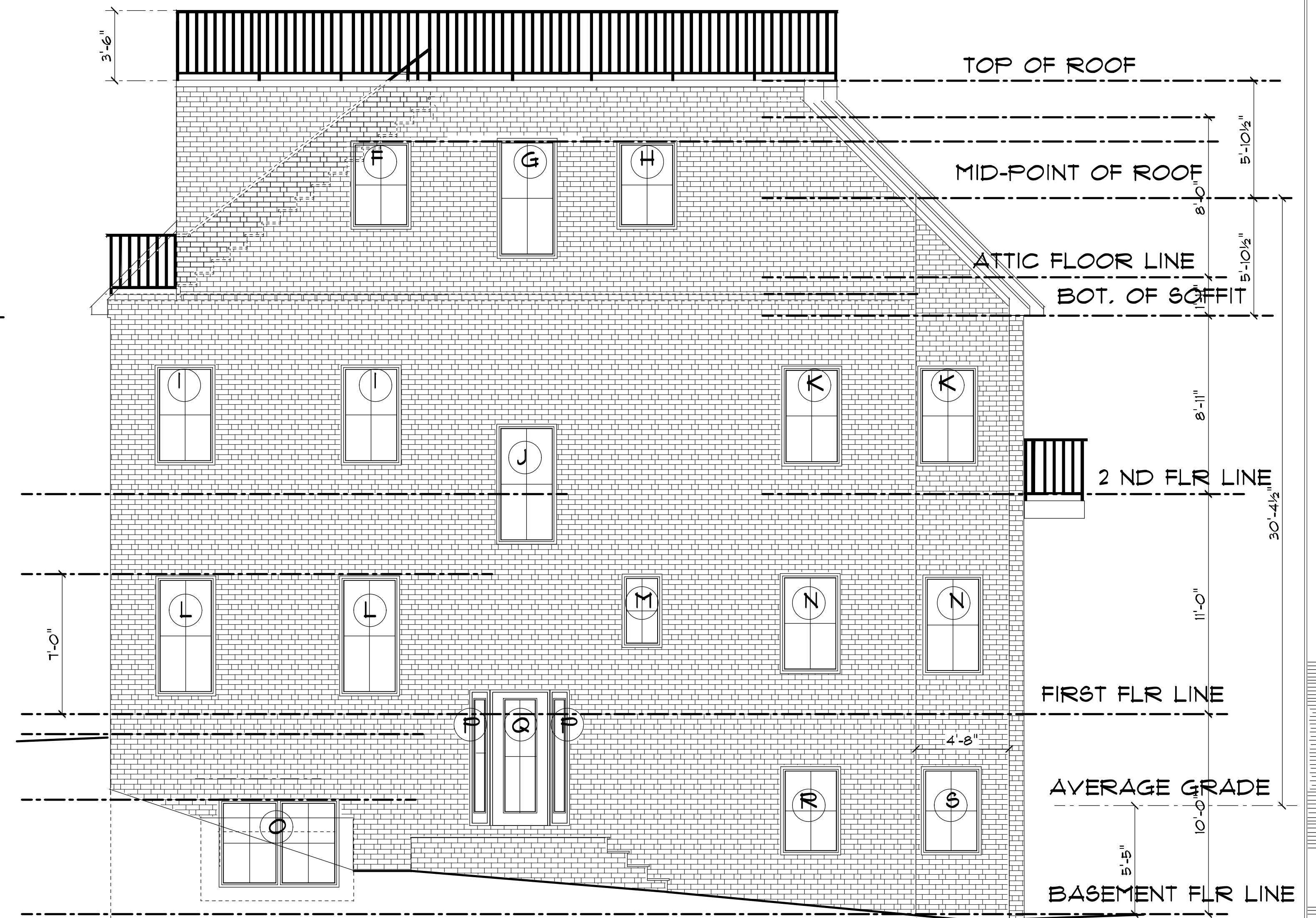

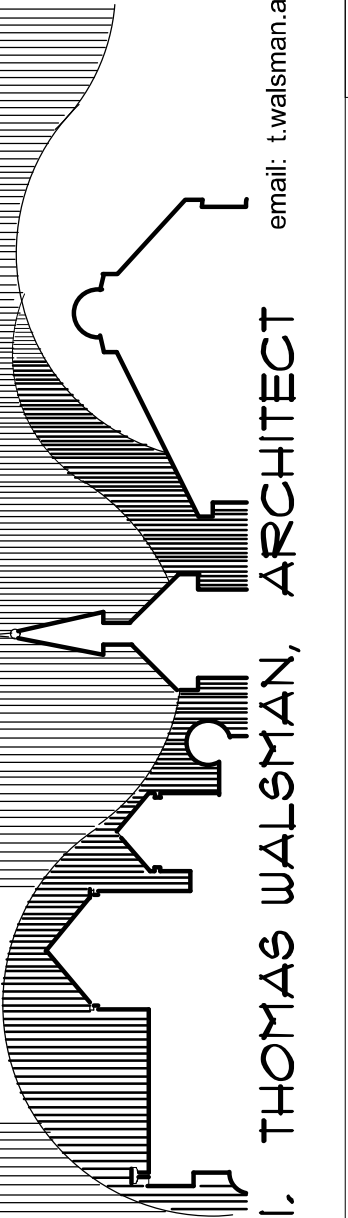


**EXISTING LEFT SIDE ELEVATION**

EXISTING AND PROPOSED LEFT SIDE ELEVATIONS



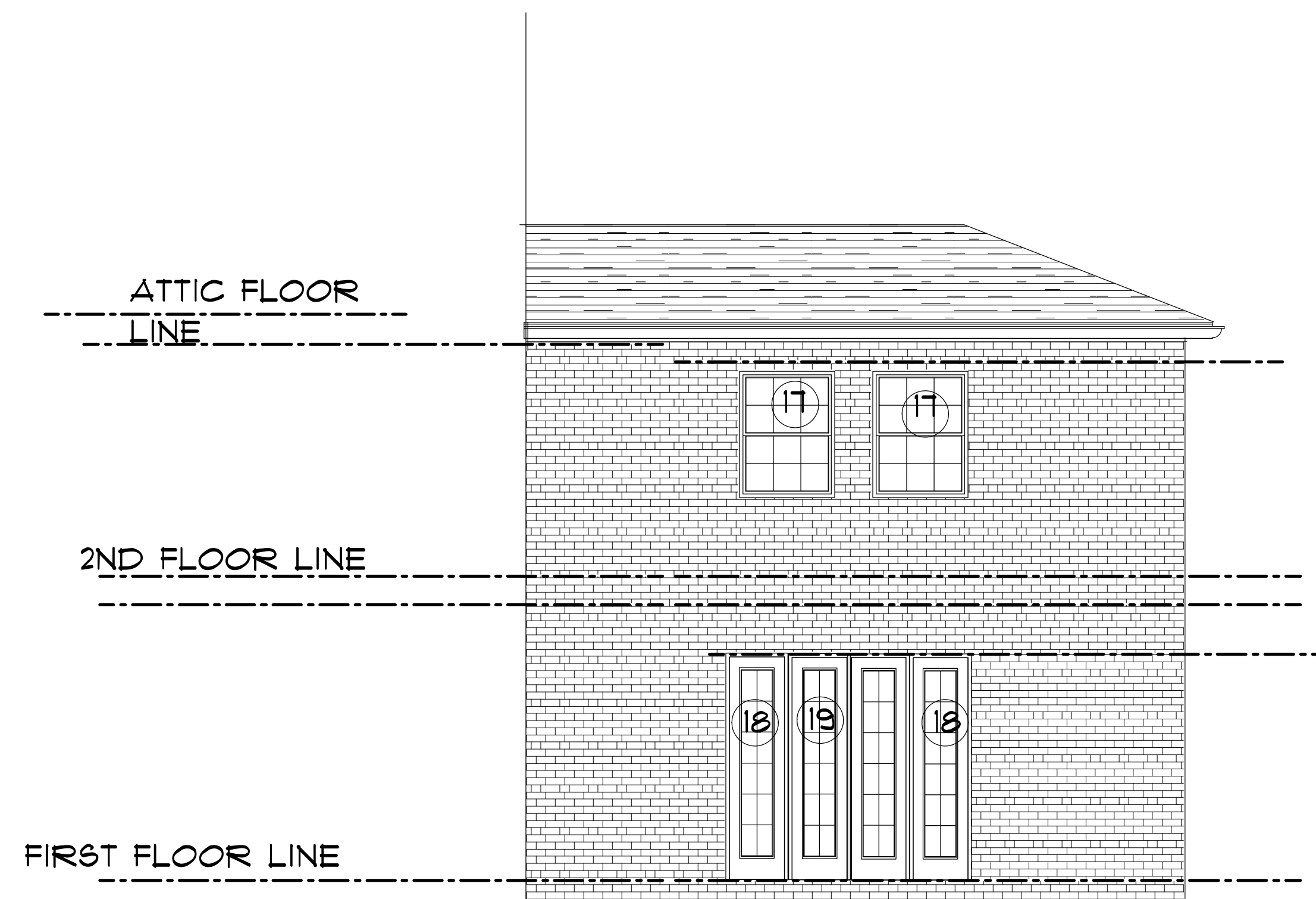

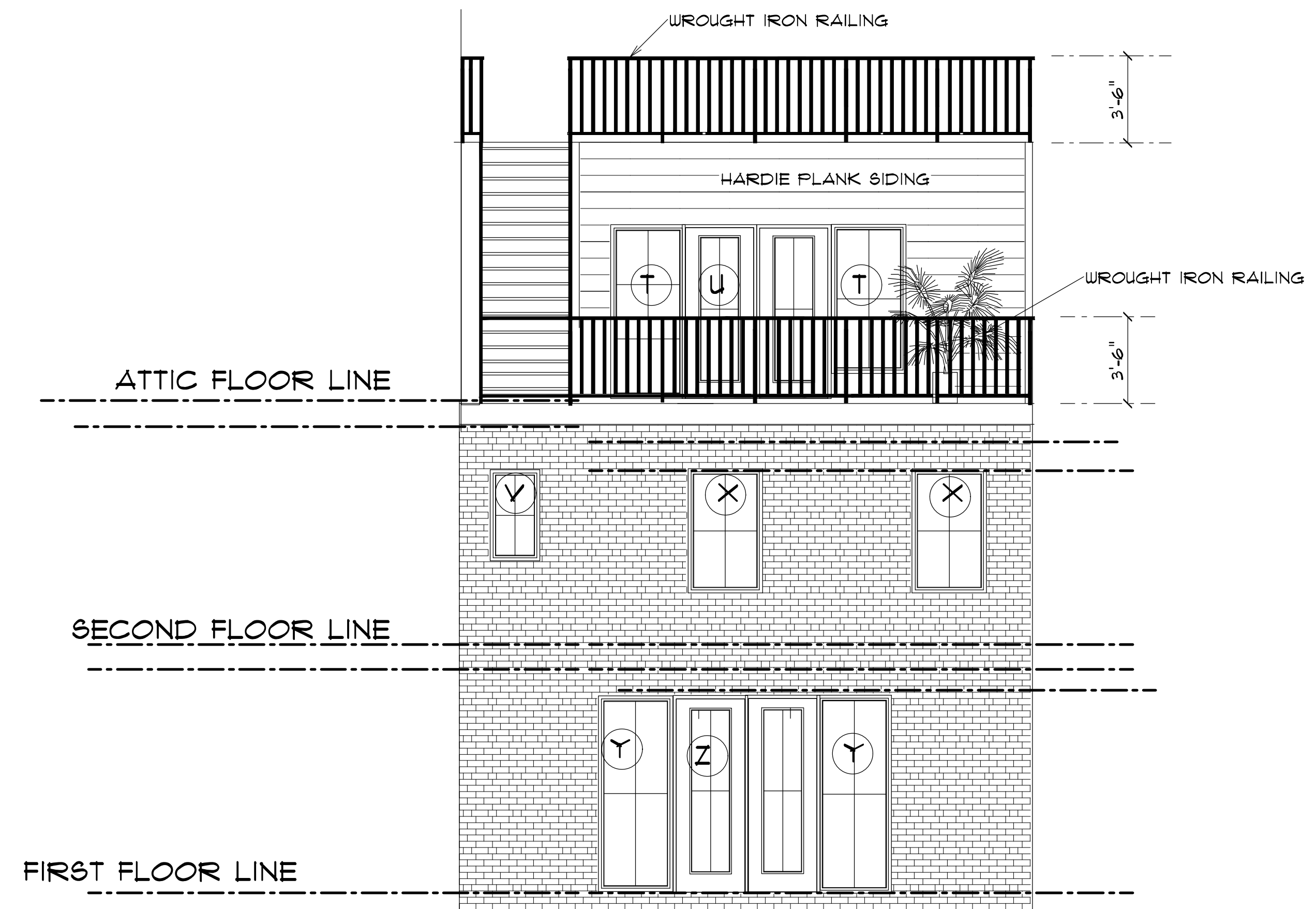

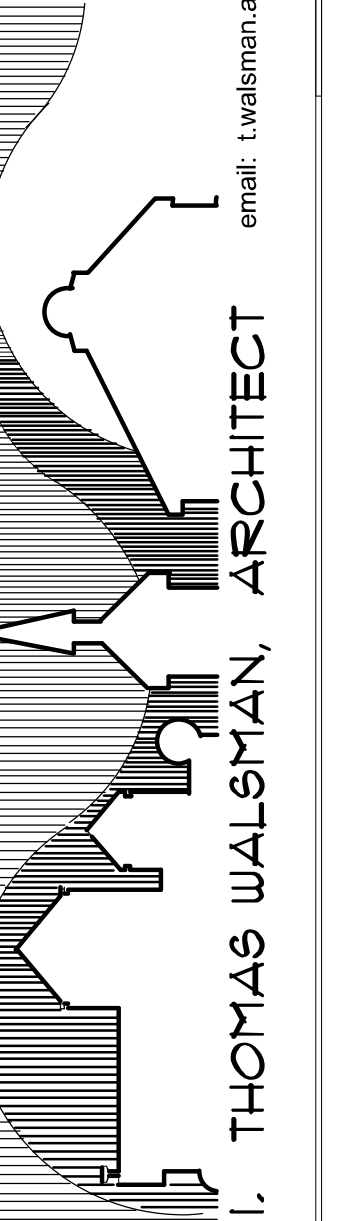


**EXISTING REAR ELEVATION**
