Statement of Interest

Hi, I'm Andy Scott, and I am applying for the October vacancy on the Board of Architectural Review (BAR). I recently completed a three-year term on the Board, and I am interested in continuing to serve in this capacity. You may recall that I applied to be re-appointed in September 2025, but I submitted my application after the deadline, so you could not properly consider my candidacy. I believe I am well-qualified for this vacancy, and I appreciate your consideration of my application. In my three years on the BAR, I was a leader and consensus builder among my colleagues. In that time, I witnessed firsthand how effective the Board is at preserving the historic character of our city while respecting the rights of property owners and developers. During my tenure, we exercised diligent oversight of large projects like the Samuel Madden housing complex, the residential conversion of CityHouse on 1101 King St., and the proposed condominium at 301 North Fairfax St. We approved all of these projects, and critically, the BAR made each of these projects better through the many hearings and meetings we held to help steer these applicants to guideline-conforming designs without undermining their overall vision. I believe the BAR sits at the critical nexus of historic preservation and forward progress in Alexandria, and I have been a leader on the Board in ensuring both of these ends are met. During my time on the Board, we did not deny a single application for a major development requiring a Development Special Use Permit (DSUP), but we did make all of them better by building community consensus, working with developers, and helping to drive applications to final approval. We also approved the vast majority of applications from individual homeowners. I considered each of these applications fairly and consistently, and when an application did not meet with the BAR's guidelines or the Zoning Ordinance, I encouraged and guided applicants toward solutions that would work for them and comply with the relevant standards. In almost all cases, we were able to help homeowners to achieve their goals and grant a Certificate of Appropriateness for their projects. My peers serving on the BAR have recognized my hard work, fair temperament, and dedication to the BAR's mission by electing me first as the Vice Chair and then as the Chair of the Board. I was also appointed to the Guidelines Subcommittee, where I have been instrumental in helping to update and clarify the BAR's guidelines to be more easily understandable to the citizens of Alexandria. I also have the best attendance record of any member of the Board. I accomplished all of this without campaigning or asking for any of these positions, and all in my first term. It has been a humbling experience to receive this much support and encouragement from my peers on the Board, and it inspires me to keep working for the City and our collective community. As a career Army officer-turned Senate committee staffer, I have led a life of service. Continuing to serve on the BAR would be an extension of my commitment to public service and a continued expression of my great affection for Alexandria. Although I do not have a background in building or architecture, I have learned a great deal in my three years on the BAR, and I feel totally qualified to continue to serve on the Board. As a lawyer, I am comfortable reading and interpreting regulations, and that has been indispensable for myself and my colleagues on the Board. I believe I am the right person to fill the BAR vacancy at this critical time. With several important projects pending before

the Board, including the renovation of City Hall and the consideration of installing a new pump station in Waterfront Park, I will provide leadership and continuity to the City and to my colleagues on the Board. If selected to continue to serve on the BAR, I would continue to be a committed and diligent servant of the City. I would continue to strive to strike the right balance between historic preservation and individual property rights, and I would maintain my practice of reviewing each matter on its own merits, without any agenda or bias.
