28 29 30	(t) The Samuel Tucker School Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district.
31 32 33 34	The voting place within the Samuel Tucker School Election District shall be the Samuel Tucker School, located at 435 Ferdinand Day <u>Drive Way</u> .
35 36 37	(x) The South Port <u>Tucker West</u> Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district.
38 39 40	The voting place for the South Port <u>Tucker West</u> Election District shall be the South Port <u>Apartment ComplexSamuel Tucker School</u> , located at <u>435 Ferdinand Day Drive</u> .
40 41 42 43 44	Section 2. That Section 12-1-4(c) of The Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to delete the text shown in strikethrough and add the text shown in underline as follows:
44 45 46 47	(c) The city shall be divided into three school board election districts, District A, District B and District C. Three school board members shall be elected from and shall represent each such district. The three districts shall be composed of the following precincts (or, as identified

That "The Official Map of the City of Alexandria, Virginia, Designating 21 Election Districts and Voting Places," adopted by Section 2-2-13 of the Code of the City of 22 Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained as 23 shown on Exhibit 1, attached hereto and incorporated fully by reference. 24 25 Section 4.
