<p><u>Option 1 – City Council Public Hearing on Tues. 7/9</u> Tuesday 6/25 – Planning Commission Public Hearing Friday 6/28 noon – P&Z submits reports to City Clerk Monday 7/1 – City Clerk publishes CC Docket Tuesday 7/9 –City Council Public Hearing</p>	<ul style="list-style-type: none"> • This option satisfies the request for an additional public hearing for the Planning Commission and the City Council in the summer. • 7/9 – 7/9 is a Tuesday which is a typical meeting date for the City Council Legislative Meeting, recognizing that they typically do not meet in July and August. • No Saturday Public Hearing held in the middle of summer vacation season. 	<ul style="list-style-type: none"> • 6/25 – Planning Commission Public Hearing and the Regular City Council Legislative Meeting would occur on this same date (6/25). • An alternative meeting location would therefore be needed for a 6/25 Planning Commission Public Hearing.
<p><u>Option 2 – City Council Public Hearing on Sat. 7/13</u> Tuesday 7/2 – Planning Commission Public Hearing Friday 7/5 noon – P&Z submits reports to City Clerk Monday 7/8 – City Clerk publishes CC Docket Saturday 7/13 –City Council Public Hearing.</p>	<ul style="list-style-type: none"> • This option satisfies the request for an additional public hearing for the Planning Commission and the City Council in the summer. 	<ul style="list-style-type: none"> • P&Z has one less day to prepare reports to submit to City Clerk (due to a holiday – July 4).
<p><u>Option 3 – City Council Public Hearing on Tues. 7/23</u> Thursday 7/11 –Planning Commission Public Hearing Monday 7/15 noon – P&Z submits reports to City Clerk Tuesday 7/16 – City Clerk publishes CC Docket Tuesday 7/23 –City Council Public Hearing</p>	<ul style="list-style-type: none"> • This option satisfies the request for an additional public hearing for the Planning Commission and the City Council in the summer. 	<ul style="list-style-type: none"> • P&Z has one less day to prepare reports to submit to City Clerk. • Public Hearings are held in the middle of summer vacation season.
