Towing and Storage Fees Ordinance Update





To share the following two recommendations resulting from the March 26, 2024, Towing Advisory Board Meeting:


1.To amend the trespass towing fee of \$135 to \$150, and

2.To increase the after-hours charge of \$25 to \$30.



Trespass Towing Fee









Charge to remove and tow a vehicle from private property, like an apartment complex parking lot, to another location

The City sets the fee as established by the State range of \$135 to \$150

Assessment is to take into consideration the fair market value

This excludes other kinds of towing, like an owner requesting a tow for a broken vehicle



Current Trespass Fees

The City is **below** the state maximum for two fees and allows/regulates three fees.

2015 Last Update

Maximum fee for vehicles less than 7,500 pounds gross weight changed from \$125 to \$135.

2021 and 2024

- Vote to increase fee from \$135 to \$150 per private tow.
- Vote to increase after hours fee from \$25 to \$30 per private tow.
 - Why: State Law allows for up to \$150 and to align with Fairfax County.

Towing Advisory Board recommendations were shared via Memo to CC.

Fair Market Value Analysis

- Under State code, City Council is required to take the fair market value (FMV).
- T&ES coordinated with the Office of Performance Analytics to conduct an analysis that included inflation, a comparison of fees in neighboring jurisdictions, market charges, and service demand.
 - ☐ Comparator Rates
 - ☐ Trespass Tow Trends
 - ☐ Bureau of Labor Statistics (BLS)
 - **DC Area:** goods, services, food, housing, transportation, medical care, and education.
 - Transportation: fuel, maintenance, insurance, transit fares, public and private transportation.



Trespass Tow Trends





Bureau of Labor Statistics

Inflation has increased since the City last set the towing fee in June 2015.5

DC area inflation increased by 25%

Transportation inflation in the DC area increased by 29%







Trespass Fee Analysis

In all instances, the City's towing fees either match the majority of neighboring jurisdictions or are lower

Neighboring jurisdcitions: Fairfax Co., Prince William, Arlington, Falls Church



Hooked, up but not towed

\$50 in 3/5 jurisdictions, incl. City



Fuel Surcharge

\$20 in **all** jurisdictions



Notify/Admin

\$75 in 2/5 jurisdictions, incl. City*

*Arlington does not assess/ Falls Church data was unavailable



Storage

\$50 in all but Falls Church



Towed

\$150 in 3/5 jurisdictions, excl. City



After Hours

\$30 in 3/5 jurisdictions, excl. City



Staff Recommendations

That City Council:

- 1. Receive and approve the proposed ordinance to amend the trespass towing fee of \$135 to \$150 and increase the after-hours charge of \$25 to \$30; and
- 2. Schedule it for a second reading, public hearing, and final passage on Saturday, November 16, 2024.

To understand how this may affect someone, the Towing Advisory Board ran four scenarios:



When fees are stacked, the City is still aligned with or lower than its neighbors



Trespass Towing Fee

- The trespass towing fee is a charge to remove and tow a vehicle from private property. (apartment complex, parking lot, or another private location)
- A trespass tow may occur because a vehicle has no parking permits, an expired parking permit, expired plates, or similar issues.
 - This excludes other kinds of towing, like a vehicle owner requesting a tow for a broken vehicle.
- The City sets the fee as established by the State.
- The Towing Advisory Board recommends reviewing the City's trespass towing fee.
