As a legal aid attorney specializing in anti-human trafficking and domestic violence efforts, I have witnessed firsthand the devastating impact of exploitation and the urgent need for comprehensive legal protections for survivors. I have served as a member of the Human Rights Commission for 3 terms and am seeking a 4th. (I realize this is a long term of public service but others have served as long and longer.) I believe in the work the Commission is doing and I believe the Commission, especially now, needs to focus on Alexandria's issues, and the issues faced by Alexandria's residents, rather than be pulled into extraneous matters. I have worked hard to push for that focus and would like to continue to do so. My work for the Commission in my last term successfully lobbied the city for installation of PRIDE Plus "rainbow" crosswalks at Market Square and I am proud of the consensus-building we achieved in bringing that about. In addition, I currently serve as the liaison from the Human Rights Commission to the Alexandria Commission on HIV/AIDS, where I am working to expand the focus from a single avoidable and treatable condition, to work with the Health Department and Public Health Advisory Commission on addressing issues of stigma experienced by members of Alexandria's LGBTQ+ community in encounters with medical professionals and medical office staff. The liaison position with these commissions and the Department of Health brings together the essential parties to this discussion. Further, after the creation of the Alexandria Independent Community Policing Review Board, and the recognition that functions of that body intersect with functions of the Human Rights Commission, I was tasked with serving as unofficial liaison between the two groups. There remain important functions of the Police Department that the Human Rights Commission monitors, such as hiring practices and employment goals, as well as other functions. I am well-suited to continuing this work and would appreciate the opportunity to do so.
