EDUCATIONAL BACKGROUND

I spent my entire K-12 education in public schools. I received my undergraduate degree in social policy from Northwestern University in Evanston, IL. There I focused my studies on policies that support children, youth and families, including housing, childcare, education, food support, domestic violence, and financial assistance to families in need. My master's degree is in elementary education from Northwestern University, and through that program I furthered my expertise in child and youth development.

SUMMARY OF WORK AND PRACTICAL EXPERIENCE:

My professional and personal endeavors over the last 21 years have centered on supporting children, youth and families. I conducted research and served as a student teacher in bilingual classrooms in Chicago, which deepened my appreciation of multilingualism and the experiences of recently arrived immigrant families. I began my professional career as an elementary school classroom teacher in the Chicago Public Schools. From that experience I learned that to support a child's success, you need to support the family's well-being. Upon moving to the Washington, D.C. area in 2005 from Chicago, I supported the U.S. Senate Subcommittee on Children and Families as they developed policies for out-ofschool time for youth. From there, I moved to a non-profit organization, the Council of Chief State School Officers, and I provided technical assistance to state leaders on policies and programs that improve children's educational outcomes. As part of that, I led programs that developed partnerships between local community organizations, healthcare providers, local government agencies, and educational entities so schools can be a community hub for families. The power of partnership to improve youth and family outcomes is something I would prioritize if I was a member of this Commission. I currently lead policy and engagement efforts in K-12 education for a national organization aimed at increasing children's educational outcomes. In my personal life, I have volunteered as a GED tutor for young parents and reading tutor for first graders. I am involved with the Alexandria City Public Schools (ACPS) as the parent of two children in the school system. I served on the PTA Council of Alexandria (PTAC) and currently am the Mount Vernon Community School (MVCS) PTA co-VP of fundraising. In this role, I consider how to create more equitable access for all families in our community, develop more collaborative family-school partnerships, and how funds raised by the PTA can benefit students who are most in need of additional support and services. Gun violence prevention is also an important issue to me in reducing injury and death among children and youth, since now firearms are the number one cause of death among children in America. I therefore volunteer and have held a leadership position in Moms Demand Action for Gun Sense in Alexandria. In my faith community, I volunteer for our Matthew 25 program to provide nutritional and clothing assistance to families. I try to spend my time outside of work and being a mom volunteering to improve our community for children and families.
