#### I. OPENING.

#### 1. Calling the Roll.

Mayor Wilson called the meeting to order and the Deputy City Clerk called the roll. All the members of Council were present with Vice Mayor Jackson and Councilman Chapman arriving during the executive session; and Councilmember Bagley arriving after the executive session.

2. Executive Session.

Consideration of the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of the governmental unit would be adversely affected and a personnel matter.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried 5-0, City Council convened in closed executive session at 6:08 p.m., to discuss matters involving the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of the governmental unit would be adversely affected and a personnel matter; specifically, potential public funding of incentives to three different industries considering locating in the City and consideration of prospective candidates for appointment to the position of Independent Policing Auditor/Investigator; pursuant to Sections 2.2 3711(A)(6) and (A)(1) of the Code of Virginia. The vote was as follows: In favor, Mayor Wilson, Councilman Aguirre, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none; Absent, Vice Mayor Jackson.

**WHEREUPON**, upon motion by Councilmember Aguirre, seconded by Councilman Chapman and carried unanimously, City Council reconvened in open session at 7:03 p.m. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none.

**WHEREUPON**, upon motion by Councilmember Aguirre, seconded by Councilman Chapman and carried unanimously, City Council adopted the resolution regarding the closed executive session previously circulated to Council. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none.

3. Approval of Electronic Participation Resolution by Member(s) of City Council.

**WHEREUPON**, upon motion by Councilmember Aguirre, seconded by Councilman Chapman and carried unanimously, City Council adopted the resolution City Council adopted the resolutions regarding Electronic Participation by Members of City Council. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none.

City Council observed a moment of silence and recited the Pledge of Allegiance.

4a. Recognition of Youth/Students by City Council

City Council recognized Ivy Schrouter-Stevenson. She was accompanied by her art teacher, Lauren Pierson.

#### II. ORAL REPORTS FROM MEMBERS OF CITY COUNCIL ON BOARDS, COMMISSIONS AND COMMITTEES

#### \*Alexandria Transportation Commission (Councilman Chapman and Councilman McPike)

Councilman Chapman reported on the USDOT Reconnecting Communities grant application submitted for the study of a pedestrian bridge connecting a west end community to the Landmark area.

Councilman McPike reported on the upcoming legislative priorities including the expansion of the speed camera programs and budget priorities regarding the state of the city's trails.

#### \*Northern Virginia Regional Commission (Councilman Chapman and Councilwoman

#### Gaskins)

Councilwoman Gaskins reported the group received a presentation from the Department of Defense on climate change, new projects, and net zero base support military.

Councilman Chapman noted a grant awarded to the region for a Go Virginia study regarding foreign investments.

# \*Alexandria Gang Prevention Community Task Force (Councilwoman Gaskins and Councilman Aguirre)

Councilwoman Gaskins reported the group welcomed a new youth member and the group is in the process of developing an action plan with DCHS and used the Developmental Asset Survey to address specific assets. Councilwoman Gaskins noted the group increased the number of meetings from four times a year to six times a year and discussed the need for additional funding for various programs.

Councilman Aguirre reported the group welcomed a new citizen member chairman and noted the 3-5 year action plan for the board.

Vice Mayor Jackson inquired on the possibility of bringing this topic to the City Schools Subcommittee. Vice Mayor asked if new data was bought to the staff if the Task Force discussed. Councilwoman Gaskins noted that December may be a great time to check in once all reports have been combined.

## \*Children, Youth, and Families Collaborative Commission (Councilwoman Gaskins and Councilmember Bagley)

Councilwoman Gaskins highlighted the abilities to dive deeper in the Developmental Asset Survey and looking at the specific disparities amongst students. Councilwomen Gaskins noted an upcoming communitywide discussion in October, date to be announce and the Substance Abuse Prevention Coalition.

Councilman Chapman added his hope that we act on the data received.

Councilman Aguirre voiced concern to not to lose sight of the Children Master Plan.

Vice Mayor Jackson voiced concerns about communicating and promoting the resources available for those missing out.

#### \*Waterfront Commission (Councilmember Bagley)

Councilmember Bagley reported the group received a presentation about 2 King Street potential sale. Councilmember Bagley noted General Services requested a joint committee with Parks and Waterfront members to discuss how to maximize the parcel and the sale. Councilmember Bagley noted concerns raised at the meeting regarding flooding mitigation, trashcan, and bikes racks. Councilmember Bagley reported on the I Love You installation and display through November 17. Councilmember Bagley noted the group did not receive \$15 million grant for the waterfront plan.

#### \*Virginia Railway Express (Councilmember Bagley)

Councilmember Bagley reported that a rail strike had been averted on September 27, 2022. Councilmember Bagley noted that VRE will remind fare free to DC through October to DC. Councilmember Bagley reported that VRE has posted "988" signs for suicide prevention. Councilmember Bagley noted there was an FY24 budget discussion and upcoming solar implantation projects for two stations.

#### \*COG Transportation Planning Board (TPB) (Councilman Aguirre)

Councilman Aguirre reported the group updated bylaws regarding virtual participation. Councilman Aguirre noted his desire to limit the number of virtual meetings, however the group voted the not limit the number of virtual meetings.

#### \*Alexandria Library Board (Councilman Aguirre)

Councilman Aguirre highlighted 75-year celebration and events and noted the discussion regarding library budget and staff compensation. Councilman Aguirre informed Council of the new Director of Development.

#### **Resolution No. 3100**

WHEREAS, the City of Alexandria is a subrecipient of the Virginia Department of

Transportation (VDOT) for Federal Highway Administration (FHW A) funds; and

**WHEREAS**, Title 23 of the Code of Federal Regulations Part 200, Title 49 of the Code of Federal Regulations, Part 21, and the U.S. Department of Transportation Title VI Order 1.000.12C dated June 11, 2021, requires subrecipients to have their own Title VI programs and to submit the Program to the primary recipient,

**WHEREAS**, City of Alexandria staff have updated the City of Alexandria's Federal Transit Administration Title VI Program in adherence with VDOT requirements of subrecipients to develop a unique program for FHW A; and

**WHEREAS**, the Program has been reviewed by VDOT and their comments have been incorporated into the updated Program, attached hereto;

## NOW, THEREFORE, IT IS HEREBY RESOLVED, by the City Council of the City of Alexandria, Virginia

That the updated FHW A Title VI Program is hereby adopted; and that the City Manager is hereby authorized and directed to implement the Title VI Program in compliance with Federal Law.

8. City Council adopted the resolution to support a grant application to the U.S. Department

of Transportation for the FY 2022 Reconnecting Communities Planning Grant.

The resolution reads as follows:

### RESOLUTION NO. 3101

#### RESOLUTION TO SUPPORT PROPOSED INFRASTRUCTURE PROJECT APPLICATION FOR THE FEDERAL INFRASTRUCTURE FUNDING (RECONNECTING COMMUNITIES PLANNING GRANT) FOR FY 2022

**WHEREAS**, in 2021, the Bipartisan Infrastructure Law (Infrastructure Investment and Jobs Act) was signed into law, and in 2022, funded \$1 billion for the U.S. Department of Transportation's Reconnecting Communities discretionary grant program; and

WHEREAS, the purpose of Reconnecting Communities grant is to fund projects to reconnect communities that were previously cut off from economic opportunities by transportation infrastructure. Funding supports planning grants and capital construction grants, as well as technical assistance, to restore community connectivity through the removal, retrofit, mitigation, or replacement of eligible transportation infrastructure facilities; and

WHEREAS, projects are scored based on a merit criteria review by the U.S. Department of Transportation's Federal Transit Administration. Evaluation criterion includes: equity, environmental justice, and community engagement; mobility and community connectivity; community-based stewardship, management and partnerships; and equitable development and shared prosperity; and

**WHEREAS**, the City Council of the City of Alexandria commits to study the feasibility of a bicycle and pedestrian bridge over I-395 to provide critical mobility, access, safety, and connectivity improvements to the redeveloped Landmark Mall through this project; and

**WHEREAS**, the City Council of the City of Alexandria desires to submit applications for an allocation of funds up to \$300,000 through the US DOT 2022 Reconnecting Communities Program to fund critical transportation and sustainability needs in the City of Alexandria, Virginia; and

#### NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF ALEXANDRIA, VIRGINIA:

1. the City Council of the City of Alexandria hereby supports this application for an allocation of up to \$300,000 through the U.S. Department of Transportation Reconnecting Communities Program;

2. the City Council hereby commits to include, if awarded, up to \$60,000 for the required 20% local match through the Transportation Project Planning Capital Improvement Program; and

3. the City Council of the City of Alexandria hereby grants authority for the City Manager to execute all necessary documents that may be required under this program

9. City Council adopted a resolution amending City of Alexandria's Guidelines for the Use

of the Virginia Public-Private Education Facilities and Infrastructure Act of 2002 ("PPEA").

The resolution reads as follows:

#### **RESOLUTION NO. 3102**

#### RESOLUTION TO AMEND THE PUBLIC-PRIVATE EDUCATION FACILITIES AND INFRASTRUCTURE ACT OF 2002 GUIDELINES

WHEREAS, the General Assembly has granted authority for localities to enter into certain public private partnerships for development or operation of qualifying projects under the Public Private Education Facilities and Infrastructure Act of 2002 (Virginia Code § 56-575.1 et seq.) ("the Act"); and

WHERAS, City Council finds that there is a public need for timely acquisition, design, construction, improvement, renovation, expansion, equipping, maintenance, operation, implementation, or installation of education facilities, technology infrastructure and other public infrastructure and government facilities within the City that serve a public need and purpose; and

WHEREAS, City Council finds that there is demonstrated evidence that public-private partnerships can meet these needs by improving the schedule for delivery, lowering the cost, and providing other benefits to the public; and

WHEREAS, City Council finds that authorizing private entities to develop or operate one or more qualifying projects may result in the availability of such projects to the public in a more timely or less costly fashion, thereby serving the public safety, benefit, and welfare; and

**WHEREAS**, under the Act, prior to requesting or considering a proposal for a qualifying project, the City must adopt and make publicly available guidelines that are sufficient to enable compliance with the Act and such guidelines shall be reasonable, encourage competition, and guide the selection of projects; and

**WHEREAS**, City Council adopted the City of Alexandria Public-Private Education Facilities and Infrastructure Act Guidelines ("the Guidelines") on September 18, 2021; and

**WHEREAS**, several clarifications of the Guidelines are necessary to ensure appropriate flexibility and City engagement during PPEA project implementation.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ALEXANDRIA, VIRGINIA:

1. That City Council adopts the amended Guidelines pursuant to Virginia Code §56-575.3.

10. City Council approved a resolution authorizing the City Manager to accept a bequest from the Winkler Botanical Preserve Organization to the City of Alexandria.

#### **RESOLUTION NO. 3103**

**WHEREAS**, pursuant to Section 2.02 (e) of the Charter of the City of Alexandria (1950), as amended, City Council has the authority to accept gifts and donations; and

**WHEREAS**, Winkler Botanical Preserve Organization bequest to the City of Alexandria \$1 million in funding to advance community engagement and learning resources for City residents and visitors of the Preserve.
