

AN ORDINANCE to amend and reordain Chapter 8 (PARKING AND TRAFFIC REGULATIONS) of Title 5 (TRANSPORTATION AND ENVIRONMENTAL SERVICES) and Chapter 2 (TRAFFIC REGULATION), Chapter 3 (OPERATION OF VEHICLES), and Chapter 4 (STOPPING, STANDING, AND PARKING) of Title 10 (MOTOR VEHICLES AND TRAFFIC) of the Code of the City of Alexandria, Virginia, 1981, as amended.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Chapter 8 of Title 5 and Chapter 2, Chapter 3, and Chapter 4 of Title 10 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended by adding the text shown in underline and deleting the text shown in strikethrough as follows:

Chapter 8 – Parking and traffic regulations

Article A - Traffic and parking board

Sec. 5-8-1 - Established; composition; procedures. ~~term; compensation; vacancies; chairman.~~

(a) There is hereby established a traffic and parking board, which shall be composed of seven residents of the city who are not serving on any other official city body except the Alexandria Transportation ~~Safety~~ Commission.

(b) The members shall be appointed by the city council for terms of two years; ~~provided, that the initial appointments made under the authority of this section shall be one year terms for four of the members and two year terms for the other three members. Members of the board shall serve without compensation and may be removed by the city council for neglect of duty or malfeasance in office, after written notice and after public hearing. Vacancies on the board shall be filled by council appointment for the balance of the unexpired term.~~

(c) The chairman and vice chairman of the board shall be selected by the members of the board.

(d) The board shall meet monthly, as needed.

Sec. 5-8-2 - ~~Meeting; consideration of matters concerning traffic, parking and taxicabs.~~ Purpose – Generally.

The traffic and parking board shall ~~consider~~ meet at least once each month and all matters concerning substantial changes to traffic; and on-street parking regulations, and taxicabs; ~~shall be presented to the board for its consideration prior to action by the director of transportation and environmental services or presentation to the city council. When reviewing these matters,~~ the Board shall prioritize safety of all users when making recommendations.

Sec. 5-8-3 - ~~Duty and authority generally.~~ Functions, powers, duties.

It shall be the duty of the traffic and parking board to ~~;~~ within the limits of the funds at its disposal, investigate, study and analyze traffic and parking problems within the city, receive complaints having to do with traffic and parking matters, devise plans, methods and means to

1 control and relieve parking and traffic congestion, have jurisdiction over taxicabs and buses and
2 their owners and operators as specified in title 9, chapter 12 of this code, control parades within
3 the city, prepare reports on traffic, parking and taxicabs, and render advice and make
4 recommendation to the city manager, the city planning commission and, through the city
5 manager, to the city council and other officers and agencies of the city government.
6

7 (a) Provide a forum for public comments about parking and traffic issues.

8
9 (b) Consider matters related to taxicabs and their owners and operators as specified in Title 9,
10 Chapter 12 of this code.

11
12 (c) Consider matters related to permit parking districts as specified in Article F of this chapter.

13
14 (d) Consider matters related to metered parking as specified in Article G of this chapter.

15
16 (e) Consider appeals of curb cut requests as specified in Section 5-2-14.

17
18 (f) Render advice and make recommendations to the director of transportation and
19 environmental services or city manager regarding the following, except where review by a
20 different body may be otherwise provided by law:

21 (1) Changes to one or more on-street parking spaces, including the location and design of
22 parking, general parking restrictions, and restrictions for specific uses. For the purpose of
23 this section, a parking space shall be 20 feet long.

24 (2) Changes to speed limits as specified in Section 10-3-30.

25 (3) Removal or installation of traffic signals and stop signs.

26 (4) Changes to the flow of traffic, including elimination of travel lanes, temporary street
27 closures that are not already reviewed through the procedure for special events and
28 parades in Title 6, Chapter 4 of the city code or exceed 90 days, and turn restrictions.

29 (5) Other traffic and parking issues that are referred to the Board for review by the director of
30 transportation and environmental services, the city manager, or the city council.

31
32 (g) Render advice and make recommendations to the city council, who makes the final decision,
33 regarding the following:

34 (1) Changes to the city code that pertain to traffic, parking, and taxicab matters.

35 (2) Designation of truck routes and no through truck streets.

36 (3) Converting one-way streets to two-way traffic, or vice versa.

37
38 (h) Consider general traffic and parking processes where review and approval is delegated to
39 staff.

40
41 **Sec. 5-8-4 - Certain city officials to act in advisory capacity.**

42 The city manager and any member of his staff whom he designates may sit with the traffic and
43 parking board in an advisory and consulting capacity, but with no right to vote.
44

1 **Sec. 5-8-5 - Authority of the director to administer this chapter**

2 The director of transportation and environmental services is charged with administering changes
3 to traffic controls and on-street public parking in the city and has the authority to establish rules
4 and regulations to do so. In this administration, the director shall consider the recommendations
5 of the board, where the matter is required to be reviewed by the Board prior to administering a
6 change. In the event the board's recommendation does not fully support the director's proposed
7 action, the director shall notify the board in writing of his decision and reasoning for taking
8 alternative action. This information shall be made available to the public.

9
10 For items where the board, planning commission, or city council have authority to make the final
11 decision, the director shall adhere to the specific decision and administer the change.
12

13 **Sec. 5-8-6 - Change of controls established by director of transportation and environmental**
14 **services.**

15 (a) Any traffic control device established by the director of transportation and environmental
16 services that has been reviewed by the traffic and parking board at a public hearing may be
17 appealed to the city council by a group who submits a petition signed by at least 25 property
18 owners or residents of the city.

19
20 (b) An appeal under this section shall be filed with the clerk of city council within 15 days of
21 the board's recommendation to the director or the director's notification to the board of
22 alternative action. The clerk shall schedule the appeal for a public hearing before the city
23 council.

24
25 (c) The city council shall then have the power to retain, remove, or change any control; provided
26 that the council shall first examine the recommendation from the traffic and parking board,
27 receive a report on the matter from the director of transportation and environmental services,
28 and hold a public hearing in relation thereto.

29
30 (d) The subject matter of an application to the board for removal or change of a traffic control on
31 which the council has rendered a decision pursuant to this section shall not be considered
32 again by the board for a period of twelve months, unless the new application differs in
33 material respect to the application that was previously considered.

34
35 (e) For the purpose of this article, traffic control device is defined as a marker, sign, or signal
36 used to inform, guide, or control traffic and parking.

13 ~~public access easement with permission from the owner shall be submitted by the city manager~~
14 ~~or designee to the traffic and parking board for its review and recommendation.; and provided~~
15 ~~further, that,~~

17 (b) ~~in~~ In the event the city manager or designee disagrees with the recommendation of the
18 board, the proposal shall be submitted to city council which shall make the final decision on
19 the proposal. In making its determination, city council shall first examine the recommendation
20 from the traffic and parking board, receive a report on the matter from the director of
21 transportation and environmental services, and hold a public hearing in relation thereto.

22
23 (c) A map of all approved parking meter locations shall be maintained on file with the director
24 of transportation and environmental services. Existing parking meter locations currently in
25 effect as of the date of passage of the ordinance are hereby adopted as part of the approved meter
26 plan without any further action by the city manager or the traffic and parking board.

27
28 **Sec. 5-8-93 - Parking meters; hours and days of operation; maximum time limits; rates.**

29
30 (a)(1) ~~The parking meters in zones 1 and 2, established by section 5-8-92 of this code, shall be~~
31 ~~operated every day of the week except Sundays and legal state federal holidays. The city~~
32 ~~manager may designate additional days when meters, including specific meters in an identified~~
33 ~~location, shall not be in operation.~~

34 (2) ~~The daily hours of operation and maximum time limit of the meters shall be determined by~~
35 ~~resolution of the city council.; provided, that, within the area bounded on the north by the north~~
36 ~~side of Princess Street, on the west by a line 10 feet to the east of and running parallel to the~~
37 ~~east side of Washington Street, on the south by the south side of Wolfe Street and on the east~~
38 ~~by the Potomac River, meters which permit a maximum of two hours of parking shall be in~~
39 ~~operation from 8:00 a.m. until 9:00 p.m.~~

40 (2) ~~The parking meters in zones 3 and 4, established by section 5-8-92 of this code shall~~
41 ~~be operated every day of the week except Sundays and state legal holidays, and the daily~~
42 ~~hours of operation of the meters shall be determined by resolution of the city council.~~

43
44 (b) ~~The maximum time limit for parking in any space shall be set forth on the meter for that~~
45 ~~space, and shall not exceed four hours, subject to the provisions of subsection (a) above.~~

1 (c) ~~In all parking meter zones, the parking meter rate shall be set by resolution by city~~
2 ~~council. \$1.25 per hour at those meters that are coin only operated until such time as multi-~~
3 ~~space meters or single space meters that accept credit or debit cards are installed. In all~~
4 ~~parking meter zones, the rate shall be and \$1.75 per hour at those spaces served by multi-~~
5 ~~space meters or single space meters that accept credit or debit cards installed before~~
6 ~~November 13, 2010. Thereafter, when multi-space meters or single space meters that accept~~
7 ~~credit or debit cards are installed elsewhere in all parking meter zones, the rate will increase~~
8 ~~to \$1.75 per hour at those spaces. In all parking meter zones, the applicable rate shall be~~
9 payable in such increments as provided at the applicable meter or pay station. The rates set
10 forth above do not include any convenience fee that may be charged by the service provider
11 in the event the city implements a "pay by phone" or other technology-based parking payment
12 option.

13
14 (d) As used in this article, the phrase parking meter shall be deemed to include a parking pay
15 station for multiple parking spaces, and all provisions applicable to parking meters shall apply
16 to parking pay stations, *mutatis mutandis* when meters are replaced by parking pay stations.

17
18 **Sec. 5-8-94 - City manager to provide for installation and maintenance.**

19
20 The city manager, or any officers and employees of the city as he or she may select, shall provide
21 for the installation, regulation, control, operation and use of parking meters in the parking meter
22 ~~zones hereby created~~ locations authorized by this article, and shall maintain the meters in good
23 workable condition.

24
25 **Sec. 5-8-95 - Contracts for purchase and repair of meters.**

26
27 The city manager is hereby vested with power and authority to enter into a contract in the
28 manner as prescribed by law for the purchase and installation of parking meters, and to provide
29 payment for the meters and installation exclusively from the receipts, funds, and revenues
30 obtained by the city from the operation of the parking meters without in anywise personally
31 obligating the city to pay for them from any other source. The city manager is further authorized
32 and empowered to enter into a contract for repairs and any parts of the parking meters as may be
33 necessary to maintain them in good operating condition and to pay for the repairs and parts
34 exclusively from the receipts, funds, and revenues received from the operating of the parking
35 meters.

36
37 **Sec. 5-8-96 - How single space meters to be installed; operation generally.**

38
39 (a) The parking meters shall be placed upon the curb alongside of or next to individual parking
40 ~~places~~ spaces, which ~~parking places~~ shall be either parallel to or diagonal with the curb ~~and shall~~
41 ~~be marked with proper lines.~~

42
43 (b) Each parking meter shall be so set as to display a signal that the parking space alongside
44 thereof is or is not in use.

1 (c) Each parking meter shall be so set as to display a signal showing legal parking in the
2 adjoining space, upon the deposit of a coin or coins of the United States or other authorized
3 payment, for a period of time conforming to the parking limits specified in this article.
4

5 (d) Each parking meter shall also be so arranged that upon the expiration of the parking limit it
6 will indicate by appropriate signal that the parking period has expired.
7

8 (e) ~~In the event the city implements~~ Meters that are enabled with a "pay by phone" or other
9 technology-based parking payment option, ~~each parking meter~~ shall also display instructions
10 setting forth the means through which a customer may pay the meter charge through ~~such system~~
11 all available systems.
12

13 **Sec. 5-8-97 - How parking pay stations (multi-space meters) to be installed; operation**
14 **generally.**

15 (a) The parking pay stations shall be placed upon the curb alongside of or next to ~~individual~~
16 parking places ~~spaces~~ within a block, which parking places shall be either parallel to or diagonal
17 with the curb.
18

19 (b) Each parking pay station shall print a receipt, when required to be displayed, that indicates
20 legal parking in a parking space within the block, upon the deposit of a coin or coins of the United
21 States or other authorized payment, for a period of time conforming to the parking limits specified
22 in this article.
23

24 (c) The printed parking pay station receipt will indicate when the parking period expires.
25

26 (d) ~~In the event the city implements~~ Pay stations that are enabled with a "pay by phone" or
27 other technology-based parking payment option, ~~each parking station~~ shall also display
28 instructions setting forth the means through which a customer may pay the meter charge through
29 ~~such system~~ all available systems.
30

31 **Article J - On-street parking standards**
32

33 **Sec. 5-8-160 - Purpose and scope of article.**
34

35 (a) The purpose of this article is to lessen congestion on, to facilitate the safe and expeditious
36 movement of vehicular traffic along, and to ensure the ability of emergency services vehicle to
37 move without delay on the public streets of the city. ~~To achieve this purpose, the article sets~~
38 ~~forth standards for the size of parking spaces located on the public streets of the city and for~~
39 ~~the amount of travel way available to vehicular traffic on such streets. The article also sets~~
40 ~~forth a procedure for the application of these standards which is designed to ensure that the~~
41 ~~standards are applied to streets or portions of streets where existing conditions pose a threat to~~
42 ~~public safety and the general welfare.~~
43

44 (b) This article shall apply to all public streets in the city, ~~except such streets or portions~~
45 ~~thereof located within the R-20, R-12, R-8, R-5 and R-2-5 residence zones.~~
46

1 **Sec. 5-8-161 - Standards; enforcement.**

2
3 (a) Standards for street types, sidewalks, roadways, intersections, and curbsides shall comply with
4 the Complete Streets Policy established by resolution of the city council.

5
6 ~~(a) The following standards apply to parking spaces located on public streets, to the travel~~
7 ~~way available to vehicular traffic on public streets and to sidewalks adjacent to public~~
8 ~~streets:~~

9 ~~(1) Travel way on one-way streets, with parallel parking only, shall be a minimum width of~~
10 ~~16 feet.~~

11 ~~(2) Travel way on one-way streets, with perpendicular parking on either side, shall be a~~
12 ~~minimum width of 20 feet.~~

13 ~~(3) Travel way on two-way streets, with parallel or perpendicular parking, shall be a~~
14 ~~minimum width of 24 feet.~~

15 ~~(4) Travel way on four-lane arterial and/or four-lane collector streets, exclusive of parking,~~
16 ~~shall be a minimum width of 44 feet, except in the Old and Historic District where the travel~~
17 ~~way shall be a minimum width of 40 feet.~~

18 ~~(5) Perpendicular parking spaces for full-size cars shall be a minimum of nine feet wide by~~
19 ~~18 feet long.~~

20 ~~(6) Perpendicular parking spaces for compact cars shall be a minimum of eight and one-half~~
21 ~~feet wide by 16 feet long.~~

22 ~~(7) Parallel parking spaces for full-size cars shall be a minimum of eight feet wide by 22 feet~~
23 ~~long.~~

24 ~~(8) Parallel parking spaces for compact cars shall be a minimum of seven (7) feet wide by 20~~
25 ~~feet long.~~

26 ~~(9) Sidewalks adjacent to a public street containing perpendicular parking shall be a~~
27 ~~minimum width of five (5) feet and shall be located in a public easement and/or public right-~~
28 ~~of-way.~~

29 ~~(10) Sidewalks adjacent to a public street containing parallel parking shall be a minimum~~
30 ~~width of five (5) feet and in a public easement and/or right-of-way.~~

31
32 (b) The director of transportation and environmental services shall be responsible for
33 enforcing the standards set out in subsection (a).
34

35 ~~**Sec. 5-8-162 - Review of director's enforcement actions by traffic and parking board and**~~
36 ~~**city council.**~~

37
38 ~~(a) Before taking any action to enforce the standards in section 5-8-161, the director of~~
39 ~~transportation and environmental services shall propose the action to the traffic and parking~~
40 ~~board. Upon receipt of a proposed enforcement action, the board shall schedule a public~~
41 ~~hearing on the proposed action and shall provide notice of the hearing by posting written~~
42 ~~notice or notices immediately adjacent to the public street or portion thereof affected by the~~
43 ~~proposed action. After conducting the public hearing, the board shall make a~~
44 ~~recommendation to the director on the proposed action. Except as provided in subsection~~
45 ~~(b), the director may then proceed with the proposed action only in accordance with the~~
46 ~~board's recommendation.~~

1
2 (b) In the event the board's recommendation does not fully support the director's proposed
3 action, the director may appeal the matter to city council. In the event the board's
4 recommendation supports, in whole or in part, the proposed action, any person who owns or
5 leases property immediately adjacent to the public street or portion thereof affected by the
6 proposed action and who would be aggrieved by the proposed action if it were implemented
7 by the director in accordance with the board's recommendation may appeal the matter to city
8 council. An appeal under this subsection shall be filed with the clerk of city council within
9 15 days of the board's recommendation. Within 10 days of the filing of an appeal, the board
10 shall forward in writing its recommendation, along with its reasons in support thereof, to the
11 clerk who shall then docket the appeal for the next regularly scheduled public hearing before
12 council. The clerk shall also provide notice of such hearing by causing an advertisement
13 stating the time, date and place of the hearing before council, the name and location of the
14 public street involved and the nature of the hearing to be prepared and published at least
15 seven (7) working days before the hearing in a newspaper of general circulation published in
16 the city. Following the public hearing, council shall approve, reject to modify, in whole or in

39 and federal holidays, or any vehicle granted a 72-hour parking rule exemption as provided in

- 41 (a) *Exemption.* A 72-hour parking rule exemption may be provided to residents by the Alexandria
42 Police Department in coordination with the department of transportation and environmental
43 services pursuant to the regulations detailed in [subsection] (b). If granted, a 72-hour parking
44 rule exemption will not supersede any posted signage. All hourly restrictions otherwise

1 applicable to a parked vehicle remain subject to enforcement. The provisions of subsections
2 (a) and (b) shall expire on November 1, 2019.

3 (b) *Exemption regulations.*

4 (1) Exemptions shall only be granted to vehicles registered with the City of Alexandria.

5 (2) Exemptions may not be transferred between vehicles.

6 (3) Each exemption may be granted for a maximum of two weeks.

7 (4) Vehicles may be granted a maximum of four exemptions per year.

8 (5) Vehicles may not be granted contiguous exemptions.

9 (6) Vehicles will only be permitted to park within one-eighth mile of their place of residence.
10 Vehicles granted exemptions found parking beyond this maximum radius will be subject
11 to enforcement.

12 (7) The department of transportation and environmental services and the Alexandria Police
13 Department retain the right to move and store vehicles when necessary due to street
14 maintenance, in cases of emergency, or as otherwise provided by law.

18 (a) When any vehicle shall be parked in any metered space, in accordance with the
19 provisions of this chapter, the operator of such vehicle shall, upon entering such parking
20 space, immediately ~~deposit or cause to be deposited the proper coin or coins of the United~~
21 ~~States in the parking meter,~~ make payment in accordance with one of the authorized methods
22 displayed on the meter or official parking sign, and when required by directions on
23 a meter, the operator shall also set or cause to be set in operation the timing mechanism on
24 the meter in accordance with directions, and the parking space may then be used by a
25 vehicle during the parking period purchased ~~by the proper coin or coins deposited in~~
26 accordance with the provisions of this section and this chapter. Any person placing a vehicle
27 in a parking space adjacent to a meter which indicates that unused time has been left in
28 the meter by the previous occupant of the space shall not be required to ~~deposit a coin~~ make

19 **Sec. 10-4-41 - Parking prohibited at certain locations.**

21 No person shall park a motor vehicle or permit a motor vehicle to stand, whether attended or
22 unattended, on a street in front of any part of a private driveway, within 5 feet of any part of an
23 alley, or, at any intersection of streets, within 20 feet from the intersection of curb lines or, if
24 none, within 15 feet of the intersection of the surfaced portions of the streets.

26 **Section 10-4-45 – Parking prohibited in bike lanes**

27
28 Where the City has designated a bicycle lane for the exclusive use of bicycles, a motor vehicle
29 may cross a bicycle lane for the purpose of entering or exiting adjacent property, for making a
30 turn, or for the purpose of parking, but no person shall stop, stand or park a motor vehicle in a
31 bicycle lane. Nor shall any person drive a motor vehicle in a bicycle lane for a distance of more
32 than one hundred (100) feet.

35 Section 2. That Chapter 8 of Title 5 and Chapter 2, Chapter 3, and Chapter 4 of Title
36 10 is enacted pursuant to Section 1 of this ordinance, be, and the same hereby is, reordained as
37 part of the City of Alexandria City Code.
