I urged city staff to recommend a roundabout redesign for the Mount Vernon North Complete Streets project, because that redesign will help address traffic problems at that location as well as improve the safety for pedestrian and bicycle users. That project is expected to be presented before the Traffic and Parking Board this upcoming spring. As a Board member for Alexandria Families for Safe Streets, I represented interested residents and users in favor of the Duke Street in Motion project. I worked with other members to encourage the City to adopt separated bus lanes, a complete bike lane, and safe and enjoyable pedestrian infrastructure for users on the Duke Street in Motion project. I believe that the project is an important step towards addressing the significant traffic and safety concerns for users of the Duke Street Corridor. Most recently, I advocated for good bicycle and pedestrian infrastructure as part of the Taylor Run redesign. I urged the city staff to address the safety concerns of users, and highlighted potential conflicts between users in some of the proposed redesigns under consideration. At the City of Albuquerque, I served the citizens and public officials by helping formulate effective policies and ordinances. I researched tax and policy initiatives, assessed the financial feasibility of municipal and construction projects, and helped the city to communicate with and listen to our constituents. My success depended on the ability to reconcile competing policy goals and diverse community perspectives together into effective municipal policy and planning actions.
