AN ORDINANCE to amend and reordain Section 2-2-10 (ESTABLISHMENT OF ELECTION DISTRICTS AND VOTING PLACES) Subsection (m); to amend and reordain "The Official Map of the City of Alexandria, Virginia, Designating Election Districts and Voting Places," adopted by Section 2-2-13 (MAP OF ELECTION DISTRICTS AND VOTING PLACES), all of Chapter 2 (ELECTIONS), Title 2 (GENERAL GOVERNMENT) of The Code of the City of Alexandria, Virginia, 1981, as amended; and to amend and reordain Section 12-1-4 Subsection (c)(ii) (ELECTION OF SCHOOL BOARD MEMBERS; DATE AND MANNER OF ELECTION), of Chapter 1 (SCHOOL DISTRICT AND SCHOOL BOARD), Title 12 (EDUCATION, SOCIAL SERVICES AND WELFARE) of The Code of the City of Alexandria, Virginia, 1981, as amended.

THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 2-2-10 Subsection (m) of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended by deleting the text shown in strikethrough and adding the text shown in underline as follows:

The following election districts and voting places are hereby established for the City of Alexandria, Virginia:

(m)The North Quaker ~~Blessed Sacrament Church~~ Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district.

The voting place within the North Quaker ~~Blessed Sacrament Church~~ Election District shall be the Christ the King Anglican ~~Blessed Sacrament Church~~, located at 1801 North Quaker Lane~~1427 West Braddock Road~~.

Section 2. That "The Official Map of the City of Alexandria, Virginia, Designating Election Districts and Voting Places," adopted by Section 2-2-13 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained as shown on Exhibit 1, attached hereto and incorporated fully by reference, to reflect the revised precinct name "North Quaker Election District" and the new voting place within the North Quaker Election District located at Christ the King Anglican Church, 1801 North Quaker Lane, Alexandria, VA 22302.

Section 3. That Section 12-1-4 Subsection (c)(ii) of The Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to delete the text shown in strikethrough and add the text shown in underline as follows:

(ii)District B shall be composed of the Naomi L. Brooks School, George Mason School (temporarily renamed Trinity), North Quaker ~~Blessed Sacrament Church~~, Beth El Hebrew Congregation, Northern Virginia Community College Arts Center, Charles Barrett Center, Douglas MacArthur School, Chinquapin Park Recreation Center, Ferdinand T. Day School, AlexRenew, The View Alexandria, and James K. Polk School precincts; and
