## Core Advisory Group Member

- 1 of the 16 SLEP Advisory Group Members
- Participates in both core SLEP Advisory Group and Subcommittee meetings
- If a parent or community member, will be selected through application process
- Can vote on whether or not a recommendation should move forward from the core SLEP Advisory Group to the Superintendent

## Participatory Subcommittee Member

- 1 of the Subcommittee Members
- Participates in the Subcommittee meetings; does not participate in core SLEP Advisory Group meetings
- If a parent or community member, will be selected through application process
- Can vote on whether or not a recommendation should move forward from a subcommittee to the core SLEP Advisory Group











## **Application Process**

Added to impart more transparency into the parent and community member selection process

Applicants can request to become a Core Advisory Group Member or a Participatory Subcommittee Member

Completed applications will go to the Office of Family and Community Engagement for review and selection

Applicants will be required to share their areas of expertise as it relates to law enforcement, black male achievement or community engagement



Those interested in applying for the SLEP Advisory Group must submit their application by 11:59PM on Monday, 05/02/22.












## **Next Steps**
