## Statement of Interest

While a law student, I had the privilege of being a part of my school's Civil Justice legal clinic. My responsibilities included working with the CJC's supervising attorneys and our partners in the local Legal Aid office to represent clients facing eviction. I also conducted research interviews with individuals who had suffered evictions and who were left trying to navigate the consequences of Durham's increasing shortage of affordable housing. The stories shared by clients and interviewees were terrifying because they revolved around such conventional struggles. One person got sick, ran out of sick leave at work, was fired, and didn't have enough savings to make rent. Another fell a little more behind each month trying to balance between caring for her children and a part-time job. Another got into a car accident, didn't have enough money to get the vehicle fixed, and thus lost a job that required commuting by car. Another was injured at work, lacked insurance, and needed to pay medical bills. Another's wages just couldn't keep up with how fast the landlord was raising rent. These people were living proof that more often than not, eviction turned on the axis of bad fortune, not personal failings. The confluence of unaffordable housing and unlucky happenstance would then give rise to catastrophic consequences. In Alexandria and elsewhere, there can be a temptation to view "affordable housing" as a sort of nebulous good, an item to be included among (and balanced against) a list of various other abstract priorities. My experience is that people facing eviction see affordable housing through a more concrete lens, and our city should strive to do so as well. Affordable housing is one hundred more dollars in the bank at the end of the month that can go to baby formula, diapers, and medicine. Affordable housing is keeping your child in a school with her friends and favorite teachers. Affordable housing is lungs that breathe asbestos-free air and hearts that beat lead-free blood. Affordable housing is the ability to live in the same community that your parents, grandparents, and great-grandparents did. Affordable housing is the barrier that keeps a one-time instance of bad luck from spiraling into a life-altering event. The absence of affordable housing is hunger, sickness, pain, fear, loss, and displacement. In AHAAC I see an organization committed to understanding and promoting affordable housing from this grounded, multi-faceted, outcomes-focused lens. The Committee's diverse membership provides the broad base of expertise needed to weigh the fact-intensive issues surrounding affordable housing in Alexandria. I hope that I am given the chance to serve as a member of the Committee and contribute to its crucial work.
