






Decisions Appealed From:

- **Reduce one general purpose lane** in each direction to slow vehicle speeds and create space for other important roadway features.
- **Convert the through-left lane to a left-only lane** on the eastbound approach of South Pickett Street and Edsall Road.
- **Add new median space** to be used as a left-turn lane or a pedestrian refuge.
- **Reduce up to 10 on-street parking spaces** at select locations to allow appropriate sight distance for a new crosswalk, provide a continuous bike lane through the intersection of South Pickett Street and Edsall Road, and better align the travel lanes through the intersection.
- **Implement No Turn on Red** restrictions at signalized intersections to reduce conflicts between users and allow for Leading Pedestrian Intervals to be installed to enhance pedestrian safety
- **Install protected bicycle lanes** to provide a dedicated space for people biking and scooting and to calm traffic.
- **Install bus boarding islands** to improve bus boarding, ADA compliances, and mitigate conflicts.
- **Install painted curb extensions** at key locations to shorten crossing distance and reduce turning speeds.
