WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried 6-0, City Council convene in closed executive session at 6:01 p.m., for consultation with legal counsel regarding specific legal matters requiring the provision of legal advice by such counsel, discussion regarding a prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the business' or industry's interest in locating or expanding its facilities in the community, and discussion regarding the investment of public funds where competition or bargaining is involved, where if made public initially, the financial interest of the governmental unit would be adversely affected, specifically, legal advice regarding government speech as it pertains to parades, and a corporate headquarters, and associated uses, considering relocating to the City, pursuant to Sections 2.2-3711 (A)(5), (A)(6) and (A)(8) of the Code of Virginia. WHEREUPON, upon motion by Councilman Aguirre, seconded by Vice Mayor Jackson and carried unanimously by roll-call vote, City Council adopted the resolution regarding the Closed Executive Session previously circulated to Council. II. Oral Reports from Members of Council on Boards, Commissions and Committees

*Visit Alexandria Board of Governors (Vice Mayor Jackson)

Vice Mayor Jackson reported that Visit Alexandria produced the Alexandria Boat Light Parade and the Scottish Christmas Walk Parade. Vice Mayor Jackson noted that they are working on the George Washington Birthday Celebration Parade in February. Vice Mayor

Jackson reported that Winter Restaurant Week in Alexandria will be January 19 – 28. Vice Mayor Jackson reported that the Carlyle Market was held this past weekend. Vice Mayor Jackson reported that the Green Business Program is currently accepting applications for participation. Vice Mayor Jackson reported that Visit Alexandria will be hosting a What's New Alexandria 2024 on January 22.

*Citizen Corps Council (Vice Mayor Jackson and Councilman McPike)

Vice Mayor Jackson reported that meeting was recap of the activities for 2024. Vice Mayor Jackson noted that the current executive officers of the Council were reelected. Councilman McPike reported that the Council would like to add a seat for a member from the Alexandria Radio Club, which was included in their Annual Report.

*School Law Enforcement Task Force (SLEP) (Vice Mayor Jackson and Councilmember Bagley)

Vice Mayor Jackson reported that SLEP met to discuss the SROs, the programming models and best practices for establishing a foundational basis for the next MOU review in 2025 for safety in the schools. Councilmember Bagley noted that the next meeting will be held January 17 here at City Hall.

*Northern Virginia Transportation Commission (NVTC) (Councilmember Bagley and Councilman Aguirre)

Councilmember Bagley reported that the Commission received a presentation on changes to the SmartScale process and discussed the impact it would have on the current applications. Councilmember Bagley also reported that the Commission received a clean audit. Councilmember Bagley noted that there was an extensive discussion on about the budget shortfall that WMATA was projecting and how it would impact the participating jurisdictions.

Councilman Aguirre reported that the Commission thanked departing director Jennifer DeBruhl upon her retirement and thanked departing Commission members John Faust, John Bell and Nick Clemente. Councilman Aguirre also noted that discussion on WMATA budgeting issues and how it is imperative to work on solution that will not impact the many people who use and depend on WMATA in the region.

*Council of Governments (COG) - Metropolitan Washington Air Quality Committee (MWAQC) (Councilmember Bagley and Councilman McPike)

Councilmember Bagley reported that there were updates on the impacts of particulates in the air and how it affects air quality. Councilmember Bagley reported that there was a discussion about Purple Air monitors in Loudon County. Councilmember Bagley reported that the subcommittee on Air Quality is beginning there work on environmental justice.

*Alexandria Campaign on Adolescent Pregnancy (ACAP) (Councilmember Bagley and Councilman Aguirre)

Councilmember Bagley reported that the Board heard from the Ms. Zimmerman from the Health Department about the City's teen pregnancy rate for Alexandria, noting there is an

increase and some disparity among the Hispanic population. Councilmember Bagley noted that the WRAP Up campaign launched this week and receiving much use of the condom dispensers in the Del Pepper Community Building.

*Naming Committee (Councilmember Bagley, Councilman Chapman, and Councilwoman Gaskins)

Councilman Chapman reported that the Committee recently held a public hearing and considered a number of names to bring before Council on January 9 for consideration.
