3	AN ORDINANCE to amend and reordain Sheet No. 068.04 of the "Official Zoning Map,
4	Alexandria, Virginia," adopted by Section 1-300 (OFFICIAL ZONING MAP AND

6	properties at 4991 and 5001 Eisenhower Avenue from, OCM (100)/Office commercial
