

## Petition on proposed Braddock Road traffic changes

On February 23, Alexandria's Traffic and Parking Board approved the BRADDOCK ROAD CORRIDOR IMPROVEMENT PLAN. This may be appealed within 15 days which would require City Council to hold a public hearing on the proposal. Valid signatures of 25 residents are needed. It would also be helpful to email City Council members with your thoughts.

We oppose reducing the number of vehicle lanes and elimination of parking along Braddock Road between Russell Road and Mt Vernon Avenue as Braddock Road is a busy major route for emergency vehicles as well as cars. Elimination of turn lanes will slow traffic and lead drivers to use smaller neighborhood streets to avoid the Braddock intersections, making smaller streets less safe. Many bikers use various smaller streets in this neighborhood to avoid busy routes like Braddock Road; increased traffic on side streets will not help them. Numerous churches and residents will be negatively affected daily while traffic and safety worsen right outside their doors.

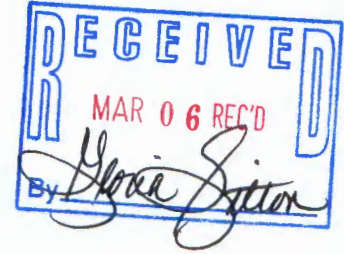



  - a. including the **installation of dedicated, protected bike lanes** on West Braddock Road between Russell Road and Commonwealth Avenue, and
  - b. including the **installation of dedicated bike lanes** on East Braddock Road between Commonwealth Avenue and Mt. Vernon Avenue;
2. **Remove on-street parking** on Commonwealth Avenue between Braddock Road and Spring Street,
  - a. including the **installation of dedicated bike lanes** on Commonwealth Avenue between Braddock Road and Spring Street;
3. **Relocate one disability parking space** from the unit block of West Braddock Road; add one disability parking space on Hancock Avenue at Braddock Road and on Luray Avenue at Braddock Road;
4. **Consolidate the turn lanes and through lanes** on the Braddock Road approaches to the intersection of Braddock Road, Russell Road, and West Alexandria Avenue;
5. **Consolidate the turn lanes and through lanes** at all applicable approaches to the intersection of Braddock Road and Commonwealth Avenue;
6. **Consolidate the eastbound turn lanes and through lane** on Braddock Road at Mount Vernon Avenue; and
7. **Including the clarifying comments of the motion**, “This means the Compact Intersection at Mt. Vernon, the Commonwealth Bike Lanes on Commonwealth and the Bike Lane Option at Russell” and depicted in the staff presentation slides 87 and 88 below.

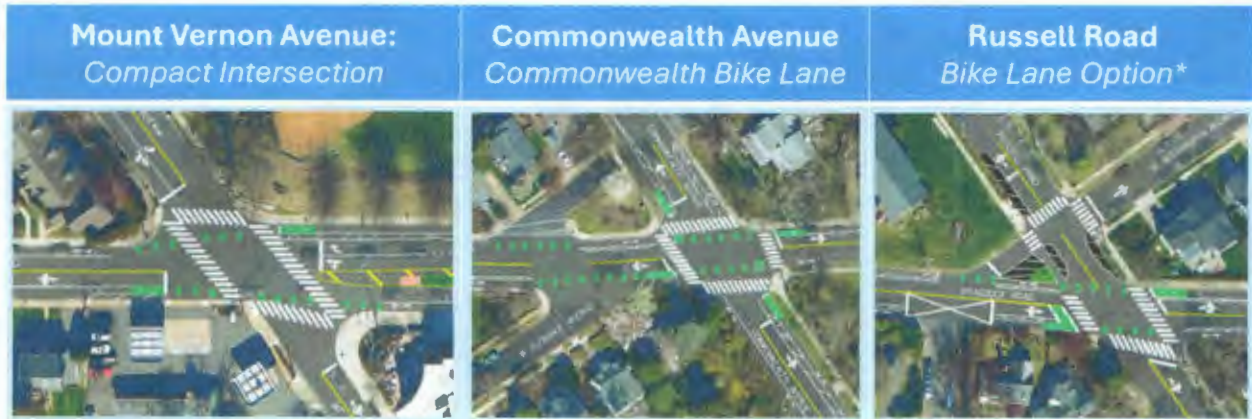











The elimination of the existing Braddock Road handicap-accessible parking space directly in front of Good Shepherd Lutheran Church will reduce accessibility and impose hardship on mobility-limited individuals. The proposed relocation to Hancock Avenue and Luray Avenue increases the distance from car to door from 25 feet to 125 feet and 175 feet, respectively.



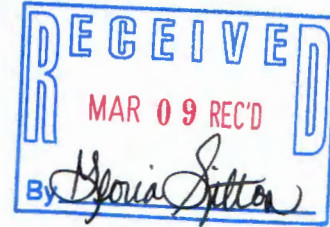

### **Re: Appeal of Parking Decision Affecting Russell and Braddock Roads**

Dear Members of the Traffic and Parking Board:

My name is Pastor Melvyn W. Warfield, Jr., and I have the privilege of serving as the Senior Pastor of Community Praise Church Seventh-day Adventist in Alexandria, Virginia. I write with deep respect for the work of the Board and with sincere concern regarding the recent decision to remove parking near the intersection of Russell and Braddock Roads.

Community Praise Church has a direct and meaningful interest in this matter. Our congregation has a regular attending membership of well over 500 people, and each Saturday between 8:00 a.m. and 4:00 p.m., that surrounding area serves as an important point of access for worshipers, ministry volunteers, guests, families, seniors, and community members who gather for worship, service, and fellowship. For many, the availability of nearby parking is not simply a matter of convenience. It is what makes participation possible.

This decision will have a real impact on people. It will affect our congregation, but it will also affect neighboring houses of worship, including sister faith communities with little to no dedicated parking of their own. It will also affect local residents who depend on accessible parking for their families, visitors, and daily routines. In that sense, this is not only a church issue. It is a community issue.

Our church is committed to being a good neighbor and a positive presence in this city. We care deeply about the wellbeing of the surrounding neighborhood, and we understand the Board's responsibility to balance safety, access, and the needs of the broader public. It is in that spirit that we respectfully ask for reconsideration of this decision. We believe there is room for a solution that protects public safety while also preserving reasonable access for the churches, residents, and community partners who are directly affected.

Enclosed with this letter is a petition from community residents and community partners who share these concerns. Their voices reflect the genuine and widespread

impact this change will have on the people who live, worship, and gather in this area every week.

Thank you for your time, your service, and your thoughtful consideration of this appeal. We are hopeful that, working together, a more balanced and community-sensitive outcome can be achieved.

  - a. including the **installation of dedicated bike lanes** on Commonwealth Avenue between Braddock Road and Spring Street;
3. **Relocate one disability parking space** from the unit block of West Braddock Road; add one disability parking space on Hancock Avenue at Braddock Road and on Luray Avenue at Braddock Road;
4. **Consolidate the turn lanes and through lanes** on the Braddock Road approaches to the intersection of Braddock Road, Russell Road, and West Alexandria Avenue;
5. **Consolidate the turn lanes and through lanes** at all applicable approaches to the intersection of Braddock Road and Commonwealth Avenue;
6. **Consolidate the eastbound turn lanes and through lane** on Braddock Road at Mount Vernon Avenue; and
7. **Including the clarifying comments of the motion**, “This means the Compact Intersection at Mt. Vernon, the Commonwealth Bike Lanes on Commonwealth and the Bike Lane Option at Russell” and depicted in the staff presentation slides 87 and 88 below.

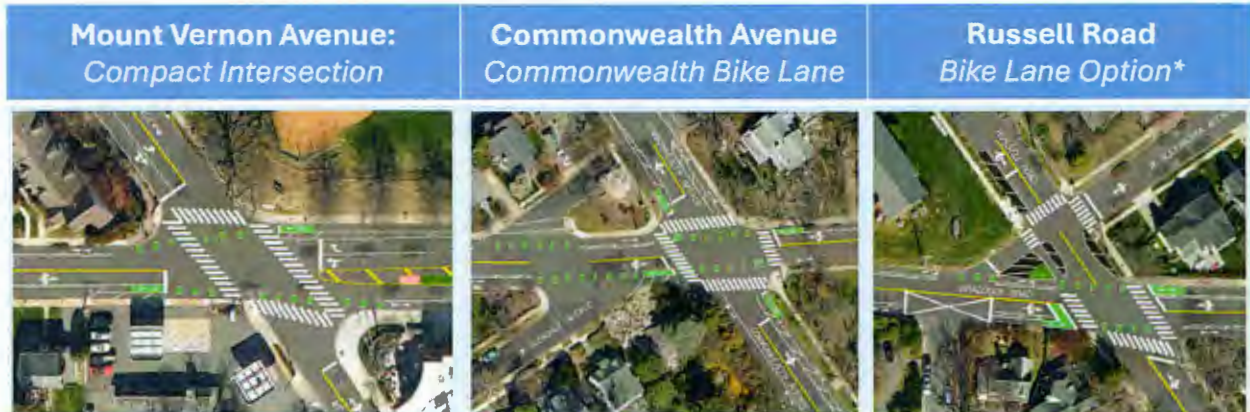

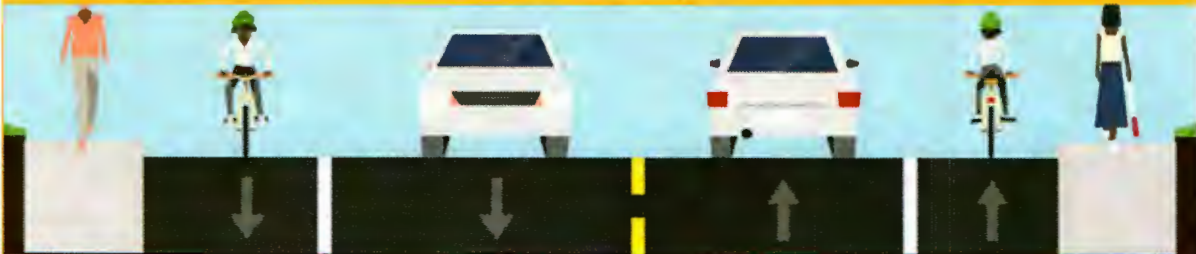
