WHEREAS, the Landlord is the owner of the building located at 105 North Union Street, Alexandria, Virginia, 22314 the Torpedo Factory Art Center ("TFAC");

WHEREAS, the Tenant is an artist(s) leasing a working art studio space in TFAC; and

WHEREAS, the Alexandria City Council has determined that it is in the best interest of the public to extend the original lease terms of tenants of the TFAC who are in good standing for one (1) additional year.

NOW, THEREFORE, the parties hereto do mutually covenant and agree as follows:

- 1. <u>Original Lease Term</u>: Pursuant to Article II of the Lease Agreement, the Landlord and Tenant(s) entered into an original lease agreement for the tenant's leased premises at the TFAC which began on the _[start date day]__ day of _[start date month]_, 20_[start date year]_.

- 4. <u>Terms and Conditions</u>. By signing below, Landlord and Tenant(s) agree that all the terms and conditions of the Original Lease Agreement shall remain in full force and effect during the new extended tease term.
