I strongly believe in the importance of community engagement to help the City make the best decisions possible in all aspects of the lives of its residents. As a lifelong resident in the City of Alexandria, I have spent more than seven years advocating for my local community through service on my neighborhood's civic association and multiple City task forces and advisory groups. Mobility, in particular, is a significant area of interest of mine, as evidenced by my extensive experience working with the City and the community on transit issues. Over the last 15 years, I have seen the impact of increased congestion directly in my own community, the Clover/College Park (CCP) neighborhood. During that time, our community experienced a significant increase in cut-through traffic, primarily commuters seeking to reach the Telegraph Road/Duke Street interchange. These conditions lead to an erosion in not only the quality of life for me and my neighbors, but also created unsafe conditions for pedestrians and cyclists. As a result, over the last seven years, I engaged with the City and my community on a variety of initiatives and projects related to traffic and mobility.
