I. OPENING

1. Calling the Roll.

Mayor Gaskins called the meeting to order and the City Clerk called the roll. All members of City Council were present with Councilman Chapman arriving during the closed session.

WHEREAS, City Council Member Sarah R. Bagley will participate in the City Council Meeting by video conference call from Dallas, Texas and arrangements have been made to ensure the member shall be heard by all participants at the City Council Meeting; and

WHEREAS a quorum of the City Council is physically assembled in person.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ALEXANDRIA, VIRGINIA:

RESOLUTION NO. 3358

**DECLARATION OF LOCAL EMERGENCY
CITY OF ALEXANDRIA, VIRGINIA**

WHEREAS, the Director of Emergency Management of the City of Alexandria, Virginia finds that, due to the January 24, 2026 snowstorm, the City may face emergency conditions that imperil life and property of sufficient severity and magnitude to threaten or constitute an emergency; and

THEREFORE, IT IS HEREBY DECLARED, that a local emergency exists throughout the City of Alexandria; and

IT IS FURTHER DECLARED AND ORDERED, that during the existence of said emergency, the powers, functions and duties of the Director of Emergency Management shall be those prescribed by state law and the ordinances, resolutions and operations plans of the City of Alexandria, and that any actions taken under this declaration shall be directed at the prevention or mitigation of damage, loss, hardship or suffering threatened by, or resulting from, the emergency.

The declaration is effective January 24, 2026, at 6:00 p.m. and; this declaration shall expire at 11 :59 p.m., January 27, 2026, unless extended or sooner terminated by the Director of Emergency Management in writing.

Resolution No. 3359

Acceptance of the rededication of Calhoun Avenue, Stevens Street, and Frost Street

WHEREAS, the City of Alexandria is committed to addressing the inequalities and historic legacies that impact residents, businesses, workers, and visitors across the community; and

WHEREAS, on January 10, 2023 , Mayor Justin Wilson introduced a proposal to rename city streets currently named for confederate officers; and

WHEREAS, many such streets were named in 1953 through ordinance no. 769, which directed

that "streets running in a generally north-south direction shall, insofar as possible, bear the names of confederate military leaders." This ordinance was adopted one year after the annexation of Alexandria's west end, where many streets had not yet been developed or named, and in anticipation of the landmark U.S. supreme court decision in *Brown v. Board of education*, a defining moment in the civil rights movement that, as stated by the Southern Poverty Law Center, resulted in a widespread backlash among segregationists, including the naming of streets and public facilities for confederates; and

WHEREAS, the City seeks to remove honors previously granted to confederate military leaders, most of which were bestowed during the civil rights era, to correct historical injustices and better reflect Alexandria's present-day values; and

WHEREAS, the city council naming committee recommended that, where feasible, streets named for confederate military leaders be rededicated to individuals of the same surname who made significant, positive contributions to Alexandria, thereby providing a new civic narrative while minimizing logistical challenges associated with full street renaming; and

WHEREAS, rededicated streets will receive markers providing historical context and highlighting the contributions of the individuals for whom they are newly dedicated; and

WHEREAS, the City of Alexandria has identified three streets appropriate for rededication, including:

- Calhoun A venue
- Stevens Street
- Frost Street; and

WHEREAS, ROBERT "BOB" CALHOUN was a yale-educated attorney, respected republican member of the Alexandria City Council (1976-1982), and former vice mayor, known for his intelligence, civility, and leadership on transportation policy, including his role in establishing the dash bus system and advancing child-custody law reform; and

WHEREAS, MOSES STEVENS was a pioneering black businessman who, in post-civil war Alexandria, operated a successful livery business, founded mt. Jezreel Baptist church, and served as an early adopter of telephone and automotive infrastructure in the city, making enduring civic and economic contributions; and

WHEREAS, the City Charter further requires that the Circuit Court of Alexandria shall order that a special election be held not less than forty nor more than sixty days after the filing of the resolution to fill such vacancy for the unexpired term;

WHEREAS, due to the statewide referendum scheduled for April 21, 2026, the City Council requests that the special election to fill the City Council vacancy be held on the same date in order to reduce the expense of conducting a separate election and to avoid voter confusion associated with multiple elections held in close succession; and

WHEREAS, City Code Section 5-2-29 governs permitted encroachments into the public

WHEREAS, City Code Section 3-2-85 provides that the annual charge for encroachments shall be established by resolution of the City Council;

WHEREAS, the City Council finds and determines that establishing permit processing fees and annual charges for permitted encroachments for publicly accessible electric vehicle (EV) charging equipment in the public right-of-way is necessary and proper at this time.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ALEXANDRIA, VIRGINIA:

1. Encroachment applications that include Publicly Accessible Electric Vehicle (EV) Charging Equipment, as that term is defined under City Code Section 5-2-29(b)(3), shall pay an initial Permit Processing Fee of \$100 and an Annual Charge upon first application submission and annually thereafter. The entity that applies for and maintains the permit for EV charging equipment within the right-of-way shall be responsible for compliance with all fees.
2. The Annual Charge shall be based on the square footage of the right-of-way that is encumbered by the proposed EV charging equipment, including the equipment footprint and any protective or clearance area designated by the director of transportation and environmental services, and the adjacent EV charging only parking space.
3. The Annual Charge for EV charging equipment shall be \$1.50 per square foot of occupied public right-of-way.
4. The Annual Charge for each EV charging only parking space shall be \$140.
5. Only EV charging equipment that meets all City Code requirements may be permitted in the public right-of-way, including the adjacent EV charging only parking space.
6. Each annual renewal of the permit will be at no cost if the permit has not expired due to lack of evidence of the current certificate of insurance. A \$100 Permit Processing Fee shall be due prior to issuance of any permit renewals if the permit expired due to lack of evidence of current certificate of insurance or payment of annual charge if applicable.
7. That such fees established above shall apply, unless and until revised by the City Council.
8. That the City Clerk be, and hereby is, authorized and directed to affix the seal of the City to such document as may be necessary or convenient to implement this Resolution.
9. This resolution is intended to supplement Resolution 3167, adopted by the City Council on June 13, 2023, not to supersede it.
