Statement of Interest

Statement of Interest As a lifelong Alexandrian whose family has owned a building on King St. for over 50 years, with a restaurant tenant, Taverna Cretekou, which has been there just as long, I have a deep appreciation for the importance of visitors to Alexandria. I know that no restaurant can survive on locals and neighbors alone. This lesson was also brought home when my family partnered with the neighborhood restaurant group to bring Evening Star to Mt. Vernon Ave, which has been one of the catalysts for the tremendous success of the Del Ray business community. When we owned the building I tried to participate as much as possible in the Del Ray Business Association. My mother was instrumental in creating their predecessor The Potomac West Business Alliance and also in uniting Kismet and the King St. Business Association in the early 2000's. I am now keenly aware that Old Town has no business association to represent their interests, which is one of the main reasons I would like to join the Board of Governors. The other is my personal interest as owner of 8 Air B and B's which my partner and I manage ourselves, so we work everyday with visitors to Alexandria, guiding them to restaurants, shops and historic sites here and in DC. We have hosted around 3,000 guests from around the world, and many of them are repeat guests. As an Air B and B host with local knowledge we have a unique ability to guide our guests during their visits, and I have given many informal tours as well. We leave a Visit Alexandria guide in each unit, but also have our own on-line guidebook with our recommendations that we give to guests. We have tried to build partnerships with local businesses and other Air B and B owners. When Alexandria recently introduced new Air B and B regulations, myself and two other hosts I recruited were the only people who testified. I hope to expand my business here in Alexandria and appreciate that our city has been a friendly place to start an Air B and B, and that we also contribute through sales tax and lodging tax significantly to taxes, and indirectly contribute positively to the local economy by bringing visitors to town. Not only do I feel like I could represent the Air B and B community but I have a long history of advocacy and involvement in Alexandria. I have been on the Budget and Fiscal Affairs Advisory Committee, the Woodrow Wilson Bridge Force and the Potomac Yard Advisory Board. I am a graduate of the inaugural class of Leadership Alexandria in 2004. I helped preserve the Marquis of the Old Town Theater when I was the only person to testify at the Board of Architectural Review against removing it. I helped save the Carver Nursery School at Queen and Fayette by building coalitions with all the historic preservation groups in Alexandria. I recently assisted Historic Alexandria in their commemoration of a lynching that took place, by having a sign placed in my yard and organizing a tour of all the sites of the terrible event. Years ago I was a docent at Lee Fendall House and having grown up around the Torpedo Factory, I am a fierce advocate for its preservation and continued use as an art center. I have been a vendor at Art on the Avenue, as well as spent a great deal of time there with a political committee, and also helped my girlfriend at the Christmas Market and the annual Women's Market when it used to be held at the Charles Houston Rec Center. Through my work in historic preservation, I have been to over 10 National Trust and Main Street conferences, and visited cities across the country to learn more about them, how they work, their most important sites and how they attract tourists. Most recently I attended the National Trust conference in New Orleans last fall. I understand how cities work and how we fit into the metropolitan region and into a larger tourist landscape. As the organizer of opposition to the proposed Business Improvement District, which did not meet the threshold of approval, I talked to dozens of business and property owners, and became even more connected to our community. With the

potential upcoming downturn and economic volatility coming from the current administration, and some small businesses on King St. struggling, I feel like the additional tax would have been an additional burden, and that we should be thankful that it is not in place. Some may disagree with me, but healthy debate is something we should all welcome. I look forward to the opportunity to serve, but I feel like I would represent and be able to communicate with many business owners who do not currently feel connected to Visit Alexandria.
