The City's Traffic Board just approved a heavy "road diet" on S. Pickett St. which will result in a huge increase of cut-through traffic on Cameron Station Blvd.

Did you know that South Pickett Street has the same traffic level as King Street at Bradlee Shopping Center? Cameron Station will become a very enticing bypass, indeed!

**YOUR SIGNATURE on a FORMAL PETITION IS NECESSARY, at this Town Hall Meeting.**

A formal petition forces City Council to hold public hearings on the South Pickett road diet plan. Petition signatures are needed no later than this Wednesday night, July 31, 2024, due to the 15-day filing deadline.

WHAT JUST HAPPENED?

- July 22: City approved severe road diet on S. Pickett St.
  - 2 lanes only - Duke St. to S. Van Dorn St.
  - More crosswalks
  - Dedicated bike lanes eating up whole car lanes each
  - Ostensibly improve safety & “share the road”
- Hurts businesses
- Slows traffic
- **Encourages cut-through traffic via Cameron Station!**

## FUTURE OF S. PICKETT ST. ROAD DIET

- July 22 – Road Diet Passed by City's Traffic & Parking Board
  - Becomes Binding Recommendation to Director of TES (Transportation & Environmental Services)
- August 6 - Deadline for Petition Against Road Diet to City Council
  - Halts plan implementation
  - Forces Public Hearing by City Council
- Sept. / Oct. - City Council Public Hearing on Road Diet
  - IN-PERSON TESTIMONY WILL BE CRITICAL

*City Council can rescind or revise at any time, too!*

---

WHAT WE WANT:

REVISE S. PICKETT ST. PLAN TO PROTECT CAMERON STATION

- LOWER speed limit to 25 MPH
  - Sooo much safer for all
  - 2018, 2024 requested by the businesses
  - Passport BMW letter opposed lane reduction
- KEEP dedicated turn lanes @Duke & @Edsall
- ADD more crosswalks
- SHARE the road, not dedicate the road to bicyclists
