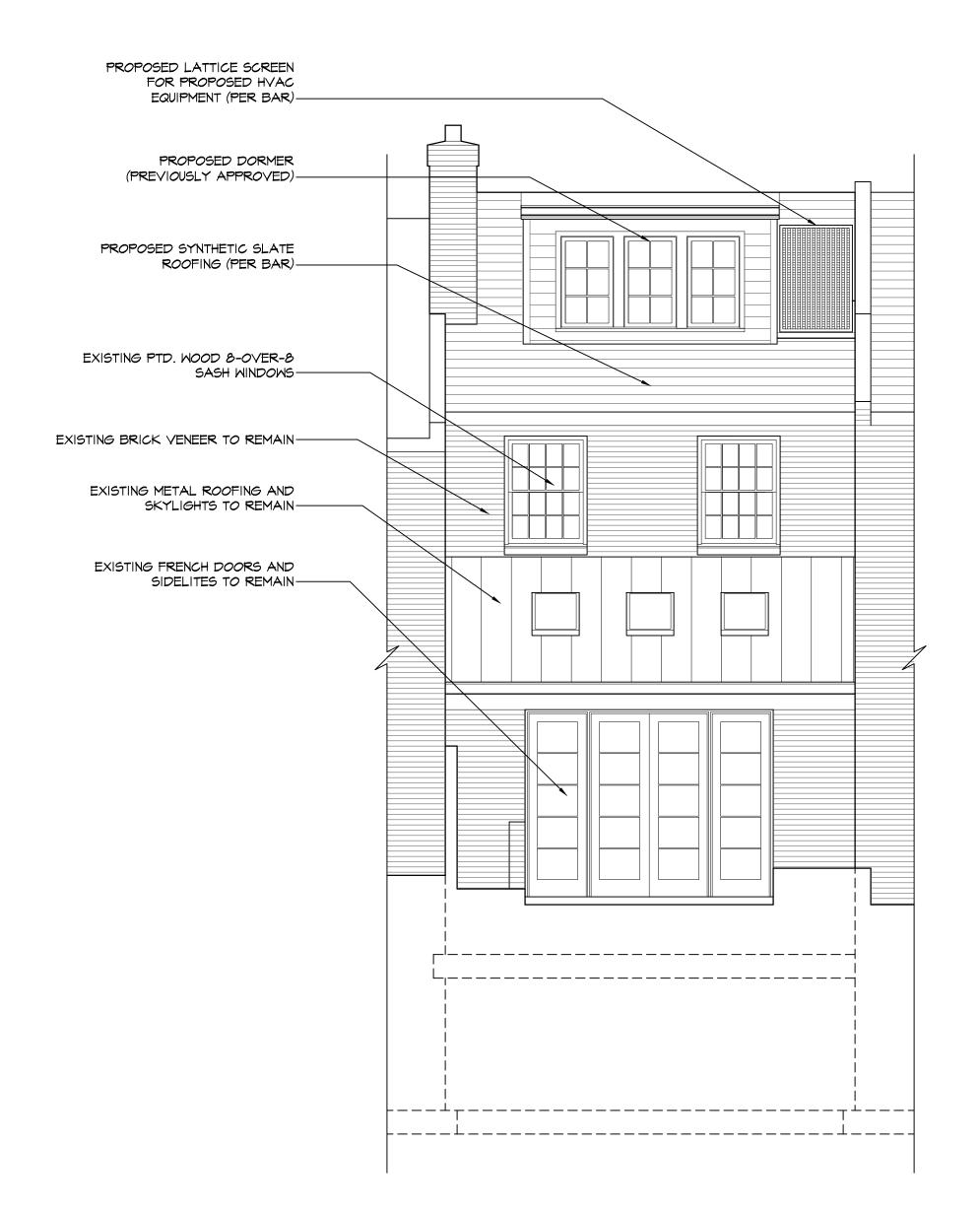

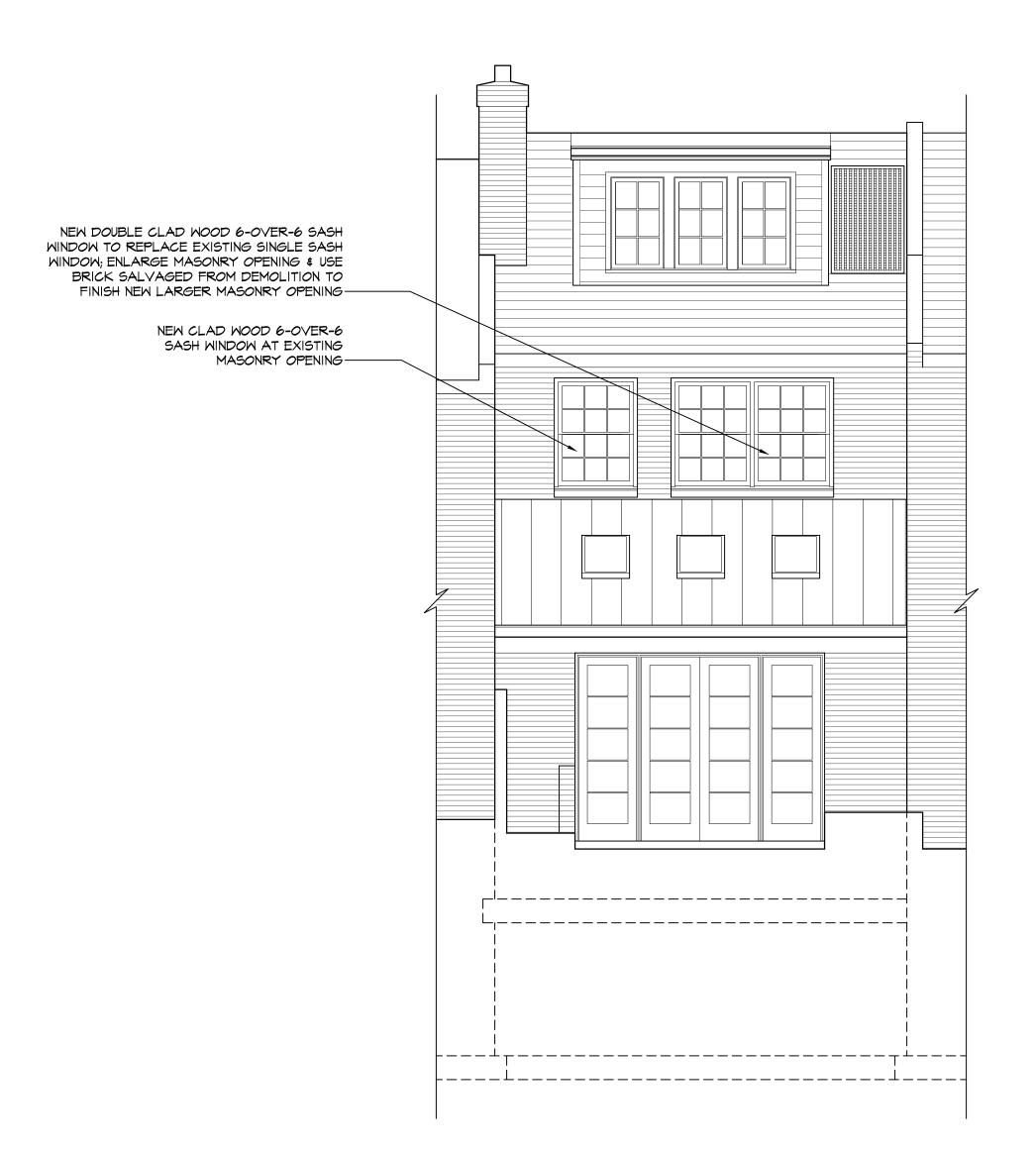

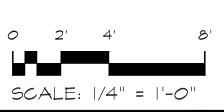


2 REAR ELEVATION: PROPOSED

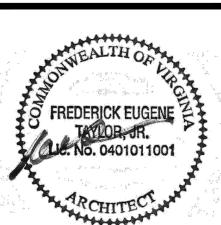

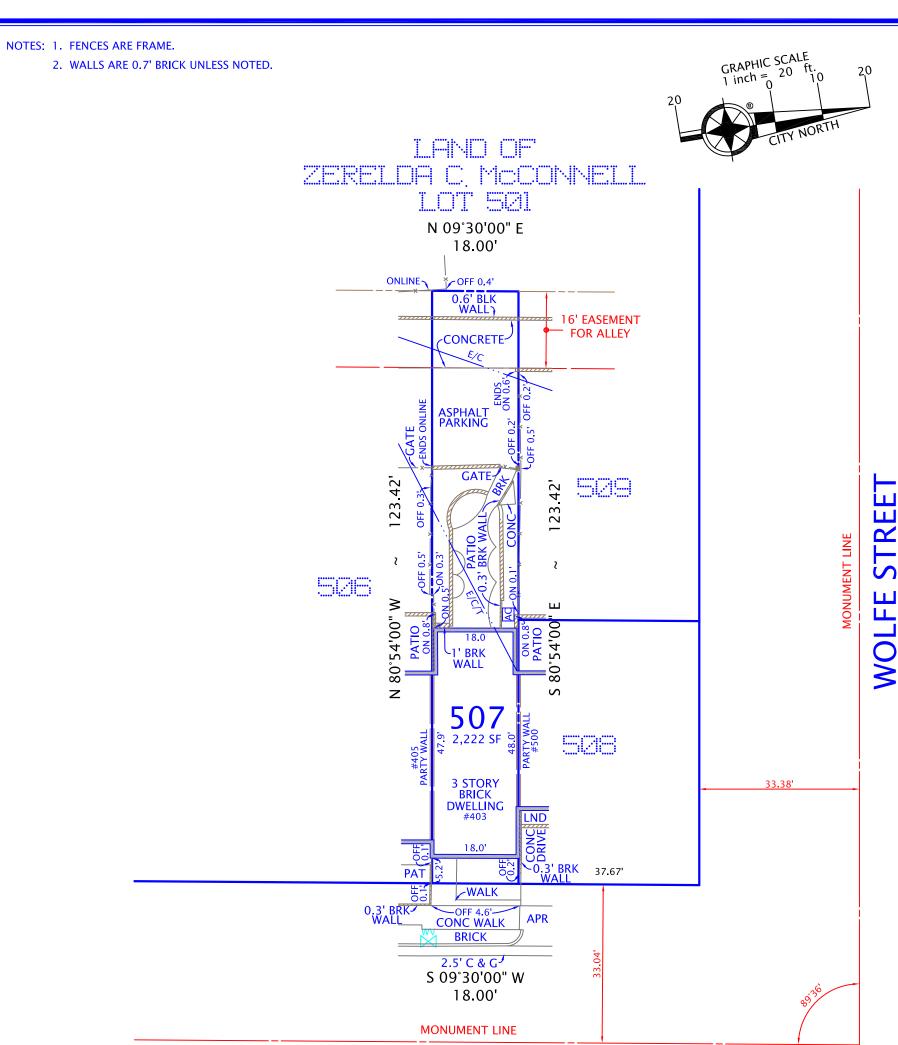

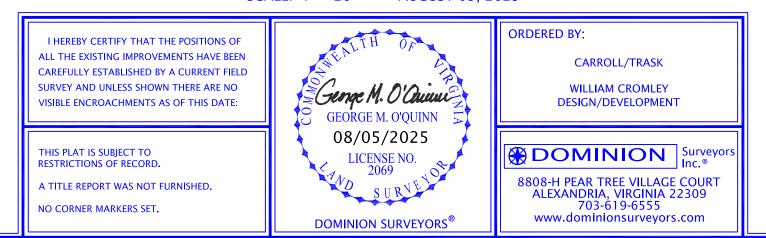
PLAT SHOWING HOUSE LOCATION ON LOT 507
