### RESOLUTION TO SUPPORT PROPOSED TRANSPORTATION PROJECT APPLICATIONS FOR THE I-395/95 COMMUTER CHOICE PROGRAM FOR FY 2022-FY 2023

**WHEREAS**, as part of the agreement for the High Occupancy Toll (HOT) lanes on I-395/95, the toll operator (Transurban) is required to provide grant funding for the I-395/95 Commuter Choice Program; and

WHEREAS, the Northern Virginia Transportation Commission (NVTC), OmniRide/Potomac/Rappahannock Transportation Commission (PRTC), the Department of Rail and Public Transportation (DRPT), the Virginia Department of Transportation (VDOT) and the Commonwealth signed a Memorandum of Agreement (MOA) that will provide a minimum of \$15 million annually to fund transit related improvements in the I-395/95 corridor beginning in 2019; and

WHEREAS, the purpose of the I-395/95 Commuter Choice Program is to support projects that maximize person throughput and implement multimodal improvements along the I-395/95 corridor; and

WHEREAS, the I-395/95 Commuter Choice Program projects will be scored based on technical merit, cost effectiveness, applicant preference, and toll day one readiness; and

WHEREAS, the City Council of the City of Alexandria desires to submit applications for allocation of funds of \$6,810,000 over two years for the first priority project for DASH West End-Pentagon Bus Service Enhancements (Line 35) and \$4,180,000 over two years for the second priority project for DASH West End-Potomac Yard Bus Service Enhancements (Line 36) for a total allocation of funds for \$10,990,000 over two years for the City of Alexandria, through the I-395/95 Commuter Choice Program.

### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ALEXANDRIA, VIRGINIA:

- 1. The City Council of the City of Alexandria hereby supports the applications for an allocation of up to \$10,990,000 through the I-395/95 Commuter Choice Program; and
- 2. The City Council of the City of Alexandria hereby grants authority for the City Manager to execute all necessary documents that may be required under this program.

### Re: Endorsement of Application for I-395/95 Commuter Choice (Round Two) Grant

Dear Mayor Wilson and Members of City Council:

At its December 16, 2020 meeting, the Transportation Commission voted to endorse two I-395/95 Commuter Choice Grant applications, which will be brought to Council on January 12, 2021. The proposals seek a total of \$10,990,000 over a two-year period for service enhancements on two DASH routes in the new 2022 Alexandria Transit Vision (ATV) Plan that provide important transit connections for the West End.

The proposed top priority project, "DASH West End – Pentagon Bus Service Enhancements", would provide weekday, Saturday, and Sunday service enhancements for the new DASH "Line 35". This route replaces the existing AT-1 Plus DASH route in West Alexandria with an extension up to the Pentagon. This project will build on pre-pandemic AT-1 Plus ridership increases along the planned West End Transitway corridor, maintain a potential future source of operations funding for the transitway, and support the implementation of the 2022 ATV Plan. Total project cost for FY 2022 – 2023 is \$6,810,000.

The second-priority project, "DASH West End – Potomac Yard Bus Service Enhancements", proposes weekday, Saturday, and Sunday service enhancements for "Line 36", which replaces the existing AT-9 DASH route. "Line 39" provides service to key destinations along the I-395 corridor including the Mark Center, Shirlington, Arlandria, and the future Potomac Yard Metro Station. The proposed service enhancements will increase service along this corridor so that it runs every 15 minutes, all-day, seven days each week, as outlined by the 2022 ATV Plan. The total two-year cost of the project is \$4,180,000.

The Commission recommends that Council support these grant requests.

- Cost: \$6.81 million (24 months)



## #2 / End-Potomac Yard (Line 36) **DASH Service Enhancements**

- Creates highly useful transit for Mark Center, Southern Towers, Arlandria & Potomac Yard Metro)
- Replaces existing AT9 (orange) with 15 min. all-day service, 7 days/week (Currently 20-30 min.)
- Previous AT9 enhancements netted 45 percent YOY ridership increase, prior to pandemic.
- Consistent with 2022 Alexandria Transit Vision (Summer 2021)
- Cost: \$4.18 million (24 months)
