It is the second time I've had it. It appears to be a mild case, and because the timing of my test fell outside the five day window since the first symptom, I can treat it with acetaminophen and OTC nasal spray. What a difference research and education make! How wonderful it is that there was a time so recently in our lives that medical research and related public health education were considered national priorities. How worrisome that this is no longer true. I just want to appreciate that a life threatening disease that destroyed so many lives and wreaked havoc on our city and our country, less than a decade ago, has been reduced to a manageable virus, IF we continue to support and advocate for herd immunity. And if we continue to conduct research on the virus and its variants. I understand that the research is not Alexandria's responsibility, but I believe the Public Health Advisory Commission can successfully reach out to our citizens to keep them informed of important health developments, and help support them to make optimal choices in prevention and treatment of disease, and promotion of healthy living. I want to be a part of that effort. Of course, with limited resources, we would look to the City and other Boards, Commissions and organizational partners whose missions touch on public health to provide the key data that would help us to identify our city's health priorities, and to engage with those with the greatest need. It appears the Commission is already doing this. I'm also excited to see that the PHAC and City Council are working so much more strategically (than when I chaired the Commission 2004-2006) in their approach to the Virginia State Legislature regarding public health advocacy. In my years in the work force, I analyzed health trends and developed with health care providers, consumers, business leaders, state and local officials and community activists a range of innovative national and regional perinatal care programs in the areas of adolescent pregnancy prevention, HIV/AIDS, infant immunization, substance abuse including smoking cessation, genetics, oral health, injury prevention, breastfeeding promotion and access to care for medically underserved populations.
