AN ORDINANCE to amend and reordain Section 2-2-10 (ESTABLISHMENT OF ELECTION DISTRICTS AND VOTING PLACES) by amending Subsections (a) and (n) and adding Subsections (ee) and (ff), all of Chapter 2 (ELECTIONS), Title 2 (GENERAL GOVERNMENT) of The Code of the City of Alexandria, Virginia, 1981, as amended; to amend and reordain Section 12-1-4 (ELECTION OF SCHOOL BOARD MEMBERS; DATE AND MANNER OF ELECTION), all of Chapter 1 (SCHOOL DISTRICT AND SCHOOL BOARD), Title 12 (EDUCATION, SOCIAL SERVICES AND WELFARE) of The Code of the City of Alexandria, Virginia, 1981, as amended; and to amend and reordain "The Official Map of the City of Alexandria, Virginia, Designating Election Districts and Voting Places," adopted by Section 2-2-13 (MAP OF ELECTION DISTRICTS AND VOTING PLACES), all of Chapter 2 (ELECTIONS), Title 2 (GENERAL GOVERNMENT) of The Code of the City of Alexandria, Virginia, 1981, as amended.

#### THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

Section 1. That Section 2-2-10 Subsections (a), (n), (ee), and (ff) of The Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to delete the text shown in strikethrough and add the text shown in underline as follows:

(a) The <u>Ladrey Senior Building Old Town - North</u> Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this code as comprising the said district.

The voting place within the Ladrey Senior Building Old Town - North Election District shall be at the Ladrey Senior Building Charles Houston Recreation Center, located at 300901 Wythe Street.

(n) The Douglas MacArthur School Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this Code as comprising the said district.

The voting place within the Douglas MacArthur School Election District shall be at the Douglas MacArthur School, located at 1101 Janney's Lane. However, notwithstanding the prior, for the November 2020 through November 2023 elections the voting place within the Douglas MacArthur School Election District shall be at the George Washington Masonic National Memorial, 101 Callahan Dr, Alexandria, VA 22301.

(ee) The View Alexandria Election District shall be bounded and described by the census blocks show on the map adopted by section 2-2-13 of this Code as comprising the said district.

The voting place within The View Alexandria Election District shall be at The View Alexandria located at 5000 Fairbanks Avenue.

(ff) The Redella S. "Del" Pepper Community Resource Center Election District shall be bounded and described by the census blocks shown on the map adopted by section 2-2-13 of this Code as comprising the said district.

The voting place within the Redella S. "Del" Pepper Community Resource Center shall be at the Redella S. "Del" Pepper Community Resource Center located at 4850 Mark Center Drive.

- Section 2. That Section 12-1-4(c) of The Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained to delete the text shown in strikethrough and add the text shown in underline as follows:
- (c) The city shall be divided into three school board election districts, District A, District B and District C. Three school board members shall be elected from and shall represent each such district. The three districts shall be composed of the following precincts (or, as identified in title 2 of this code, "election districts") located within the city, the boundaries of which are described in section 2-2-10.
- (i) District A shall be composed of the Lyles Crouch School, City Hall, Ladrey Senior-BuildingOld Town North, Fire Department Headquarters, Lee Center, George Washington Middle School, Cora Kelly "Chick" Armstrong Center, Mt. Vernon Recreation Center, Durant Center, Charles Houston, and Potomac Yard precincts;
- (ii) District B shall be composed of the Naomi L. Brooks School, George Mason School, Blessed Sacrament Church, Temple Beth El, Northern Virginia Community College Arts Center, Charles Barrett Center, Douglas MacArthur School, Chinquapin Park Recreation Center, Ferdinand T. Day School, AlexRenew, <u>The View Alexandria</u>, and James K. Polk School precincts; and
- (iii) District C shall be composed of the Patrick Henry Recreation Center, Samuel Tucker School, Charles E. Beatley, Jr., Central Library, John Adams School, William Ramsay Recreation Center, Cameron Station Community Center, Olympus Condo, Redella S. "Del" Pepper Community Resource Center, and South Port precincts.

Section 3. That "The Official Map of the City of Alexandria, Virginia, Designating Election Districts and Voting Places," adopted by Section 2-2-13 of the Code of the City of Alexandria, Virginia, 1981, as amended, be, and the same hereby is, amended and reordained as shown on Exhibit 1, attached hereto and incorporated fully by reference.

Section 4. That this ordinance shall become effective upon the later of i) receipt by the City Attorney's Office of a Certification of No Objection by the Office of the Attorney General of Virginia or ii) January 1, 2024, and the adjustments contained herein will be utilized for the elections in 2024 and thereafter until or unless further modified and amended.

WHEREUPON, upon motion by Councilwoman Gaskins, seconded by Vice Mayor Jackson and carried unanimously, City Council approved the Planning Commission recommendation with an amendment to Condition #23 stating, "The applicant shall control cooking odors, smoke, and any other air pollution from operations at the site and prevent them from becoming a nuisance to neighboring properties as determined by the Department of Transportation and Environmental Services. In order to mitigate impacts of smoke and odor from the smoker and prevent them from being a nuisance to neighboring properties, the applicant shall (1) relocate the smoker away from the western property line to be adjacent to the building stairwell; (2) extend the exhaust pipe up and above the main roof line of the building with the top of the exhaust pipe oriented toward Mt. Vernon Avenue; and (3) install a fan on the roof to dilute and further disperse the smoke. At the six month check-in, the performance of this equipment will be evaluated against the standard expressed in this condition. If necessary to meet this condition, adjustments to this equipment, or additional equipment, may be requirement. The vote was as follows: In favor, Mayor Wilson, Vice Mayor Jackson, Councilman Aguirre, Councilmember Bagley, Councilman Chapman, Councilwoman Gaskins, and Councilman McPike; Opposed, none.
