I. OPENING

WHEREUPON, upon motion by Councilman Chapman, seconded by Vice Mayor Bagley and carried unanimously by roll-call vote, City Council approved the electronic resolution. WHEREUPON, upon motion by Councilman Elnoubi, seconded by Councilman Chapman and carried unanimously, City Council endorsed proclamation. The vote was as follows: In favor, Mayor Gaskins, Vice Mayor Bagley, Councilman Aguirre, Councilman Chapman, Councilman Elnoubi, Councilwoman Greene, and Councilman McPike; Opposed, none.

III. Oral Reports from Members of City Council on Boards, Commissions, and Committees

* Council of Governments: Board of Directors (Mayor Gaskins)

Mayor Gaskins reported that the Board received a briefing on World Pride, noting the addition of an International March on Washington as part of the activities and the addition of a Human Rights Conference to focus on policies. Mayor Gaskins also reported that there are ongoing safety conversations about what each jurisdiction needs to do keep the LGBQT and trans residents safe during World Pride activities. Mayor Gaskins reported that the Board also received a report of the state of the economic impacts of the current administration on the region.

* Northern Virginia Transportation Authority: Governing Body (Mayor Gaskins)

Mayor Gaskins reported that she was part of the kick-off ceremony for the NVTA Transportation Summit, which included members of City staff as presenters. Mayor Gaskins reported that NVTA is in the process of updating its Strategic Plan to be completed by Fall 2025, focusing on transportation equity, transportation safety and transportation sustainability.

* Eisenhower Partnership Board of Directors (Councilwoman Greene and Mayor Gaskins)

Councilwoman Greene reported that there discussion about increasing membership for the Partnership. Councilwoman Greene noted that there was discussion about the upcoming Economic Summit. Councilwoman Greene reported that there was discussion about their recurring events including the WEBA Networking Event and Movie Nights, which will resume on May 17.

* Council of Governments: Food and Agriculture Regional Member Policy Committee (FARM) (Councilwoman Greene)

Councilwoman Greene reported the Committee received an update on the potential for food insecurity in the region due to loss of funding and grants from the federal government. Councilwoman Greene reported that there was an update on food waste prevention week and there was discussion on the committees legislative updates and outreach.

* Council of Governments: Regional Transportation Planning Board (Councilman Aguirre)

Councilman Aguirre reported that the Board was only receiving information items and there will be more discussion when the 495 HOT lanes are discussed at the next board meeting.

* Library Board (Councilman Aguirre)

Councilman Aguirre reported that the Library Board received updates from Friends of the Library groups and he noted that Spring2Action was a successful event for the branches. Councilman Aguirre reported that the Board would be electing new officers at the June meeting.

* Alexandria Transportation Commission (Councilman Chapman and Councilman McPike)

Councilman Chapman reported that the Commission received information on the kick-off for the Smart Mobility Lab, on May 1 at 2 p.m., at the Virginia Tech Campus. Councilman Chapman reported that there was an update and modernization of the Paratransit Program. Councilman Chapman reported that there was an update on bikeshare, including the inclusion of a new bikeshare program.

* Stormwater Advisory Committee (Councilman Chapman)

Councilman Chapman reported that the Committee would be sending a letter to Council with concerns they have about the Flood Action Alexandria program, including the timeline of the work for the program. Councilman Chapman reported that there was conversation about challenges and opportunities for flood preparation throughout the City.

* ARHA Redevelopment Work Group (Councilman Chapman and Mayor Gaskins)

Mayor Gaskins reported that the Work Group met and began the discussion about the policies of the current administration and how it will affect the work of ARHA and how the City would support families and the amount of coordination that needs to occur to address concerns of the both organizations. Mayor Gaskins reported that there was a discussion about future ARHA projects and the process of integrating those projects into the development pipeline for the City.

* Virgina Railway Express: Board of Directors (Vice Mayor Bagley)

Vice Mayor Bagley reported that the Board reported an increase of 100k riders in March. Vice Mayor Bagley reported that there was update on the King/Commonwealth Bridge project and the Alexandria Station improvements, to be completed in 2027. Vice Mayor Bagley reported that there was discussion of the 2050 Plan for the region.

IV. Oral Report from the City Manager

City Manager Parajon reported that the City has appointed Hashim Taylor as the Director of Recreation, Parks, and Cultural Activities and thanked Deputy Director Jack Browand to serve as the interim director.

Stephanie Landrum, President/CEO, Alexandria Economic Development Partnership,

gave an update on the upcoming Economic Summit to be held on May 8.
