335 Royal St Description of Work

The purpose of this request is for the installation of two privacy screens on our second floor porch. The porch faces an alley and the side of a Townhouse located at 314 Princess Street. Windows from this property have a direct view onto our porch and into our Primary bedroom. Additionally, one side of the porch faces Princess street and there are four townhouse units there that are owned by the Alexandria Redevelopment Housing Authority. Those units can view the side of the second floor porch. The porch has three open "window areas" facing the private alley behind the house, and two open "window areas" on the side of our house facing Princess street. We will position the alley facing screen in the center open "window area", and will position the Princess street screen in the open "Window area" furthest from the house.

The screens are made with treated wood and will be painted to match the color and structure of the current porch. The Size of the screens are 43' x 48". The screens will be fully framed with the 1" x 4" slats spaced and embedded within the frame.

Each corner of the framed screen will have a 4" integrated cleat (tab) which will be used to attach the screen to the wooden posts on the porch.

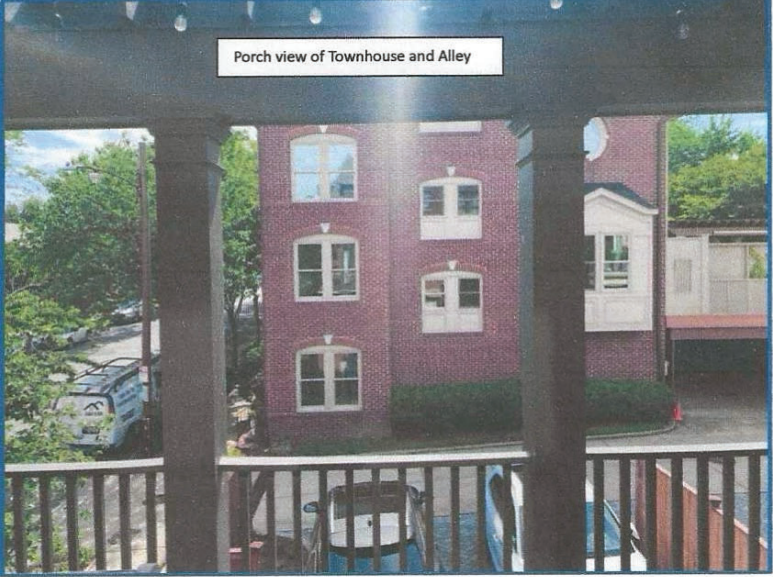
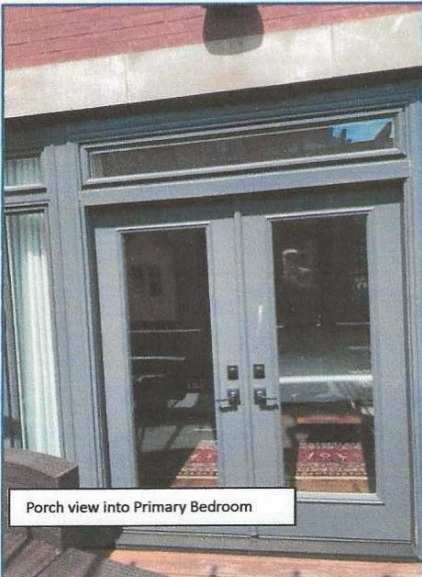
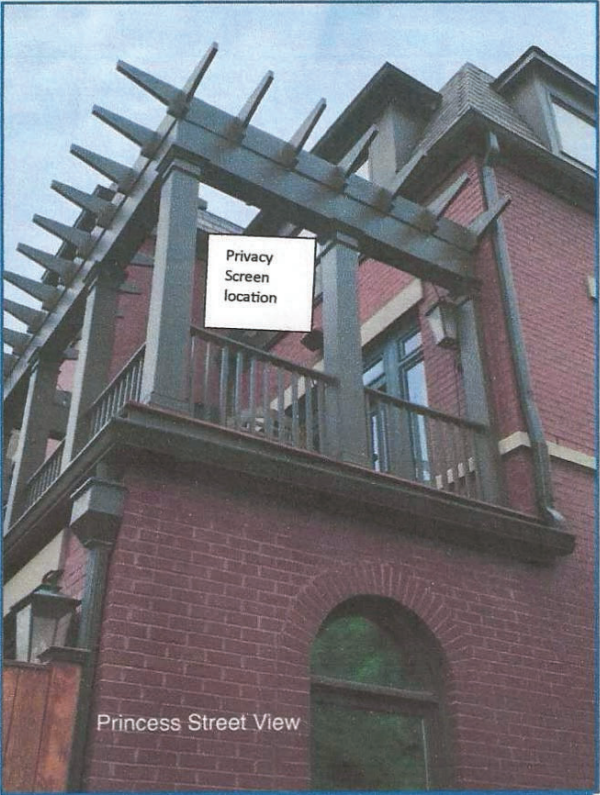
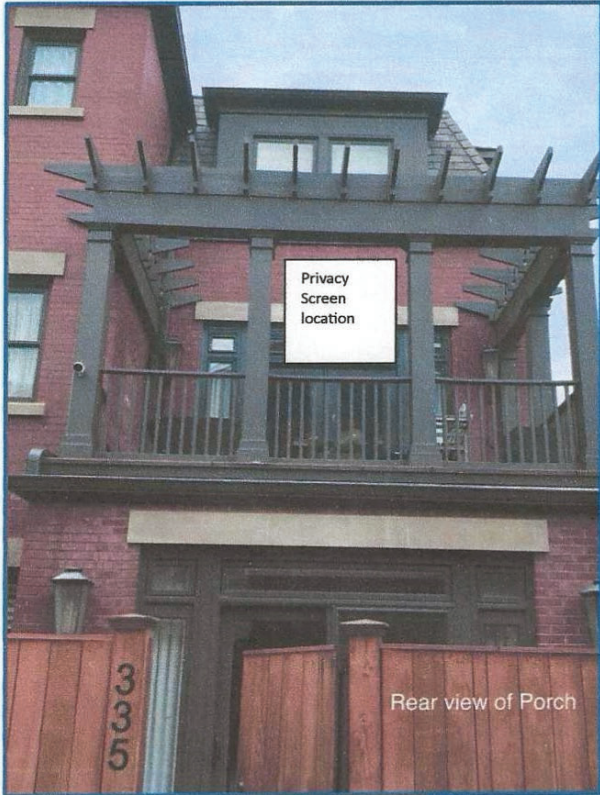
Hardware matters. We will use structural exterior screws (like GRK or Spax) for their outstanding shear strength in attach the screens to the porch wooden posts.
