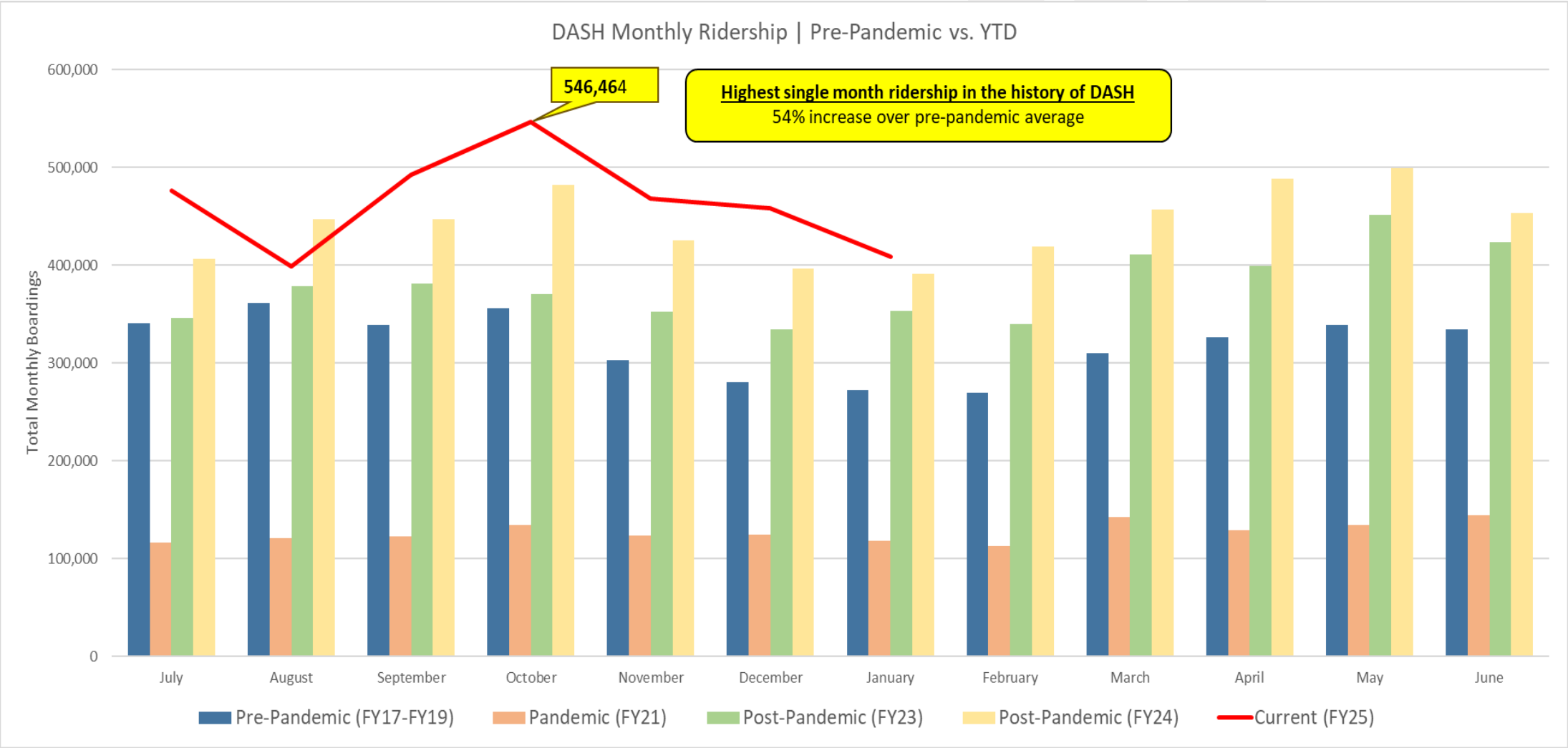

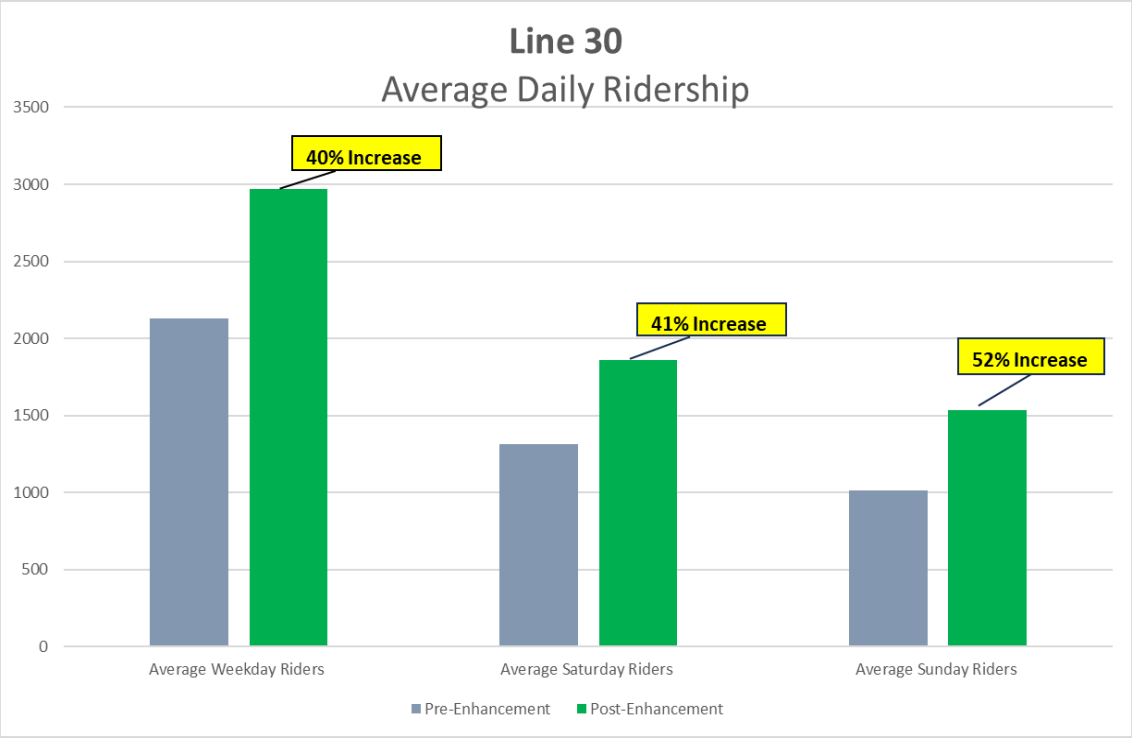

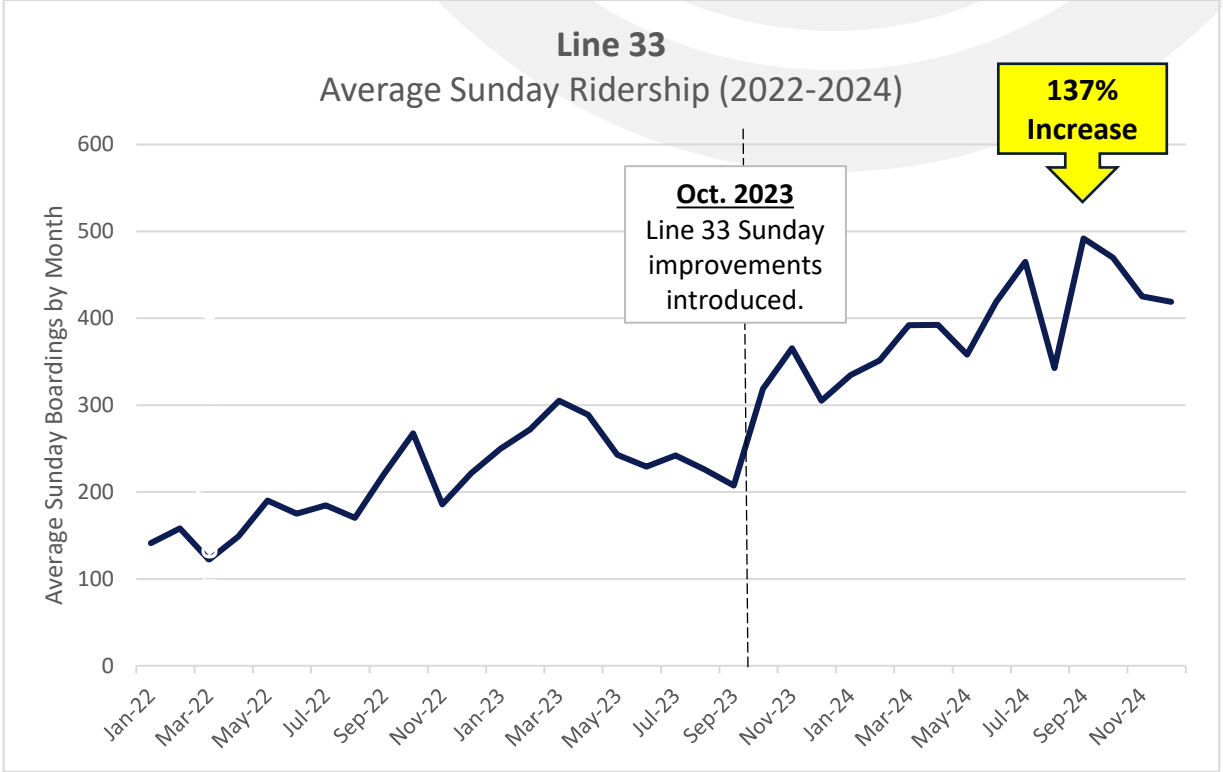


IMPACTS OF CITY INVESTMENTS

Weekday peak & weekend all-day service improvements (FY 23)

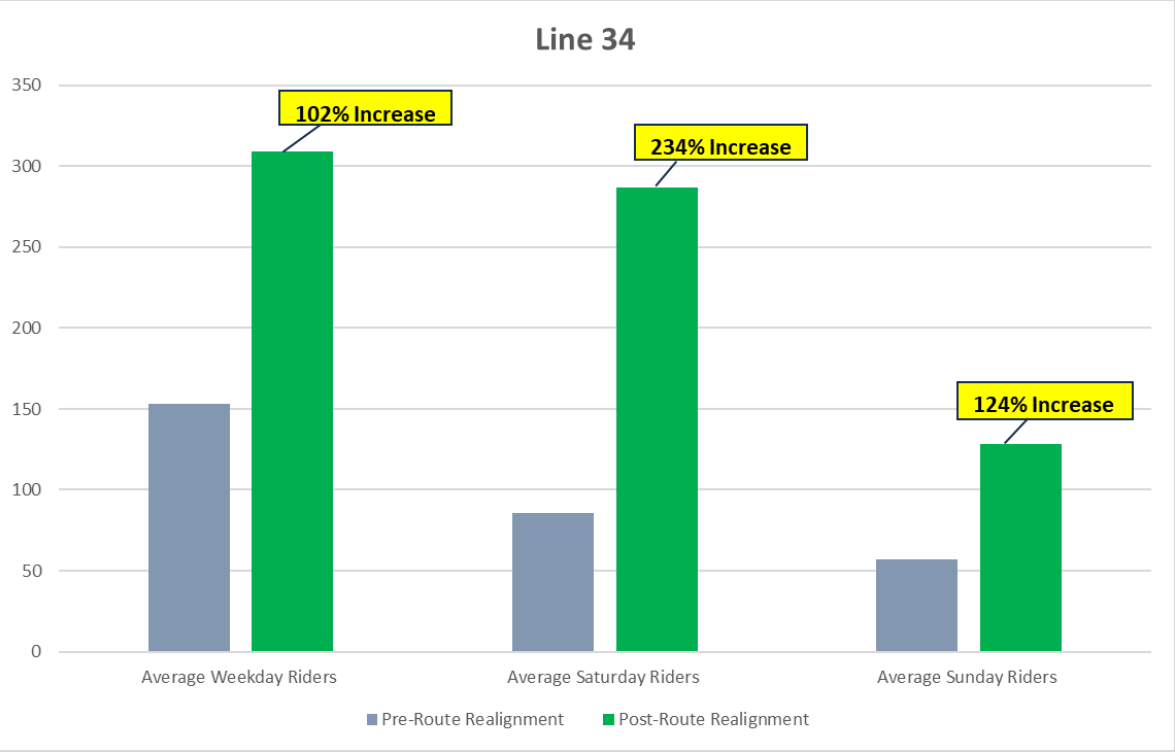


Line 33 Supplemental funding
Sunday improvements from 60min -> 30min frequency (FY 24)

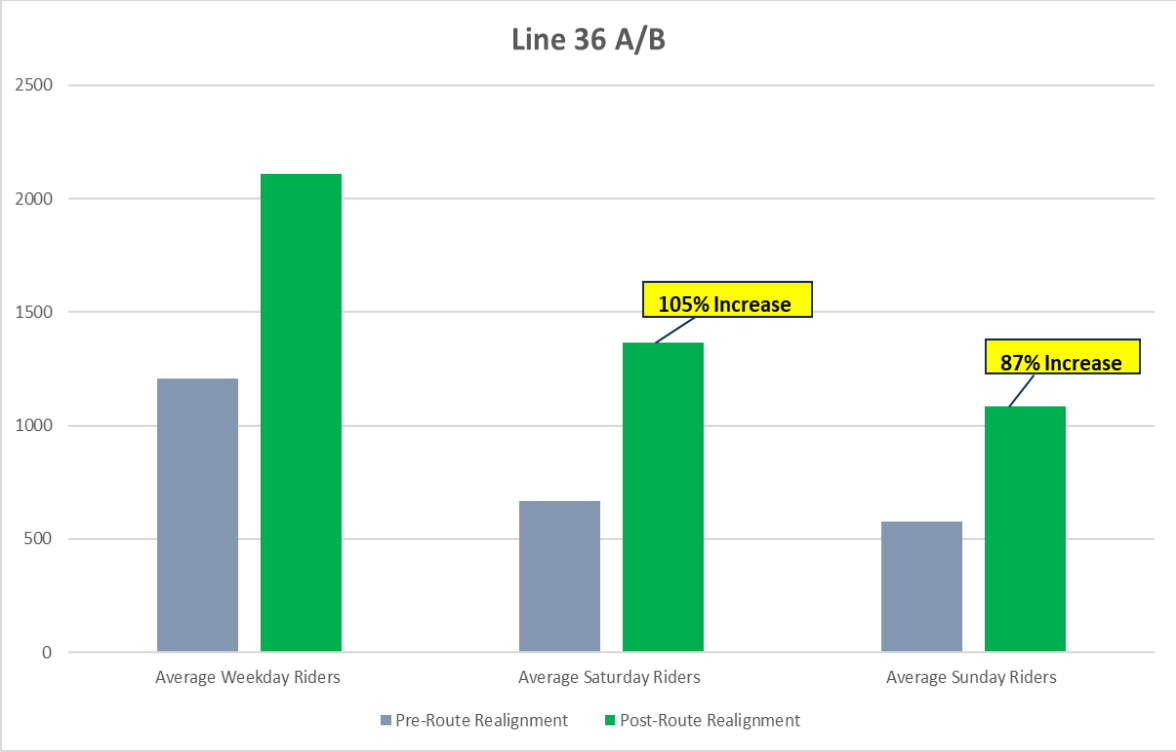


IMPACTS OF ROUTE REALIGNMENTS

MAKING A DIFFERENCE

Moving People

5.3 million total rides in FY24, an increase of over 800,000
~**3.4 million** low-income passenger trips
~**3.9 million** minority passenger trips
~**1.9 million** zero-vehicle household trips

Environmental Stewardship

~**3.6 million** SOV trips displaced
~**15,000 Tons** of CO² emissions eliminated

Fiscal Benefits

DASH supports the generation of an estimated **\$64m** in annual tax revenue for the City
Secured over \$75m in Federal, State, and Regional Grants
DASH is 20% less expensive to run in ALX vs. MetroBus*

BUS STOP IMPROVEMENTS – PROGRESS

- **Bus Stop Accessibility & Amenities**
 - 32 additional stops brought up to ADA compliance
 - 63% of all stops are now ADA accessible
 - 7 benches installed
- **Real-Time Info Displays**
 - 10 Signs Added via I-395 Commuter Choice Program
- **Landmark Transit Center**
 - Temporary Relocation to Parking Garage
- **King Street Corridor Bus Stop Consolidations**
 - Started in February 2025



BUS STOP IMPROVEMENTS – FUTURE

- **New Bus Shelters:**
 - DASH/City Staff to finalize location and design plans for ~20 New Bus Shelters planned for 2027.
- **King Street Bus Improvement Plan:**
 - Continues in FY25 for better stop access and amenities in Old Town
- **DRPT TRIP Grant - Bus Stop Improvements:**
 - New Transit Center & Bus Shelters at Landmark
 - 12-15 Additional Bus Stop Improvements (ADA Pads, Benches, etc)
