

Statement of Interest

I would like to be on the City of Alexandria's Community Criminal Justice Board for a number of reasons. The criminal justice system has been at the center of my life ever since I was a young child as my dad was a police officer for the Nassau County Police Department in New York. His service and Bring Your Daughter to Work Day inspired me to follow in his footsteps. My education and early career are in Criminal Justice. I earned a Master of Science in Criminal Justice, a Bachelor of Arts in Criminal Justice, and a Bachelor of Arts in Political Science, along with a minor in anthropology, from the C.W. Post Campus of Long Island University. I earned a Juris Doctor from the University of Dayton School of Law, where I was enrolled in the Advocacy and Dispute Resolution Track, focusing on criminal law and procedure. I possess a variety of experience working within the criminal justice system and legal system. I have interned for a district attorney's office, a county prosecutor's office, a United States Attorney's Office, a Federal District Court Judge, a police department, and a county legislator. I eventually served as an assistant prosecutor, prosecuting numerous criminal and children services cases. I have been working for the federal government in the field of contract negotiation for almost ten years and currently work as a Contracting Officer for the DoD at the Defense Threat Reduction Agency at Fort Belvoir. While my day job is in contracting, I am excited to share my passion of criminal justice with students by teaching criminal justice courses on the side. I have served as an Adjunct Professor of Criminal Justice at Indiana University East since 2015, at Indiana University-Purdue University Indianapolis since 2020, and at George Mason University since 2020. I am a leader within my community. When I lived in Ohio, I volunteered with "Wills for Heroes" for over 10 years in the Dayton community by creating wills and other estate planning documents for first responders and their families pro bono. This cause was near and dear to my heart given my background and I loved participating in this program. I have tried to find it in Virginia and cannot seem to find an active group that does it. I have participated in the City of Alexandria's Fund for Alexandria's Child's Holiday Sharing Program since at least 2021 by sponsoring extremely needy children and or children in foster care within the City of Alexandria by buying them clothes, toys, books, and gift cards to their preferred grocery store as they would not receive anything for Christmas otherwise. I am also active within my community as a leader as well. I am the Founder and Leader of two meetup groups called Alexandria Dining Out and Northern Virginia Trivia Players whereby I host events mostly in Alexandria and Arlington for members of the community. I have been doing this for almost five years, basically since I moved here, and I view my groups as providing a service the community - allowing strangers to come together in a safe space to enjoy food or trivia while getting to have good conversations and connecting with each other. We have become a core group of people and new people are always welcome. I have also completed various leadership programs within my jobs, which I was competitively selected for over the years, such as the USAF's Emerging Leader Course, NAVSEA's Leadership Challenge - Senior Leaders Workshop, and Humanergy's High Impact Leadership Training. I would specifically like to be on the City of Alexandria's Community Criminal Justice Board as I am dedicated to the City of Alexandria and the field of criminal justice. This opportunity would combine two passions of mine. While I don't live within city limits, I do live in Alexandria, Virginia and am in Old Town and within city limits numerous times a week. I am extremely tied to Alexandria, Virginia and hope to relocate within city limits one day. Serving on the Board would allow me to give back to my community, something that is important to me, and for a cause that I am passionate about. From reading the description for the Community Criminal Justice Board, it sounds like one of its goals is to address Broken Windows Theory, which I think is extremely important. I stand behind the goals of the Board as I think it aims to combat Broken Windows Theory and make the City of Alexandria a better place to live, work, and socialize in. If

community programs are established and properly funded, offenders can be properly diverted from correctional facilities and become productive members of society with a lesser likelihood of recidivism. With programs and services in place, offenders will have opportunities for job opportunities, extracurricular activities, and ties to the community thereby making them less likely to offend again.
