Mayor Gaskins called the meeting to order and the City Clerk called the roll. All members were present, with Councilman Chapman and Councilwoman Greene arriving during executive session.

WHEREUPON, upon motion by Councilman Aguirre, seconded by Councilman Chapman and carried 5-0, City Council convened in closed executive session at 6:30 p.m.,

pursuant to Virginia Code section 2.2-3711(A)(3) and (A)(6) to discuss or consider the acquisition of real property for a public purpose, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the City and the discussion or consideration of the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of the City would be adversely affected. ***Council of Governments (COG) Board of Directors Executive Committee (Mayor Gaskins)**

Mayor Gaskins reported that the Council of Governments has been part of the inceptor break and impact on the Potomac River and she reported that there would be a community meeting held in Alexandria on March 19 at the Lee Center from 7 pm- 9 pm with partner entities.

***Legislative Subcommittee (Mayor Gaskins and Councilman Chapman)**

Mayor Gaskins reported that the meeting was postponed on Friday, however there was an update received from the Legislative Director on bills that the City was monitoring as they move through final part of the process with General Assembly, with particular focus on budget priorities. Mayor Gaskins reported that she and other regional jurisdictions are working on letter to General Assembly to send a letter on skill games.

***City Council/School Board Subcommittee (Mayor Gaskins and Councilman Chapman)**

Mayor Gaskins reported the Subcommittee reviewed the schedule for the year and received an update on the scope of work on the long-range facilities plan and she requested that everyone send their comments to the City Manager. Mayor Gaskins reported that the board for ACPS has been invited to have a conversation about Federal law enforcement in the community and its impact on youth and families. Mayor Gaskins also reported that she and Councilman Chapman introduced the Council discussion and intent to move funding for ACPS from a lump sum to a major classification model.

***Alexandria Gang Prevention Community Task Force (Councilman Elnoubi)**

Councilman Elnoubi reported that the task force worked on implementation of work group model for the body focusing on expanding the after school opportunities for youth in the City.

***Workforce Development Center (Councilman Elnoubi)**

Councilman Elnoubi reported that the Committee moved to a new meeting format that would focus on strategy and problem solving with the first topic being the summer youth employment program, noting that they have received more than 600 applications for the program. Councilman Elnoubi reported that there is still the need for employers to host the youth employment program participants this summer. Councilman Elnoubi reported that there will be two upcoming events: a Job Fair on April 8 and a virtual transferable skills workshop on March 31.

***Alexandria Economic Development Partnership (AEDP) Board of Directors (Councilman Chapman)**

Councilman Chapman deferred the report.

***Northern Virginia Regional Commission (NVRC) (Councilman Chapman and Councilwoman Greene)**

Councilman Chapman reported that Commission was shifting its focus and discussed workforce development and the future of it in the region and he noted that the Commission has held some strategic work session.

***Health and Safety Coordinating Committee (Mayor Gaskins and Councilwoman Greene)**

Councilwoman Greene reported that the Committee met on March 6 and were joined by Councilman Elnoubi. Councilwoman Greene reported that Committee received an update on the reduction of harm from the eviction process.

A base real estate tax rate on residential, commercial and industrial property for calendar year 2026 of \$1.14.5 per one hundred dollars of assessed valuation. The FY 2027 proposed budget reflects a real estate tax rate of \$1.135.

1. Assumed in this proposed amount is the continued dedication of 1.0 cents for affordable housing;
2. Assumed in the proposed amount is the continued reservation of 2.2 cents of the real property tax rate for transportation projects;
3. A Special Services District tax is proposed to continue to be levied on all real property located in the Tier I Potomac Yard Metrorail Station Special Services District at the current rate of \$0.20 per one hundred dollars of valuation;
For all other taxes, the following rates are proposed:
4. A personal property tax rate on vehicles for calendar year 2026 of \$ ____ per one hundred dollars of assessed value. The FY 2027 proposed budget recommends a vehicle personal property tax rate of \$5.33 to fund the base budget;
5. A personal property tax of \$_____ for vehicles with specially designed equipment for use by the physically disabled. The FY 2027 proposed budget recommends a rate of \$3.55 to fund the base budget;
6. A personal property tax rate of \$_____ for privately-owned pleasure boats and

watercraft that are used for recreational purposes only. The FY 2027 proposed budget recommends a rate of \$0.01 to fund the base budget; and,

7. A tangible business personal property tax rate for calendar year 2026 of \$ ____ per one hundred dollars of assessed value and a machinery and tools tax rate of \$ ____ per hundred dollars of assessed value. The FY 2027 proposed budget recommends a tangible personal property tax rate of \$4.75 and a machinery and tools tax rate of \$4.50 to fund the base budget.


