Hi Ann & Alex - Finally got a response from the majority of the LUC.

We support the Planning Commission's recommendation to treat the second floor of Del Ray Pizzeria as a regular part of the restaurant without restrictions of reservations but do not support the reduction of the required parking from the previously approved ten spaces to eight spaces. We have not had the opportunity to present this reduction to the community. Furthermore, the applicant has offered to provide the ten spaces, which we feel is a goodwill gesture. Leasing of the spaces is a good solution as we felt the voucher system had enforcement issues. If you could pass this on to the City Council, we would appreciate it.
